FORMAT: All events will be timed finals. Scratches will be due 30 minutes before the start of each session

No deck registrations or additions will be added to the meet

ELIGIBILITY: Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet. No swimmer will be

permitted to compete unless the swimmer is a member as provided in Article 302.

Age on February 4, 2023 will determine age for the entire meet.

All adults participating in or associated with this meet, acknowledge that they are subject

to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with the MAAPP policy is a

condition of participation in the conduct of this competition.

DISABILITY

Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special

consideration.

The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior

to the competition.

ENTRIES: Swimmers are limited to 3 events per session

DEADLINE: 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be received by Tuesday, January 24, 2023.

3: Metro entries received between January 26, and January 27, 2023 and all entries from other LSC's will be entered in the order they were received, as space allows.

ENTRY FEE: An entry fee of \$6.00 per individual event and \$10 athlete surcharge must accompany the entries.

*Swimmers qualifying for outreach membership are eligible to have this fee waived at request

Payment must be received by February 4, 2023 for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

WARM-UP: Warm up sessions will be assigned

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual events

scratches and which swimmers will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA

Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not

possess these credentials will be required to leave the deck area.

RULES: The current USA Swimming Rules and Regulations will apply.

The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee.

Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches,

officials and/or spectators are present.

SAFETY: Metropolitan Swimming Safety and Warm-up procedures will be in effect. Marshals will be present

throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet

Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.

Certified lifeguard staff will be in attendance at all sessions, and available to athletes should they need it.

There is an AED device available on the premises.

""Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of a backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the

swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement"

WATER
USA 2011 - 202.3.7 "The meet announcement shall include information about water depth measured for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."

The water depth is 3 feet at the shallow end and 10 feet deep at the diving end.

AUDIO/VISUAL Use of Audio or visual recording devices, including a cell phone, is not permitted in changing STATEMENT: areas, rest rooms or locker rooms, or behind the blocks

Heading West (from Port Chester or Connecticut):

Tke Exit 9S. After light bear right onto the Hutchinson River Pkwy South. Take Exit 25W as above.

From I-684:

Follow to end which merges with the Hutchinson River Pkwy. Take Exit 25W as above.
