#### **CALL TO ORDER**

Dom Boccio, General Chair, called the April 26, 2023 House of Delegates meeting to order at 6:30 PM with the following Board members in attendance:

#### **MINUTES**

**MOTION:** To approve the Minutes from the November 22, 2022, Special HOD Meeting for the budget and the election of the General Chair. Seconded. **APPROVED.** 

Mr. Boccio read the Mission and Vision Statements of Metropolitan Swimming and led a minute of silence in remembrance of the members we lost since the last meeting.

#### **AGENDA**

MOTION: To approve the House of Delegates Consent Agenda (attached) Seconded. APPROVED.

#### **Consent Agenda**

The General Chair explained the procedures of the Consent Agenda and how to pull an individual proposal for discussion. The proposals had been divided into two groups: Block A having the approval of the Board and Block B constituting the proposals that did not have Board approval. All proposals had been posted on the Metro website for the membership to read. Mr. Boccio proceeded to individually call the proposals in Block A. Two proposals, P3 and P8 were pulled for discussion. The HOD voted to approve P1, P2, P4, P5, P6, P7, P9, P10, B1 of Block A without discussion. All passed by acclamation.

**P8:** Mr. Chu pointed out that there was a mistake in the wording of the proposal in Article 202.2. The word *rule* should be replaced with the word *exemption* instead of the word *requirement*.



These minutes will be officially approved by the Metropolitan Swimming House of Delegates at its Fall 2023 meeting. He motioned to amend the proposal accordingly.

**MOTION:** To amend Proposal 8, Article 202.2 to be changed to "The 3 meet requirement exemption is applicable during the years swimmers are full-time college/university students and during the season immediately following their graduation for college/university." Seconded. **APPROVED** 

Further discussion on **P8** in regards to Article 101.2.2. Mr. Finkelstein asked for other corrections. It was determined that the suggested changes fell under New Business and were not applicable to P8 as it was proposed. He agreed to bring up his corrections under New Business later in the meeting. Mr. Chu made a motion to approve P8 as amended.

MOTION: to approve Proposal 8 as amended. Seconded. APPROVED

Mr. Wone motioned to amend P3.

**MOTION:** to amend Proposal 3, Article 308.6.1.1 to be changed to "The Board of Directors has notified meet hosts with meet bids on time, held on any of the same dates or within 3 2 days. Seconded. **APPROVED** 

Mr. Chu motioned to approve P3 as amended.

MOTION: to approve Proposal 3 as amended. Seconded. APPROVED

Mr Boccio moved on to the vote of Block B of the proposals. Nothing was pulled for discussion. Proposal B1 - Amendment to Bylaws 5.1, 6.2, 7.4 **did not pass.** 

Reports of the Officers and Committee Chairs followed.

#### **General Chair**

This was Mr. Boccio's last meeting as General Chair. He has been on the Board since 2017, first as Age Group Chair, then as Administrative Vice Chair until he was elected as interim General Chair after Eric Fisher's resignation in the fall of 2022. He thinks the LSC and the Board continue to move in the right direction. Because of other personal commitments he is not running for reelection. His written report is attached.

#### **Administrative Vice Chair**

Mr. DeCasseres urged representatives to take voting seriously. He explained that everyone who likes the direction the Board and LSC are moving in should have an interest in supporting candidates for the Board that will carry on in that direction. He will not continue on the Board but will stay on during the transition period. His written reports are attached.

Mr. DeCasseres acknowledged three clubs that were granted the Metro Club Achievement this year: Badgers Swim Club, Long Island Aquatic Club, and Westchester Aquatic Club.

#### **Finance Vice Chair**

Mr. Arena was excused. The Finance Chair's report and the Budget vs Actuals Report are attached. Mr. Boccio affirmed that the LSC had a robust season and was able to rebound significantly since the pandemic. The past SCY season had a full meet calendar and no cancellations due to COVID or COVID policies. The 23/24 season outlook is positive, too. Financially the LSC is returning back to "normal" pre-Covid numbers..

#### **Coaches Representative**

Mr. Yearwood reminded everyone about the many coaches we lost in the past year. He shared that Coach Robert Trotman's achievements were recognized in an article in SwimSwam.

Mr. Yearwood also took the opportunity to congratulate Ginny Nussbaum from LIAC for being selected as Junior World Championship Head Coach.

He further mentioned that Metro's Coach of the Year award will be reinstated and reiterated that coaches are responsible to keep their own certifications up to date.

With the Zones Championships approaching he encouraged young coaches to participate.

## **Athlete Representative**

This was Frankie Anderson's (TVSC) last meeting as Senior Athlete Rep. Joseph Apat (LIE) will move to be the Senior Athlete Rep and Dylan Gallub (HAA) was elected to assume the duties as new Junior Athlete Rep moving forward. Mr. Anderson thanked everyone for giving him the opportunity to serve on the Board.

#### Secretary

Mr. Chu encouraged the coaches to mail the Secretaries the college commitments and senior athletes for recognition on the Metro website. Corrections, news, and updates are also welcome to keep the Metro website current and informative.

#### Senior Vice Chair

Mr. Hojnacki identified the three areas the Senior Vice oversees: (1) running and overseeing the Senior Met Championships, (2) supervising the travel reimbursement program for athletes and other athlete centered programs related to senior swimming, and (3) representing the interests of Senior Swimming in our LSC, on the Board, and potentially at the national level.

The Senior Met Championship is successful and improving. The feedback provided through the Senior Mets survey has been overall positive and is very helpful to the committee for further planning.

The travel reimbursement program is strong. The committee will be reviewing the financial implications of the claims thus far and if additional meets need to be added, as well as if the reimbursement amounts are appropriate.

The state of Senior Swimming within the LSC is very positive. Metro teams and athletes are represented at the national level and Metro coaches are selected to be on national teams. The Senior Vice Chair's report is attached.

#### **Age Group Vice Chair**

Ms Hallex explained that this was her final term as Age Group Vice Chair. She thanked all the teams that helped support the swimmers by hosting meets, especially during COVID. She encouraged coaches to work at Zones Championships. The Age Group Vice Chair's Report is attached.

#### Safe Sport Co-Chairs

Mr. Paspalas was excused. Ms Graham announced that Safe Sport recognition would become easier once that the Safe Sport component was fully up and running on the new USA Swimming website. Ms Graham also reiterated the importance for coaches to be aware when their swimmers turn 18, as the Athlete Protection Training has to be completed, there is absolutely no grace period. She cited an example of a swimmer turning 18 during a meet. Even though the swimmer was allowed to compete initially as a 17-year-old (age at first day of the meet), the swimmer was not eligible to compete anymore after turning 18 without APT. APT can be completed 30 days prior to the birthday. Safe Sport Chairs' Report is attached.

## **Operational Risk Chair**

Mr. McIlhargy was excused. No report.

#### **Technical Planning Chair**

This was Mr. Ellinghaus's last meeting as Chair. He has been the Technical Planning Chair since the early 1990s. He is stepping down after 30 years on the Board. Mr. Ellinghaus thanked everyone on the Board and in the House.

#### Diversity, Equity, Inclusion, and Disability Chair

Mr. DeCasseres stressed the importance of DEI and supporting all athletes. The waving of meet fees for outreach swimmers has been very supportive. He acknowledged that Galen Franchek's team, the Mid Hudson Heat Waves, is 21st in the nation for outreach swimmers.

#### **Governance Committee**

Mr. Frawley was excused. No report.



These minutes will be officially approved by the Metropolitan Swimming House of Delegates at its Fall 2023 meeting.

#### Hall of Fame Committee

Mr. McIlhargy was excused. No report. Mr. Boccio explained that there was still discussion on the location of the Hall of Fame board.

## Times/Records/Top 15

Ms. Grayson was excused. Her report is attached.

#### **Officials Committee Co-Chairs**

Ms. Ang reiterated that the Officials Committee was looking for athlete members. The number of officials in the LSC has also dropped significantly. She underscored the importance of clubs to reach out to their membership, to help recruit officials, in order to warrant well run meets. Instructions on how to become an official are posted on the Metro website.

Ms. Ang attended the Officials Chair track at the USA Swimming Convention in Denver. She reported that USA Swimming is working on a unified program to train officials. The OTS is still not fully functional. USA Swimming is asking for patience, it will take 1-3 years before all information is available. The Officials Chairs' Report is attached.

Mr. DeCasseres stressed that coaches who are also admin officials and meet directors should make sure they are registered as Coach and Official. The OTS only recognizes officials. The registration is simple and does not cost any extra fees.

Ms Ang interjected that per USA Swimming, coaches who are only meet directors, do not need that role listed but all certifications have to go through the officials committee. Coaches who are also working as admin officials have to be registered as officials in order to be certified.

#### **Open Water Committee**

Mr. Chu acknowledged that 11 Metro swimmers participated at the Open Water National and Junior National Championships. Four Metro officials also participated.

The upcoming Metro Open Water Championship will be September 16th. The Eastern Zone Open Water Championships have changed the date to June 17 and 18, held at Beesley's Point, NJ. Open Water Flyer is attached.

# **Strategic Planning Committee**

Mr. McIlhargy was excused. No report.

Mr. Boccio pointed out that we have to reup our LEAP certification as a requirement. Strategic Planning was an area that USA Swimming asked Metro to improve upon.

#### **Elections**

Mr. Boccio read the received nominations by positions and asked for nominations from the floor.

Julie Chen and John McIlhargy were absent. Mr. Vializ spoke for Mr. McIlhargy. Mr. Wone and Mr. Rodriguez introduced themselves. Mr. Graham read a statement on behalf of Ms. Chen.

Age Group Vice-Chair - Nominations from the floor: Keith Green, Ethan Fergus. Both spoke to the house and decided to run as co-chairs.

Operational Risk Chair - Nomination from the floor: Bob Vializ.

Technical Planning Chair - Carle Fierro & Jonah Montgomery as co-chairs. Diana Pimer & Kate Hallex as co-chairs. The candidates introduced themselves. No floor nominations.

Administrative Review Board (3 members) - Abby Howard, Elaine Ang.

Mr. Boccio asked for non-athlete nominations and for athlete nominations from the floor. He pointed out that the Administrative Review Board required an athlete member. No nominations were made from the floor. He explained that with no athlete running that the third position would be vacant, and would require an appointment by the next General Chair with the advice and consent of the Board.

Governance Committee (9 members) - Allen Wone, Kyle Wilson (athlete), George Fleckenstein, Iliana Bitis, Larry Miele, Jeff Chu,

Mr. Boccio explained that this committee also requires athlete members, and that the membership in this committee was staggered. Therefore, it was important to cast a vote for every member you wanted on the committee because the top 5 vote-getters will serve a two-year term and the remaining 4 a one-year term, ensuring fluidity on the committee moving forward.

Nomination from the floor: Robert Frawley (athlete).

Mr. Boccio advised that the remaining 2 positions will be filled by the GC with advice and consent from the Board.

Mr. Chu and Ms. Mackrel distributed voting ballots and pens to all eligible voting members. Mr. Boccio advised that the earlier nominations had already been printed on the ballots, the floor nominations were to be written in by the voters if desired.

Mr. Boccio announced that the candidates for Age Group Vice Chair (Keith Green & Ethan Fergus) and Operational Risk Chair (Bob Vializ) were running unopposed.

MOTION: to vote those candidates into the positions by acclamation. Seconded. APPROVED



These minutes will be officially approved by the Metropolitan Swimming House of Delegates at its Fall 2023 meeting. Mr. Chu and Ms. Mackrel collected the ballots and proceeded to count the cast votes with Mr. Ellinghaus.

Mr. Boccio clarified that per our bylaws the General Chair needed to receive 50% of the vote + 1 in order to be elected. He recommended that people remain at the meeting in case several rounds of voting were required.

#### **Unfinished Business**

No unfinished business.

#### **New Business**

Mr. Finkelstein in regards to Article 101.2.2. He suggested that the registration fees also include \$25 for the Len Galuzzi scholarship fund.

**MOTION:** to add to Article 101.2.2 that \$25 of the registration fee is allocated to the Len Galluzzi Memorial Scholarship Fund. Seconded. **APPROVED** 

Mr. Finkelstein also requested clarification on Article 307.2. *Non-USA Swimming Registered individuals are not permitted on the pool deck at any time during the meet or practice, except for Official Timers*. Under the present wording life guards would also need to be USA Swimming members. Mr. Boccio made a

MOTION: to have the next Board of Directors provide clarity on that point. Seconded. APPROVED

Mr. Finkelstein had two more P&P housekeeping requests.

**MOTION:** to update the wording in Article 301.1.7 to 'An "Approved" meet is open to both USA Swimming athletes and non-USA Swimming athletes but follows all USA Swimming technical rules.' Seconded. **APPROVED** 

**MOTION**: to update the wording in Article 301.1.8 to 'USA Swimming athletes in a competition that does not conform to USA Swimming technical rules such as High School or College Championships may request Observed swims.' Seconded. Discussion

Ms. Hallex made the

**MOTION:** to amend that any where applicable in Article 301 'USA Swimming rules' should be changed to 'USA Swimming technical rules'. Seconded. **APPROVED** 



These minutes will be officially approved by the Metropolitan Swimming House of Delegates at its Fall 2023 meeting.

MOTION: to strike YMCA from article 301.1.8 and to change where applicable in Article 301 'USA Swimming rules' to 'USA Swimming technical rules'. Seconded. APPROVED.

Mr Boccio asked if there were any additional bids for the championships in the 23/24 season from the floor since some were still open? He read the championships that had been awarded to teams. Bids

from the floor were NYS/VAC for Bronze North and NCAC for Bronze Central. Vote on these bids are deferred until the fall HOD meeting where the members of the North and Central regions can vote.

#### **General LSC Updates**

The 2022-2023 Short Course season was the first since 2018-2019 that saw a return to a robust meet schedule with open meets, invitationals, time trials, dual meets, and intrasquad competitions. The 2023 Long Course season looks to be full of meets as well. This year will prove to be the new benchmark as the first uninterrupted season following the COVID-19 pandemic.

A return to stability will allow the Board of Directors, committees, and you, as membership, to promote and further develop swimming in the Metropolitan LSC. This will be a welcomed return for all and I look forward to seeing what membership can develop.

I have worked to send out monthly newsletters to membership, providing updates on the workings of your Board of Directors, providing news from the local and national level, and highlighting performances of our athlete members.

I want to again thank all our championship meet hosts for the work they did to provide opportunities for all athletes at all levels to have an opportunity to compete in a championship meet.

A main goal during my tenure as General Chair was to ensure open lines of communication with your Board of Directors. At the end of the day, the Board of Directors works for you, as membership. We are committed to hearing your feedback at all times, including in between meetings. All Board of Directors meetings are open to the public and the schedule on the Metro website is updated with upcoming meetings for the Board, the House, and committees.

I repeatedly mention the great work that Kimberly Ferraris-Wyer has done for the LSC in the office. She has been an incredibly valuable resource for all of membership and is our connection with USA Swimming as they continue to improve upon SWIMS 3.0.

#### **SWOT** Analysis from the General Chair Perspective

While short, my tenure as General Chair since the Fall of 2022 has allowed me to see the LSC from a new perspective. I was a Metro athlete for my entire developmental career, a full-time swim coach for 10 years, Age Group Chair, a Meet Director, Administrative Official, Administrative Vice Chair, served on Age Group, Technical Planning, and the Officials Committee. Adding General Chair to that list has allowed me to offer the following thoughts on the state of the LSC:

**Strengths:** We have passionate membership that feels able to openly discuss and share their opinions and ideas. We have talented coaches in all areas of the LSC both continuing to grow the sport at the developmental level, while also pursuing the highest levels of competitive swimming in the United States. We have athletes that are wonderful young people in and out of the pool. We have active and engaged parents. We are in one of the most diverse geographic locations in the United States. We have the opportunity to access so many new athletes with the right plan.

We have wonderful facilities in all areas of the LSC that we can offer competition in for all levels of our membership. We have a robust travel assistance program for our athletes who reach a high level of championship in swimming to help alleviate some of the burden on families for a sport that is already so expensive to most.

**Weaknesses:** We are still in a challenging position with our officiating numbers. Previous Officials Chairs have proposed changes to Policy and Procedures to navigate these challenges. A change in leadership in this position has presented an opportunity for new Officials leadership to make further adjustments to help address this challenge.

The LSC is in an area where the sport of competitive swimming is in competition with many other sports and activities. Continuing to promote the sport to the larger community is necessary.

**Opportunities:** With the return to financial stability and a steadied meet calendar, the LSC has the opportunity to return to pre-2020 plans for increased opportunities for membership. Coach clinics and athlete workshops to name a few.

The Metropolitan area lends itself to many of the best and brightest. The LSC has the ability to leverage the knowledge of business professionals of all areas of expertise to continue to develop into an organization that steers itself toward the goal of providing the highest level of service to developing and providing opportunities for athletes of all levels in the sport of competitive swimming.

Developing multiple tracks for Officials. One for those who chose to pursue the highest level of officiating and one for those that simply want to help run competitions for their children to compete in the sport they love.

**Threats:** The LSC must commit to a Strategic Plan that lays out actionable items into the remainder of the 2021-2024 Quad as well as looking ahead to LA2028. A domestic based Summer Olympic Games in 2028 allows the Olympic Movement and the sport of competitive swimming to be involved in the conversation more as the Games in 2028 approach. Our Strategic Plan has not been updated and was a callout from USA Swimming in our LEAP Evaluation that needs to be improved.

# **Looking Ahead beyond the Spring 2023 HOD**

The LSC will be transitioning to position specific email addresses sometime later this spring. This was an item that USA Swimming has suggested for best practices for LSC Governance. This information will be relayed to membership when the transition begins.

Stay informed of upcoming clinics, committee, and Board meetings by following the website. The website is also frequently updated with athlete highlights and important news and information relayed to the LSC by USA Swimming.

Coaches and Club Administrators, please stay up-to-date on all correspondences from USA Swimming HQ. There is always valuable information in their newsletters. Please ensure your clubs are kept in the loop for all relevant information.

#### Official committee meeting summary (by Elaine Ang and Ken Graham)

- 1. Mark Amodio, the previous officials chair resigned in November 2022, and Elaine Ang and Kenneth Graham were appointed in December 2022 as the officials' co-chair. There was a meeting in November 2022. Since the appointment, we have held 2 meetings, one in March and one in April of 2023. Currently this committee has no active athlete representative, and we are currently actively soliciting new athlete representatives.
- 2. We will provide a minimum of monthly training via zoom or possibly in person for any new potential officials. We are looking to expand the training available to new officials. A need for starter and referee training has been identified and curriculums for that are in development.
- 3. Actively contacting clubs and coaches to reach out to their parents for potential officials.
- 4. We are contacting all officials, providing rules updates on a regular basis, and updating them on the USA Official Chairs meeting information. We are solicitating officials that are interested in joining the committee or becoming a trainer.
- 5. The steps of "How to Become an Official" is posted on the Metro Officials page.

#### USA Swimming Workshop, 4/20/23-4/22/23: Official Chairs (by Elaine Ang)

- 1. Overall from USA Board of Director:
  - Allocating \$5M to Education for athletes, coaches, and officials
  - 62% income from membership
  - Strategic board partner with NCAA, 98% in Rio and 91% in Tokyo National Swimmers from Colleges
  - New facility for the 2024 Olympic Team Trials in Lucas Oil Stadium (Indianapolis) with capacity of 30,000 spectators, est. 1,500 athletes and 600 coaches
  - 1st NGB (National Governing Body) that offers free programs/events on smart TVs
- 2. USA Swimming conducted a survey with over 1,000 officials that have less than 5 years' experience to gather their feedback on what should be included in training, clinic, preparation

before the 1<sup>st</sup> session, understanding of the certification process, and competency-based evaluation.

- 3. All reports in SWIM 3.0 are expected to be available by Fall of 2023
- 4. Athlete workshop/retreat in Maine from 6/22-6/25, 2023
- 5. The National Officials Committee and the working group are also working on an official certification and education project. This is a 1-3 year project.
  - To have a unified program for all 59 LSC
  - To reduce barriers
  - To streamline the process
- 6. USA Swimming Officials Committee also provided guidance on:
  - Documentation: building a case using the resources (rulebooks, educational materials, protocol, professional documents)
    - o Performance Development Plan form for all meet referees
  - Code of conduct template (CofC)
  - Discipline or De-certification with three categories:
    - Professional qualifications (lack of knowledge or application of rules)
    - Professional misconduct (violation of LSC CofC)
    - Code Of Conduct (violations of USA Swimming CofC or US Center for Safe Sport Code)

# **Outreach membership**

USA Swimming and Metropolitan Swimming offers a membership program to help and encourage the economically disadvantaged youth who are unable to afford the USA Swimming membership fees.

Looking forward to continuing to work with member clubs to find ways to increase membership through outreach and ensure the swimmers who are currently registered continue to receive the support they need.

### **Meet Fee Reimbursement**

Program continues to offer financial support in the form of meet entry fee reimbursement to qualifying registered outreach athletes within the LSC. Additionally, the DEI Committee Budget was able to cover costs for any registered outreach athletes who competed in the Metropolitan Swimming Age Group Championships and the TYR Senior Metropolitan Championships.

Looking forward to continuing this program with hopes of being able to support swimmers in need. Moving forward, the DEI Committee should explore opening up reimbursement to possibly include Silvers Championships.

#### **Donations**

DEI committee received a number of donated swim equipment and gently used tech suits from the Metro membership community. As was done in the past, these items were distributed amongst the teams within the LSC to be handed out to swimmers in need.

# Article 101 - Club Registration

101.1 Clubs shall be registered as a group member of Metro. Membership is subject to USA Swimming policies, rules and regulations and Metropolitan Swimming policies and procedures. Membership is a privilege, not a right. Along with membership come duties and responsibilities.

# 101.2 To register, a club shall:

- .1 Complete a club membership application form (available on Metro web site). Applications must be printed or typed, in blue or black ink. Complete all requirements established by USA Swimming, and pay all required fees including those from USA Swimming or from Metro.
- .2 The registration fee will be determined by the House of Delegates. \$25 of the fee is allocated to the Joseph J. Stetz Memorial Scholarship Fund.
- .3 Clubs must use their full registered name.
- .4 A new club, or one that has had a gap in membership of more than 11 months and is rejoining, shall follow the procedures outlined in The Prospective Club Membership available from USA Swimming, and submit the following:
- A Requirement Checklist for First-Year Club Membership and all documents listed on the -checklist.
- B Bylaws showing how they are organized and controlled.

Those clubs will be on probation for the next registration year. New clubs on probation shall complete USA Swimming Club Leadership and Business Management programs within one membership year. New clubs must complete all requirements established by USA Swimming (USA Swimming Bylaws, Operating Policies, etc). New clubs shall use Hy-Tek Team Manager or any other compatible program for registration and meet competition entries and results.

- .5 A renewing club shall submit the following:
  - A Safety Action Plan(s), if there have been changes or new facilities are in use.
  - B Club Bylaws, if they have changed in the past year
- .6 Each club shall designate:
  - A A safety coordinator, who shall be an adult individual member of Metro. [Bylaws 2.2.3]
  - B A head coach, who shall be an adult individual coach member of Metro. [USA 502.4.4]
- C 1 to 3 representatives to the Metro House of Delegates, who each shall be individual members of Metro.

101.3 Registrations expire on December 31st. Renewal registrations are due no later than December 1st.

### Article 102 - Individual Registration

102.1 Clubs shall register their athletes and non-athletes (coaches, officials, and representatives) with Metro. Individual members shall follow registration procedures through USA Swimming.

102.2 Registrations are not valid until they are received, with payment, and accepted by the Metro Office.

102.3 Renewal registrations are due no later than December 1st.

102.4 When transferring between LSCs or Clubs within the same LSC, the <u>athlete member swimmer</u> shall submit a completed transfer form in <u>according accordance</u> with USA Swimming procedures. <del>LSCs may not establish procedures for transfers which effectively deny a swimmer the right to transfer from one LSC or Club to another [USA 203.5] — For a swimmer to represent a USA Swimming club in a competitive event one hundred twenty (120) consecutive days must have elapsed without the swimmer having represented any other USA Swimming club in USA Swimming competition.

There is a fee of \$5.00 for a transfer.</del>

102.5 A prospective swimmer may participate in tryouts for no more than 30 consecutive calendar days in a 12-month period. This swimmer shall not have been previously a member of USA Swimming. During the tryout, the individual is not covered by insurance, but the club insurance is still valid. 102.6 Athletes shall have completed their registration with Metro in order to compete.

#### Article 103 - Club Representation

103.1 Clubs shall appoint one and may appoint up to three representatives to the House of Delegates. Each delegate casts only one vote. They must be registered members with Metro. [Bylaws 4.1.1 & 4.3.1]

103.2 Each club shall appoint one athlete over thirteen years old to the Athletes Committee.

103.3 The September Fall and May Spring meeting of the House of Delegates are mandatory meetings. Each club shall have both a non-athlete delegate representative to the House of Delegates and an athlete delegate representative (September Spring Only) to the Athletes Committee present. There is a \$100 fine for each required representative person not in attendance.

103.4 It is each club's responsibility to read the minutes of the House of Delegates and Board of Directors meetings and be aware of changes in policies.

#### Article 104 - Other Responsibilities

104.1 A Coach Member shall conduct each practice in its entirety for it to be valid.

104.2 In the event of any injury or sudden illness that occurs at practice, competition, or other covered team functions, a Report of Occurrence form shall be sent to USA Swimming, Risk Management Services Inc., and the Metro Safety Chairman. A Report of Occurrence online form is also available on the USA Swimming website.

104.3 Clubs shall apply for and must receive a sanction to run a swim meet, a time trial, a swim clinic, an exhibition, or a Swim-a-thon for it to be a covered USA Swimming event.

104.4 Clubs that host a Swim-a-thon must file a contract and financial report with USA Swimming. Copies of these reports shall also be sent to the Swim-a-thon Coordinator. <del>[USA 202.7]</del> 104.5 In order to receive meet travel reimbursements, the <del>club or swimmer</del> member applying for reimbursement shall submit the appropriate forms. The reimbursement requests shall be within 30 days of the meet for spring meets and by August 25th, for summer meets. (The forms for each meet are available on the Metropolitan Swimming website)

104.6 In order to receive grants in the Metropolitan Swimming Club Achievement Program, clubs shall submit the Metropolitan Swimming Club Achievement Program Application form. The application is due by January 15 for the annual period ending August 31st of the previous year.

104.7 Clubs shall request the subsidy for running a distance meet by notifying the Administrative <u>Vice</u> Chair when filing the post-competition report. Clubs shall be responsible to submit the Distance Stipend Form to the office.

104.8 Clubs may not use personal checks for club or athlete registration fees but can use a club credit cards, checks, Zelle, and other methods approved by the Board of Directors, General Chair, or Administrative Vice Chair for payments to Metro athlete registration fees, sanction application fees, etc.

104.9 Clubs shall be responsible for the bank fee and a \$50 fine for checks returned by the bank. 104.10 Metro registered clubs, in order to maintain good standing, must pay all invoices, registrations, fines, meet surcharges and any like items to Metro within 30 days of their invoicing. At the 30-day mark, the club will receive a written warning with copies sent to <a href="the-Finance Vice-Chair">the-Finance Vice-Chair</a>, the Administrative Vice-Chair and the General Chair. After 60 days, the club will receive a written notice of "PAST DUE" with copies sent to <a href="the-Finance Vice-Chair">the-Finance Vice-Chair</a>, the Administrative Vice-Chair and the General Chair with the addition of a 5% of the amount due as a late fee but not less than \$100. After 90 days, the club will no longer be considered in good standing and any combination of the following penalties below may be imposed on the club as recommended by the Finance Committee and approved by the Board of Directors:

- <u>Athlete members Swimmers</u> will be required to swim as <u>Uunattached</u> in all future meets until the club is in good standing
- Clubs hosting meets will pay 20% surcharge on all athletes including the host club up to the amount owed Metro
- Clubs hosting meets will have 100% of the splash fees surcharged by Metro up to the amount owed to Metro
- Loss of future sanctions for meets, including Time Trials
- Club will not be able to re-register as a club the next USA Swimming season until past due amounts are paid

Part Two - Individual Requirements

Article 201 - Athlete Registration

201.1 Athletes shall be registered as individual members with Metro. Membership is subject to USA Swimming policies, rules and regulations and Metropolitan Swimming policies and procedures. Membership is a privilege, not a right. Along with membership comes duties and responsibilities. [Bylaws 2.1.2A]

201.2 The registration fee will be determined by the House of Delegates.

201.3 Athletes who are going to represent a club shall be registered by that club. Individuals who wish to be unattached shall follow the registration process established by USA Swimming register directly with the Metro Office.

#### Article 202 - Meet Participation

202.1 To participate in a Metro Championship meet, a swimmer shall have met the qualifying time standard established by Metro for any event entered. The time shall have been achieved at a sanctioned, approved, observed swim meet, or time trial.

202.2 To participate in the Senior Metropolitan Championships a swimmer shall have competed in an individual event in three Metro sanctioned meets within the previous year. A Metro historical swimmer is one who has competed in Metro LSC boundaries for three (3) years prior to the age of 18; those swimmers should be exempt from the 3 meets requirements needed to swim in Senior Mets. The 3 meet <u>rule requirement</u> is applicable during the year's swimmers are full-time college/university students and during the season immediately following their graduation for college/university.

#### Article 203 - Travel Assistance

203.1 Metro swimmers who qualify for and attend approved national and regional meets and National Select Camp are eligible for Assistance provided they meet eligibility requirements.

203.2 Swimmers shall have competed in individual events in at least five Metro Sanctioned swim meets within one year prior to the competition or camp. College students must attend one Senior Metropolitan

Championships during the current season. For all travel Assistance requests, one of the five Metro shall have been a Senior Metropolitan Championship.

- 203.3 The club or athlete shall apply for the travel expense reimbursement. Each athlete may submit for up to a total of four (4) travel assistance per season which consists of two (2) short course season and two (2) long course season meets listed below. Olympic and World Trials are exempt and are not included in the total.
- 203.4 The meets and travel Assistance are as follows: (Senior and Disabilities Chair shall conduct an annual review of all eligible meets. Chairs may modify or add to the list based upon USA Swimming's calendar but may not eliminate or otherwise alter assistance for existing eligible meets without approval from the House.)
- .1 Eastern Zone Speedo Champion Series (Sectionals) swimmers in individual events only are eligible for travel Assistance of \$300.00. Both Summer and Winter.
- .2 Long Course Senior Zone Championship swimmers in individual events only are eligible for a travel Assistance of \$300.00. Relay only swimmers are excluded from travel Assistance.
- .3 Beginning September 1, 2012, USA Swimming Winter Junior National Championships swimmers in individual events are eligible for a travel Assistance of \$750.00. USA Swimming Summer Junior National Championships swimmers in individual events are eligible for a travel reimbursement of \$1,200.00. NCSA Junior National Championship Short course or Long Course & Futures Long Course Meet Swimmers in individual events are eligible for a travel Assistance of \$600.00. National Championship & Para Winter swimmers in Individual Events are eligible for a travel Assistance of \$900.00. National Championships and Para Summer swimmers in individual events are eligible for a travel Assistance of \$1,500.00. US Open swimmers in individual events are eligible for a travel Assistance of \$1,500.00. World Championship Trials swimmers in individual events are eligible for a travel reimbursement of \$1,500.00.
- .4 Olympic Trial swimmers in Individual Events are eligible for a \$2,250.00 travel Assistance. Swimmers who have met the Metro Competition requirement for three of the four years preceding Olympic Trials are eligible for a travel Assistance of \$4,500.00
- OPEN WATER: 10K Swimmers are eligible for a travel Assistance of \$750.00. 5K Swimmers are eligible for a travel Assistance of \$475.00.
- 203.5 Swimmers who attend National Select Camps sponsored by USA Swimming are eligible for a travel reimbursement of \$200.00.
- 203.6. Athletes travel assistance is only available for actual and necessary expenses, as outlined in the current year's NCAA manual, not to exceed the cost for the individual to participate in the event.
- 203.7. The Metro Swimming Policy for meal reimbursement will be the United State General Services Administration (GSA) per diem rate.
- 203.8 If the assistance is requested by a club all receipts must be in the club's name and swimmer's name. If a family has paid for any part of the requested assistance, the club must submit a statement confirming they are submitting on behalf of the athlete and that the family has been or will be reimbursed the amount by the club. A club may also submit expenses on behalf of the athlete and request payment be made to the athlete or family. Completed Athlete travel assistance forms are due thirty (30) days after the competition or event for which travel assistance is being requested either by the Athlete or Club. Any submissions received after the thirty days will be returned.
- 203.9 The Metro Swimming Policy for travel Assistance requirements will be as follows: List of acceptable meets: all Metro Sanctioned meets that were bid on, and accepted at the HOD Bid Meeting, or added on the calendar later with the Board Approval. Swimmers must have competed in individual events in each meet (time trials not included).

List of unacceptable meets: High school meets (dual meets, championship meets, State qualifier, State meets, etc.); Approved meets; Observed meets; Out of LSC meets; Dual/tri meets between 2/3 clubs (or more); Time Trials; "Closed" meets; League or association meets (ESSL, YMCA, WFA, etc.) [HOD May 18, 2011]

203.10 COVID participation relief requirements for travel stipends, and club excellence for historic swimmers are extended through the 2021-22 competitive year.

#### Article 204 - Swimmer Awards

204.1 Metro Swimming will be offering the following two scholarships Joseph J. Stetz and the Len Galluzzi Memorial Scholarship will be given annually to one male and one female athlete. The award is \$1,000 each. The athlete must be a High School Senior and shall submit the application to be considered for the award. The athlete must have competed in at least five Metro Sanctioned swim meets within one year prior to application. The selection committee consists of the Officials Committee and a member of the Executive Committee.

#### Article 205 - Zone Meet Participation

205.1 Swimmers qualify for any Eastern Zone Age Group Championships by achieving the time standard established by the Eastern Zone. The Eastern Age Group SC is now a club team meet. Metro will continue to travel as a Metro team for the Long Course Age Group Championship 205.2 Swimmers 11 and older must travel and room with the team for the duration of the meet. Swimmers 10-under must travel and stay with their parents; they are under their parent's responsibility for the duration of the meet. Swimmers 11 and over may be released to a parent/guardian upon completion of their age group's session on the final day of the meet, provided they do not qualify for finals/participate in a relay. The Zone Coordinator/Age Group Chair must be in possession of the athlete release form prior to the final day of competition. The participation fee for all swimmers will be determined and posted in the meet notices. Metro arranges for and pays transportation, lodging, meals, and equipment for all swimmers 11\_and older. Metro arranges for equipment for swimmers 10 and under.

205.3 All participation fees are the responsibility of the swimmers and will be posted in the meet information packet.

205.4 Swimmers who will participate in the Eastern Zone Age Group Championships shall complete the Application Form, the Equipment List Form, and pay the appropriate fee. On the Application Form, the swimmer shall provide emergency contact, medical insurance information, and sign the Metro Code of Conduct and social media policy.

205.5 The Metropolitan Zone team ean <u>may</u> bring two swimmers with disabilities from 12-and-under age groups and two swimmers with disabilities from the 13 and over age groups as team members to the Zone Championship Meet. Interested swimmers with disabilities are encouraged to apply. The form is available on the web.

205.6 Athletes who compete in the 10 & Under category age group will be encouraged but not required to attend the meet in its entirety. They will be required to stay for the full session on the days which their event(s) fall.

#### Article 206 - Coach Registration

206.1 Coaches shall be registered as individual members with Metro. Membership is subject to USA Swimming policies, rules and regulations and Metropolitan Swimming policies and procedures. Membership is a privilege, not a right. Along with membership comes duties and responsibilities.

206.2 Coaches must complete all requirements established by USA Swimming.are required to complete and have current certification in CPR, and Safety Training for Swim Coaches. Coaches are also required to complete and pass Background screening and the Athlete Protection Training (Safe Sport).

206.3 Beginning January 1, 2013 – new coaches must take Foundations of Coaching 101 as part of the registration process. Coaches must then take Foundations of Coaching 201 and foundation of coaching Rules & Regulations before they can register for the 2nd year!

206.4 All coaches shall complete the background screening as required by USA Swimming. Coaches pay for their own screening, which is valid for two years. The screening is done by an independent firm. Any disputes and appeals are handled through the independent firm and counsel to USA Swimming. To preserve your privacy, do not contact anyone in the LSC or at USA swimming. [USA 502.4.3]

206.5 The registration fee will be determined by the House of Delegates.

206.6 Coaches who are going to represent a club shall be registered by that club. Individuals, who wish to be unattached, shall follow the registration process established by USA Swimming register directly with the Metro Office.

Article 207 - Non-Athlete, Non-Coach Registration

207.1 Any other individual who participates in <del>USA Swimming</del> Metro shall be registered as individual members with Metro. <del>Membership is subject to USA Swimming policies, rules and regulations and Metropolitan Swimming policies and procedures. Membership is a privilege, not a right. Along with membership comes duties and responsibilities. This includes anyone who is an official, meet director, club representative, or safety coordinator.</del>

207.2 The registration fee will be determined by the House of Delegates.

Article 208 - Other Individual Responsibilities

208.1 All individual members must abide by the USA Swimming Code of Conduct. [USA 304]

Article 301 - Types of Meets

301.1 A sanctioned meet is open only to USA Swimming athletes and shall follow all USA Swimming rules. They may be one of the following:

- .1 An "Open" meet is open to all registered USA Swimming athletes who meet the entry requirements.
- .2 A "Closed" meet is restricted to members of USA Swimming teams that have formed an association to compete amongst themselves and follows all USA Swimming rules.
- .3 An "Invitational" meet is open only to those USA Swimming teams that have been invited by the host team. The teams that are invited shall be named in the meet information announcement for the meet to be listed on the Metro website. When inviting all Metro Teams, it may be listed as "All Metro Teams"
- .4 A "Championship" meet is a meet open only to Metro athletes and has been so designated by the House of Delegates.
- .5 A "Dual/Tri/Quad" meet is a sanctioned competition in which two, three, or four teams compete against each other.
- .6 "Time Trials" is a form of competition whereby athletes are trying to achieve a qualifying time. Time Trials are not scored. Time Trials may or may not be restricted to athletes entered in an affiliated meet. The total number of events permitted per day in a Time Trial and its affiliated meet is subject to the USA Swimming rules that limit the number of events per day. Time Trials may not be used for National Age Group Records. Time Trials must have separate sanctions.

.7 An "Approved" meet is open to both USA Swimming athletes and non-USA Swimming athletes but follows all USA Swimming rules. [USA 202.4]

.8 USA Swimming athletes in a competition that does not conform to USA Swimming rules such as High School, College, or YMCA Championships may request Observed swims. <del>[USA 202.5]</del> 301.2 In all open meets, Metro clubs shall be given priority on a first come / first serve basis if their entries are received by a specified time and date. After that time and date, teams from other LSC's as well as later entries from Metro <u>may be accepted</u> will be entered, in the order they were received, as space allows. Teams may establish a second time and date for all entries to be received. 301.3 At B Min. meets, entries shall be accepted according to date received. At A or un-classed meets, entries may be cut by date received or according to times submitted but the method shall be stated in the meet bid and entry information.

#### Article 302 - Meet Program

302.1 The recommended events for competition are listed in USA Swimming Rule 102.1. Metro may permit a meet host to run a competition with events not listed in the USA Swimming Rules (i.e. Sprint Pentathlon).

302.2 In all <u>non-invitational</u> meets after the 1st Sunday in November until September 1st of the following year, at least 50% of the events shall be from the long events for each sex gender and age group.

10 & Under Short: all 50's and 100 I.M.

10 & Under Long: all 100's except 100 IM, all 200's and longer

11-12 Short: all 50's and 100 I.M.

11-12 Long: all 100's except 100 IM and all 200's and longer

13-14 Short: all 100's and 50 Free 13-14 Long: all 200's and longer 15-18 Short: all 100's and 50 Free 15-18 Long: all 200's and longer

302.3 \$6,000.00 subsidy will be allocated based on the number of clubs that bid and host a distance meet from September through April. The total budget for that season will be divided equally among the accepted meets, with no team exceeding \$1,000 per meet. The distance meet shall be a separate meet with a separated sanction number from any other meet sponsored by that club on the same weekend. All the events shall be on the same day. The 1650/1500 Free may be in a separate session. The events that shall be included are: 11-12 400 IM, 13-14 400 IM, 10 & Under 500 Free, 11-12 500 Free, and Open 1650 Free. The Open 400 IM may be offered at the option of the host club. The age groups in the 400 IM and 500/400 Free may be combined but separate awards shall be given for each age group. Teams that want to add events to this list shall ask the Board prior to receiving their sanction, in writing, for an exception to this rule. The host team may collect entry fees.

#### Article 303 - Meet Entries

303.1 Swimmers are limited to the number of individual events as stated in the meet <u>announcement</u> information. The number of individual events a swimmer competes in per day cannot exceed 5 events for timed finals and 3 events for trials and finals. This includes the total number of events swum in a swim meet and its affiliated time trial. [USA 102.2]

303.2 If there is an established qualifying time in an event, then the swimmer shall have met the qualifying time to enter the event. The time shall have been done at a sanctioned, approved, or observed swim meet, or time trial (the time must be in the SWIMS database).

- 303.3 All changes of entries into a swim meet shall be made through the meet director or other designated meet personnel.
- 303.4 All entry information shall use the athletes name and IeD numbers as recorded by the registrar. Teams are subject to a \$100 fine per individual for third and subsequent errors, for that individual when they are detected by the "recon".
- 303.5 If an entire team's entry is rejected from a meet the host team shall return all entry items. If a team is partially rejected from a meet all refunds shall be made to the entering team by the first day of the meet. Notification of rejected entries shall be made personally to the coach, swimmer, or club representative prior to seven days before the start of the meet. If notification is not made within the allotted time frame, the swimmer(s) shall be allowed to swim.
- 303.6 In Metro Championship meets swimmers may not swim in more than two-time trials during the meet and shall abide by the limit on total number of events per day and per meet as follows:
- .1 Senior Metropolitan Championships Swimmers may swim up to 3 individual events per day and 6 events total.
- .2 Age Group Championships (formerly Junior Olympics) Swimmers may swim up to 3 individual events per day. Each Rrelay must be made of at least 2 athletes entered in individual events.
- .3 Silver Championships Swimmers may swim up to 5 events per day.
- .4 Bronze Championships Swimmers 9-18 may swim up to 4 events per day.
- 303.7 When entering championship meets, clubs having more than one base, shall enter using a single file and shall pay using 1 check or money order. For all other meets the different bases may enter and pay independently.
- 303.8 All entries must be submitted using a Hy-Tek or Team Unify computer file or any other program approved by USA swimming.
- 303.9 All entries are subject to pre-meet recon for proof of times and registration
- 303.10 The entry deadline for Metro Championships meet shall not be more than 10 days prior to the first day of the meet.

#### Article 304 - Entry Fees

- 304.1 The maximum entry fee that may be charged at non-invitational meets is:
- .1 In short course yards/meters beginning September 1, 2016 \$5.00 for an Individual Timed Final event, \$6.00 for an Individual Trials & Final event, and \$10.00 for a Relay event.
- .2 In long course meets beginning September 1, 2016 \$6.00 for an Individual Timed Final event, \$7.00 for an Individual Trials & Final event, and \$12.00 for a Relay event. The maximum allowable entry fee for an individual timed finals or trials and finals event for the short course and long course Senior METS championship is \$12.00.
- 304.2 20% of the entry fees, except those of the host club (Clubs may have an additional host(s) but only one team may be exempt from the surcharge), constitute the Metro surcharge and shall be paid by the host club to Metro. This does not apply to distance meets. Any teams that host Invitationals that invite "all Metro Teams as well as teams from other LSC's will still have the 20% surcharge waived for their swimmers.
- 304.3 There is a per swimmer surcharge at the following Championship meets:
- .1 Senior Met surcharge is \$20.00
- .2 Age Group Championships (formerly Junior Olympics) surcharge is \$5.00
- .3 Silver Championships surcharge is \$1.00
- .4 Bronze Championships surcharge is \$1.00
- .5 8 and Under Championship is \$1.00

.6 Metro Championship meets hosted by Metro Clubs shall be allowed to add a facility surcharge up to and not to exceed \$4.00. The Total surcharge of the facility charge plus the Metro surcharge of \$1.00 shall not exceed \$9.00 for Age Group Championships (formerly Junior Olympics) and \$5.00 for Silver, Bronze and 8 and Under Championship meets.

304.4 Entry Fees for Championship meets, excluding Senior Mets, shall be:

- .1 \$7.50 for Timed Finals Events
- .2 \$9.00 for Prelims/Finals Events
- .3 \$15.00 for Relays

#### Article 305 - Scratch Procedure

305.1 Unless otherwise stated, scratches are due 30 minutes prior to the start of the session. Any swimmer who is seeded shall swim the event. Scratch deadlines shall be included in the meet announcement.

305.2 In events where it is permitted, a swimmer may declare a false start prior to the start of the event. timed finals events or preliminaries of a trials and finals event, if a seeded swimmer does not want to swim, the procedure is as follows:

- .1 The swimmer should obtain a "Declare False Start Report".
- .2 The swimmer fills out the name, event, heat, lane, checks off false start, and writes "declared" next to it.
- .3 The swimmer shall turn the report in to the Referee at the start of the event and prior to their heat. 305.3 In Age Group Championships (formerly JO's), Silvers, Bronze and 8-Under Championship meets, no penalty shall apply for failure to withdraw or compete in an individual event. The missed event will still count against the athlete's event limit for the day and for the meet.
- 305.4 A swimmer qualifying for a D,C, B, or A (bonus, consolation, championship) final race based upon the results of the preliminaries notifies the Clerk of the Course within thirty (30) minutes after announcement of the qualifiers for that race that they may not intend to compete and further declares their final intentions within thirty (30) minutes following their last individual preliminary event. <del>[USA 207.7.9D]</del>
- 305.5 A swimmer who fails to follow this procedure will be barred from further competition for the remainder of the meet, except as noted in USA Rule 207<del>.7.6</del>11E. If this occurs during the last session of a championship meet the swimmer's club will be fined \$150.00 per occurrence.
- 305.6 Any relay team entered in a relay event at Age Group Championships (formerly Junior Olympics) only and is <u>a</u> no show (NS) they will not be penalized. Any relay team entered in a relay event at Sr. Mets and not properly scratched must swim. Failure to do so will result in each member of the relay team being barred from the next relay event in which they may otherwise be eligible to compete. A relay team member failing to appear ready to swim for a relay event will be barred from his/her next individual event. Relay members who do appear ready to swim shall not be penalized.

#### Article 306 - Warm-up Procedure

306.1 Coaches shall instruct their swimmers regarding the safety guidelines and warm-up procedures at meets. Coaches shall actively supervise their swimmers during the warm-up session at meets. 306.2 The Host Team shall supply Meet Marshals. Marshals shall be clearly identifiable (i.e. Orange safety vest). Coaches supervising swimmers in the pool during warm-up do not qualify as meet marshals. Meet Marshals shall check locker rooms as well as being responsible for safety on deck. Marshals shall have full authority to warn or order to cease and desist, and, with the concurrence of the Referee, to remove, or have removed from the swimming venue anyone behaving in an unsafe manner or using profane or abusive language, or whose actions are disrupting the orderly conduct of the meet.

[USA 102.18] There shall be at least 1 male and 1 female marshal. The minimum number of required marshals is as follows:

- .1 A six lane pool requires two marshals.
- .2 An eight-lane pool requires three marshals.
- .3 A ten lane pool requires four marshals.
- .4 If two different courses are being used, two additional marshals are required.
- 306.3 Warm up times and lane assignments shall be published in the meet information and posted at several locations around the pool area. [USA 202.2.9]
- 306.4 Backstrokers shall ensure that they are not starting when a swimmer is on the blocks. Swimmers are not to step up onto the blocks if there is a backstroker ready to start.
- 306.5 Swimmers shall exit the pool at the completion of their warm-up. This will allow other swimmers adequate warm-up time.
- 306.6 Host clubs may establish warm-up procedures for their own swim meets, remembering to include one way sprint lanes and pace lanes if desired, so long as safety considerations are not compromised. Established procedures shall conform to Metro and National policies. Any such procedures shall be announced, and/or posted in the pool area.
- 306.7 There is no diving into the pool during any warm-up, except for designated one-way sprint lanes. 306.8 These warm-up procedures shall be followed during pre-meet warm-up, warm-ups inserted into the meet program, and warm-ups in any available warm-up/warm-down lanes.
- 306.9 In Championship meets, if there is a 60-minute warm-up period, the first 30 minutes will general warm-up in all lanes. In a six-lane pool, at 30 minutes prior to the start of the meet, lanes 1 and 6 will be designated for pace, and lane 2 will be designated for one-way sprints, and at 20 minutes prior to the start of the meet lane 5 will also become a one-way sprint lane. In an eight-lane pool, at 30 minutes prior to the start of the meet, lanes 1 and 8 will designated for pace, and lanes 2 and 7 will be designated for one-way sprints, and at 20 minutes prior to the start of the meet lanes 3 and 6 will also become one way sprint lanes. In a ten-lane pool, at 30 minutes prior to the start of the meet, lanes 1, 2 and 10 will designated for pace, and lanes 3 and 9 will be designated for one-way sprints, and at 20 minutes prior to the start of the meet, lanes 2 and 8 will also become one way sprint lanes. The competition pool will be cleared 5 minutes prior to the start of the meet.
- 306.10 In Championship meets, if there is a 90-minute warm-up period, the first 30 minutes will general warm-up in all lanes. In a six-lane pool, at 60 minutes prior to the start of the meet, lane 1 will designated for pace, at 45 minutes prior to the start of the meet, lane 2 will be designated for one-way sprints and lane 6 for pace, and at 30 minutes prior to the start of the meet, lane 5 will also become a one way sprint lane. In an eight-lane pool, at 60 minutes prior to the start of the meet, lane 1 and 8 will designated for pace, at 45 minutes prior to the start of the meet, lane 2 will be designated for one-way sprints, at 30 minutes prior to the start of the meet, lane 3 and 7 will also become one way sprint lanes. In a ten-lane pool, at 60 minutes prior to the start of the meet, lanes 1 and 10 will designated for pace, at 45 minutes prior to the start of the meet, lane 2 becomes a pace lane and lanes 3 and 9 will be designated for one way sprints, and at 30 minutes prior to the start of the meet, lane 2 and 8 will also become one way sprint lanes. The competition pool will be cleared 5 minutes prior to the start of the meet.

#### Article 307 - Meet Procedures

307.1 Coaches shall present USA Swimming certifications for access to the deck. Coaches without up-to-date certifications shall not be on the pool deck. <del>DECK PASS LIVE</del> The USA Swimming App may be used to verify coach's registration

- 307.2 Non-USA Swimming Registered individuals are not permitted on the pool deck at any time during the meet or practice, except for Official Timers.
- 307.3 Only properly registered USA Swimming certified officials may be used. Clubs may ask the Officials Chair to supply officials for a meet by requesting them 30 days prior to the meet.
- 307.4 Hazards on deck, in the locker rooms, or in areas used by coaches, swimmers, spectators, or officials shall be removed or clearly marked.
- 307.5 Meet marshals are responsible for meet safety for the duration of the meet.
- 307.6 The Host Club is responsible for supplying backup timers for each lane as required by USA Rule 102.12.3 or 102.12.4. Timers should be available 15 minutes prior to the start of the meet to receive instructions by a designated meet official and the lane timing sheets.
- 307.7 In Metro run Championship meets, clubs will be assigned to supply timers based on their entries in the meet.
- 307.8 Computer operators who work a "Metro-run" Championship meet from start to finish, including pre-meet and post-meet work, will receive \$150 per session. Person doing Pre-meet preparation only will receive \$75 per session. Person running the computer only or the timing system only will receive \$75per session. Announcers for Metro run championship meets will receive \$50 per session.
- 307.9 An announcer shall be on duty for the entire warm-up session to announce lane and/or time changes and to assist with the conduct of the meet.
- 307.10 Bells shall be used to signify the final two lengths of a distance event.
- 307.11 Swimmers shall start from within the water if the water depth is 3'6" or below. If the pool depth is above 3'6", but below 4' swimmers may start from the deck or in the water, not the starting platform. [USA 103.2.3]
- 307.12 In all Metro swim meets, awards given for 12 & Under will match the number of lanes in the pool.
- 307.13 All swim meet sessions shall finish within 4 hours of the announced starting time. The only exception is a club hosted LCM Meet, the host team can run a 13 and older session at 5 hours with no penalty. Sessions set at Open events must follow the 4-hour limit rule. [BOD January 11, 2012]
- .1 Any session that runs more than 4 hours past the announced starting time shall be reported to the Admin<u>istrative</u> Vice Chair. There is no grace period, except if there is a major malfunction of the timing system, lightning, power failure, or major problem. [HOD January 18, 2011]
- .2 The Administrative Vice Chair should consider the following in determining penalties:
- A. Whether the violation was caused substantially by a matter beyond the control of the host. Such a violation may require censure and/or probation.
- B. The violation was caused unintentionally because of negligence or incompetence. Such a violation requires censure and/or probation and a minimum fine of all entry fees representing those swims which went beyond the four-hour limit.
- C. The violation was intentional. Such a violation requires a minimum fine of all entry fees representing those swims which went beyond the four hour limit, an additional monetary fine, a period of probation, and being barred from hosting any meets during the same season and the following short course and long course seasons including any for which sanctions had already been received.
- 307.14 In multiple session meets, if there are fewer than 60 minutes between the end of one session and the start of warm-up for the next session, the meet host shall provide a meal for coaches. It is recommended that meet hosts provide refreshments for coaches, officials, and volunteers at all swim meets.
- 307.15 The Host Club shall run the "recon" report at least 7 days prior to the swim meet and send it to the Metro office to certify that all swimmers entered in the meet are registered swimmers and are

eligible to represent the club they are entered with. Clubs that fail to comply will be sent to Board of Review.

Article 308 - Meet Bidding and Information

Short Course Meets – September through April

308.1 Bids must be submitted in writing on a Bid Application no later than April 15th. All information must be completed on the application. Payment is required at the time of the bid application. Meet directors listed on the bid application will be contacted by email no later than April 30th with the tentative schedule. Meet directors will have until May 7th to notify the Metro office of any changes/corrections. Final schedule will be posted after the May mandatory HOD meeting. Championship Bids/Schedules – If more than one team bids for a championship meet – those meets will be decided by vote of the HOD. If there is only 1 bid for each meet, those bids will be accepted.

Long Course Meets – May through August

308.2 Bids must be submitted in writing on a Bid Application no later than February 1st. All information must be completed on the application. Payment is required at the time of the bid application. Meet directors listed on the bid application will be contacted by email no later than Feb. 15th with the tentative schedule. Meet directors will have until February 20th to notify the Metro office of any changes/corrections. Final schedule will be posted on the Metro web site no later than February 28th. Championship Bids/Schedules – If more than one team bids for a championship meet – those meets will be decided by email vote of the HOD. If there is only 1 bid for each meet, those bids will be accepted.

- 308.3 If bidding for a Metro subsidized distance session, this shall be indicated on the bid.
- 308.4 Any bids received after the due dates will be assessed a \$50.00 fine if accepted.
- 308.5 Any other meet on a Metro Championship weekend shall be two levels removed.
- 308.6 The Board has the right to grant additional meet sanctions if it feels that a significant need exists.
- 308.7 Once a team is given a sanction, the following penalties will apply for failing to hold the meet:
- .1 Canceled more than 12 weeks before the meet or by the Fall meeting of the LSC loss of sanction fee
- .2 Canceled between 6 and 12 weeks prior to the meet loss of sanction fee and a fine equal to the sanction fee.
- .3 Canceled less than 6 weeks prior to the meet loss of sanction fee, a fine equal to the sanction fee and the granting of one less sanction in the next year than the number of meets actually held in the year the meet was canceled.
- .4 Canceled after the meet information is sent out loss of sanction fee, a fine equal to the sanction fee and the inability to hold any sanctioned meets the following year.
- 308.8 The penalties may be waived in part or in whole by the Board of Directors or the House of Delegates. They should consider: a. Was the reason for cancelation beyond the control of the club? b. Was the reason foreseeable? c. Did the reason lie primarily in lack of entries or lack of personnel? 308.9 Any party that feels the penalties have been unfairly applied may appeal to the Board of Review. 308.10 There is a sanction fee of \$25.00 per session except:
- 308.11 The sanction form and fees shall be sent to the Metro Office. The meet information should not be posted on the web or otherwise distributed until the sanction has been granted.

- 308.12 Meet directors are required to have meet information posted on the Metro Website. Teams wanting a hard copy shall request it.
- 308.13 The meet template on Metro website MUST be used and shall include the following: sanction #, date(s), site, class(es), events, start time for warm-up and competition, entry fees, mailing address, meet Director's email address phone number, method of cutting entries, awards (number and type), and warm-up procedures. The following items shall also appear in the meet information:
- .1 "Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet."
- .2 "Swimmers with disabilities are encouraged to enter and participate. Please notify the meet director of any accommodations you might require."
- .3 Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms and behind the blocks. The use of drone operation also must be included.
  .4 USA 2011 −202.3.7 "The meet announcement shall include information about water depth measured for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."
  .5 The meet announcement shall include the pool has/has not been certified in accordance with Article 104.2.2C (4)
- .6 Meet announcements and requirements for approval of competition shall include the all requirements as per USA swimming rules and regulations, as well as Metro meet template
- .7 Beginning September 1st, 2017 All Meet bids must include four officials that are registered to the host team.
- .8 Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact <u>the</u> meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.

#### Article 309 - Championship Meet Bids

309.1 A Metro Championship Contract form shall be used to bid on a Championship Meet. 309.2 Clubs hosting a Metro Championship Meet shall send a copy of the Entry Blank to both the Technical Planning Chair and either the Age Group or Senior Chair whichever is appropriate. 309.3 Metro will take responsibility for running Zone Qualifier's and Senior Mets. [All teams bidding to host Metro Championship meets shall provide information about fees for admission, programs, and parking at the time of bidding (to go on Championship Contract Form)]

#### Article 310 - Championship Meets

310.1 There will be 3 sets of time standards for all Senior Championship Meets. The conforming standard is the time in the course the meet is <u>to</u> be conducted in. The other time standards will be calculated from the standard in the conforming course. Entry times for Championship meets may not be converted from another course. The meet eligibility date for all short course Metro Championship meets (Senior Mets, Age Group Championships (formerly JO's), Silvers, Bronze), will be from January 1st of the previous year. For the long course season, the eligibility date will be as of May 1st of the previous year. [HOD January 13, 2010]

310.2 The Meet Director shall appoint a Technical Jury composed of at least one athlete representative, at least one coach, and at least one, but not more than three other persons. Written protests involving technical rules, except disqualifications due to judgment decisions by the deck officials, shall be made to the meet referee within 30 minutes of the protested act or occurrence. Decisions of the meet referee regarding these protests may be appealed to the Technical Jury, whose decision shall be made the day of the protest and shall be final.

310.3 Championship meets may run over the Metro 4-hour time limit. The meet host or Metro may alter the warm-up time and starting times of sessions to accommodate long sessions. All teams entered in the meet shall be notified of any changes of this nature 7 days in advance of the meet. Each club should provide an e-mail address or other means of being contacted with their entries so that this notification can be made.

310.4 All entries will be verified for registration and time reconciliation using a pre-meet recon file.

310.5 There will be a separate table for the Clerk of Course at championship meets.

310.6 Regions for Championship Meets that are held at multiple sites will be determined by the Technical Planning Committee and posted on the Metropolitan Swimming website.

310.7 Warm-up times for Short Course Senior Mets will be at 7:30AM with a 9:00AM start for prelims and 4:30PM with a 5:30PM start for finals, except for Sunday evening finals, which will have a 4:00PM warm-up with a 5:00 p.m. start for finals. Senior Mets is a trials and finals meet. The starting time for the 1650 or 1500 at Senior Mets will be adjusted so that last preliminary heat would end 10 minutes before start of warm-up for finals. When Senior Mets is held in a facility with no warm down area, the warmup / warm down schedule will be determined by the Senior Chair in conjunction with the Technical Planning Committee. Long Course Senior Mets Championships will follow the same format as the Short Course Senior Mets Championships. The Senior Chair in consultation with Technical Planning may decide to permit Bonus events (event(s) awarded to a swimmer as a result of making a qualifying time), the qualifying time, and the formula for entry based on anticipated size of the meet.

310.8 Updated scratch and check-in procedures at Senior Mets to follow USA Swimming National procedures. Distance events would stay as positive check-in. The prelims events will be due the night before (half hour after the finals session starts). An email address will be provided to scratch remotely. [HOD Sept 15th, 2018]

310.9 Finals for Age Group Championships (formerly Junior Olympics) will be conducted in Ten lanes. Each age group will have their own cuts (i.e. 11yr old cuts, 12yr old cuts, 13yr old cuts, 14yr old cuts 10 & Under events are swum as timed finals. They will be scored/awarded separately as 9 & Under and 10-year-old events. For the 11-12 and 13-14 age group, there will be 2 'A' finals run at night - a top age (12 or 14) final and a lower age (11 or 13) final.

Medals will be awarded for 1st -3rd in each A Final which will be single age finals, 9u, 10 11, 12, 13 14 and ribbons to be awarded finishers 4th-10th in each final.

A plaque or trophy will be awarded to the individual high point winner for both genders in all single ages. There will be team awards at Age Group Championships (formerly J.O.'s) for 10& Under, 11&12, and 13&14 age groups. 10 & Under will have only 1 relay per day at Age Group Championships (formerly J.O.'s). All 10 & under events, the 11&12 400 IM & 500 Free, 13-14 1000 Free, and the 15-18 1650 Free are run as timed finals. All other events are trials and finals.

310.10 Silver Championships will be held at 3 Regional sites on the same weekend. Each age group will have their own cuts 9 & under, 10, 11, 12, 13,14, 15-18. Swimmers shall achieve the established time which will be .01 slower than the Age Group Championships (formerly J.O.) time standard for that single age. The minimum Silvers time will remain the same for both odd and even ages. At Silver Championships those achieving the Age Group Championships (formerly J.O.) Qualifying Standard will receive an Age Group Championships qualifying ribbon and, may enter the Age Group Championships even if the entry deadline has passed. Medals are awarded for places 1-3 and ribbons for places 4-8 (or remaining lanes in the competition pool)

310.11 Bronze Championships will be held at 3 Regional sites on the same weekend for age 9 through 18. Swimmers shall be slower than the Silver time standard [HOD May 16, 2012]. Medals are awarded

to as many swimmers as there are lanes in the pool. Ribbons will be awarded to next group of swimmers for as many lanes as there are in the pool.

310.12 Relays may be entered at the lowest priority cut, provided the team has qualified for the event.

### Article 311 - Post Competition Responsibilities

- 311.1 Clubs hosting meets shall send a full meet backup within 24 hours of the conclusion of the meet. - 311.2 Beginning January 1, 2013 The following shall be submitted to the Administrative Chair within 30 days after each meet:
  - a. Meet Manager Team Fees Report (1 day Prior to the start of the meet),
  - b. Meet Manager Team Fees Report (at the end of the meet),
  - c. the post competition report,
- d. the income and expense report, and e. a check for the meet surcharges. Host teams are exempt from paying surcharges on entries for their own swimmers

## **Bylaws**

7.3 COMMITTEES In addition to the standing committees listed herein, the Board of Directors and the House of Delegates are each authorized to establish additional committees to meet programming needs. Except as otherwise provided in these Bylaws or the MRSI Policies and Procedures, members of each committee shall be appointed by the General Chair chair of the committee with the advice and consent of the respective division chair and the chair of the committee Board of Directors. Athlete members of each committee shall be appointed by the General Chair chair of the committee with the advice of the Board of Directors Senior Athlete Representative. Athlete membership shall constitute at least twenty percent (20%) of the voting membership of every committee. The division chair shall be an ex officio member, with voice and vote, of each committee within the respective division.

#### Policies and Procedures Manual

418.2 The members of the Officials' Committee are appointed by the Officials' Chair with the advice and consent of the Administrative Vice-Chair. With the exception of the Athlete Representatives, all committee members must be certified officials in good standing and they will be appointed for two-year, renewable terms. The Committee will consist of the following: The Officials' Chair, a New Officials' Training Coordinator, an Advancement and Certification Coordinator, an At-Large member, and two Athlete Representatives. The Administrative Vice-Chair will have a voice on the Committee but no vote. The New Officials' Training Coordinator and the Advancement and Certification Coordinator must have a minimum of three years' experience as a certified Referee and must have, at a minimum, current N2 DR certification and preferably will have current N3 DR, SR, and CJ certifications. The At-Large member must, at a minimum, be certified as a Stroke and Turn Judge within the LSC.
