- FORMAT:** **Sessions 1 and 4 are prelims, Sessions 2 and 5 are Timed Finals for 10 & Under & Prelims for 11-12, Sessions 3 and 6 Finals. Top 16 Prelim swimmers advance to evening finals Meet will be Pre-seeded. See Scratch section for Scratch Deadlines.**
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. No "Deck Registrations" will be accepted. Priority will be given to those teams attending all 3 days. Age on **1/27/2024** will determine age for the entire meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.
- FALSE REGISTRATIONS: If a swimmer who is not properly registered with USA Swimming competes in a sanctioned competition, the host LSC will impose a fine of up to \$100.00 per event against the individual, member coach or a member club submitting a meet the entry.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to enter and participate. Please notify the meet director of any accommodations you might require.
- The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** Any swimmers in prelims in the am and pm sessions may swim a maximum of 3 individual events per day (prelims and finals).
10 and under Timed Finals may swim a maximum of 4 individual events per day.
- Priorities will be given to those teams attending Both Days.
Minimum Age For Senior Events is 15 years old.
- The meet will be pre-seeded.**

- ENTRY FEE:** An entry fee of **\$6.00 per timed final event, \$7.00 per Trial & Final event, \$12.00 Surcharge per swimmer** must accompany the entries.

entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact the Meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.

WARM-UP: Warm up lanes will be assigned.

SCRATCHES:

Scratches for Saturday morning Trials and Afternoon Timed Finals Will be due **Friday, Jan 26 @ 4:30 pm.**

Scratches for Sunday morning Trials and Afternoon Time Finals Will be due **Saturday, Jan 27 @ 4:40 pm**

Swimmers have 30 minutes from the announcement of trials results, to declare intent to scratch from finals. Finals no shows will be scratched from the remainder of the meet. Prelim no shows will be scratched from their next event."

COACHES:

In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

AWARDS:

For all individual events, awards will be for 1st - 8th place,

Coaches **MUST** pick up their team ribbons at the end of the meet. Awards will not be Mailed out.

RULES:

The current USA Swimming Rules and Regulations will apply.
The USA Swimming Code of Conduct is in effect for the duration of the meet.
The overhead start procedure may be used at the discretion of the meet Referee.

SAFETY:

All swimmers must wear footwear upon leaving the pool area.
Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

USA 2011 - 202.3.7 "The meet announcement shall include information about water depth measured for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."

Do not stand on the edge of the pool (leave approximately two feet for officials and coaches).
