ELIGIBILITY: Open to all Invited SSC-MR USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302. No Deck Registrations will be accepted
Age on May 29, 2024 will determine age for the entire meet.
