- LOCATION:** **Sachem East HS, 177 Granny Road, Farmingville, NY 11738**
- FACILITY:** **6 Lane x 25 yard competition pool, Daktronics Timing System, touch pads primary, with 6 lane Numeric scoreboard. Competitor lane lines, Kiefer Advantage Starting Blocks**
The pool **Has NOT been** certified in accordance with Article 104.2.2C(4)
- SESSIONS:** **Session 1 - 400IM/500FR - 7:30AM Warm Up, 8:30AM Start Time**
Session 2 - 1650 Freestyle 12:45PM Warm Up, 1:30PM Start Time
- FORMAT:** **This is a Timed Finals Meet. Events will be swim Fastest to Slowest.**
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet.
No "Deck Registrations" will be accepted
Age on **November 23, 2024** will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration.
The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** All Athletes are limited to enter 1 event only. Deck entries will ***not*** be accepted.
NT's will not be accepted. Host team reserves the right to enter NT's.
Entries are by invited teams only. Hy-Tek Email entries will be accepted

- DEADLINE:** 1: Invited Metro LSC teams will be given priority on a first come/first served basis.
2: The final entry deadline for this meet is **November 15, 2024**
3: Entries received between **October 1, 2024** and **November 1, 2024** will be entered first. Entries from others will be entered in the order they were received, as space allows.
An email confirming receipt of entries if you provide an email contact.
- ENTRY FEE:** An entry fee of **\$8.00** per individual event must accompany the entries. (400IM/500FR)
An entry fee of **\$10.00** per individual event must accompany the entries (1650 FR)
A Facility Surcharge of **\$7.00** per swimmer must accompany the entries.
Make check payable to: **Sachem Swim Club of Long Island, Inc.**
Payment must be received by **11/23/24** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by the deadline could result in teams being barred from the meet.
Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers.
Coaches should contact meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.
- WARM-UP:** General warm up with assigned lanes for the first 40 minutes. Sprint lanes and General lanes will be available for the remaining 20 minutes. Lane assignments will be distributed along with the scratch sheet each session.
- SCRATCHES:** Scratches are due 20 minutes after warmup begins.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

RULES: The current USA Swimming Rules and Regulations will apply.

The overhead start procedure will be used at the discretion of the Meet Referee. .

SAFETY: All swimmers must wear footwear upon leaving the pool area.
Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet.
Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement.
