- SANCTION:** Held under the sanction of USA Swimming/Metropolitan Swimming, Inc., # 251110-DST, TT #251155-TT
- LOCATION:** Bard College Pool, Stevenson Gym, Bard College, Annandale-on-Hudson, NY 12504
- FACILITY:** 25-yard pool with six 7-foot lanes; non-turbulent lane lines; seating for 150 available; Colorado electronic timing system and scoreboard.
The competition course **has NOT** been certified in accordance with Article 104.2.2C (4).
- SESSIONS:** **Session 1: warm-ups at 7:15 AM – Meet starts at 8:00 AM**
Additional warm-up opportunities may be added between events at the discretion of the Meet Referee.
Session 2: Time Trials: approximate start time 11:00 AM
- FORMAT:** All events are timed finals. NTs are accepted. **Positive check-in deadline for the 1650 is 4:00 PM Saturday, November 22nd.** All other events are deck seeded.
1650 swum fast to slow, all other events swum slow to fast.
- ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.
All swimmers participating in this meet must be registered by the first day of the meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.
No deck registrations will be accepted.
Age on **November 23, 2025** will determine age for the entire meet.
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to enter and participate. Please notify the meet director of any accommodations you might require. The athlete (or the athlete's coach) is also responsible for notifying the Meet Referee of any disability prior to the competition.
- ENTRIES:** **Swimmers are permitted 1 individual event.**

- DEADLINE:** 1: Metro LSC teams will be given priority on a first come/first served basis. Metro teams entries must be received by **Nov 14, 2025**.
2: The final entry deadline for this meet is **Nov 16, 2025**
3: Metro Entries received between **September 22, 2025** and **November 16, 2025**
Entries from other LSC's will be entered in the order they were received, as space allows.
An email confirming receipt of entries will be sent. Please contact the Meet Director if you do not receive a confirmation of entries within 2 days of your original email.
- ENTRY FEE:** An entry fee of **\$15** per individual event.
Make check payable to: **NDAC**.
Payment must be received by **November 19, 2025**. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact the Meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.
- WARM-UP:** **The host team will assign warm-up lanes and time slots to each team for each session. The information will be distributed a few days prior to the meet.**
- SCRATCHES:** **Positive check-in deadline for the 1650 is 4:00 PM, Saturday, November 22nd.** All other events are deck seeded and coaches will be given scratch sheets, scratches are due 30 minutes before start.

COACHES:	In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

RULES:	The current USA Swimming Rules and Regulations will apply. The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the Meet Referee. Swimmers without a coach must contact the Meet Director and will be assigned a coach on deck.
SAFETY:	Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement. Lifeguards will be on deck during warm-ups and during the sessions. An AED is on site.
MAAPP POLICY:	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.
WATER DEPTH:	Start end: Water depth at 1 meter from the wall is 13 feet, at 5 meters it is 12 feet. Turn end: Water depth at 1 meter from the wall is 4 feet, at 5 meters it is 4.5 feet.
DISCLAIMER:	DISCLAIMER: Upon acceptance of his/her entries, the participant waives all claims against Bard College and Northern Dutchess Aquatic Club , Metropolitan Swimming Inc., USA Swimming Inc., their agents or representatives for any injury occurring as a result of the meet. It is understood that USA Swimming, Inc. and Metropolitan Swimming, Inc. shall be free from liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event.
AUDIO/VISUAL STATEMENT:	Use of Audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms, locker rooms. Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
DECK CHANGING:	Deck changes are prohibited.
ADMISSION:	Admission is free for all spectators.
MERCHANTS:	Swimsuits, goggles and apparel will be available on site. Food will be available for purchase.

Parking lot on Annandale Rod across the Stevenson Gym. Illegally parked cars will be towed at the owner's expense.
