are invited to this meet.

Age on January 21, 2023 will determine age for the entire meet.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than

30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual event

scratches and which swimmers will not be participating in the session.

**MAAPP Policy:** 

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.

RULES & Policy:

Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP") will govern this meet. The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee. "Deck changes are prohibited". The YMCA is a smoke free facility. No food or glass of any kind permitted in pool area or halcony.

Any photographer or videographer, who intends to take pictures at a Metropolitan Swimming sanctioned meet, must complete and submit a Photographer Registration form to the Meet Director before commencing activity. Forms are available on the Metro Swimming web site as well as from the Meet Director. "Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present."

SAFETY:

Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.

"Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge.

When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal quardian, to ensure compliance with this requirement."

There will be lifeguards on duty for the duration of the meet. There is an AED device available at the front entrance of the YMCA and there are emergency alarms on the pool deck.

WATER DEPTH: Diving end water depth – 12 feet at 1 meter, 8 feet at 15 meters Shallow end water depth – 4 feet at 1 meter, 10 feet at 15 meters

DISCLAIMER:

No Spectators permitted in the pool balcony. No admission charge. Heat sheets will be posted.

OR THE MUNICIPAL LOT ACROSS THE STREET FROM THE REAR ENTRANCE TO THE Y

#### Supervision:

Each club is requested to handle its own team and discipline problems. Anyone found guilty of vandalism or disorderly conduct will be ejected from the meet. No one is permitted above the 2nd floor of the YMCA. Coaches must show their current U.S.A. membership card to pick up meet packet. Only currently certified

<u>Spectators/Swimmers/Coaches:</u> Limited spectator seating will be provided in the balcony. When capacity is reached, additional spectators may view meet via TV in the main lobby.

<u>Swimmers will be seated on deck and in the pool balcony while they await their events.</u> Three coaches only per team on deck at a time. Pool deck will include swimmers, timers, coaches, marshals and lifeguards. No smoking allowed in the building.

### Wearing of mask is recommended but not required.

All swimmers at the Flushing Y will be seated on deck approximately 6 ft apart. Additional swimmers will be seated in the pool balcony. Swimmers will line up on side of pool deck one heat in advance and then be escorted to their lanes. We will be following NYC DOH, US Swimming and YMCA Covid guidelines. Spectators will NOT be allowed behind the glass partitions outside of the pool balcony. Any spillover will be in the main lobby with a TV monitor that will have a live feed from the pool balcony. Additional parents will be on deck timing, officiating and marshaling.

Follow about 5 blocks to 35th Ave. Make left onto 35th Ave. Go 1 block to Leavitt St. Make right. Go 1 block to Northern Blvd. Make right onto Northern Blvd and then immediate left turn/U-Turn before Linden Place. The YMCA will be on your right after Union St.

#### **DIRECTIONS:**

<u>From Triboro Bridge</u> - Take Grand Central Pkwy to Northern Blvd/Shea Stadium exit. Follow signs to Northern Blvd. YMCA will be about one mile on the right.

<u>From Whitestone Bridge</u> - Stay to the right when coming off the bridge. Exit at Linden Place and follow as above.
