FORMAT: This is a timed-Final Meet.

The meet will be deck-seeded. Events will be seeded Slow to Fast.

ELIGIBILITY: Open to all invited USA swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet. No swimmer

will be permitted to compete unless the swimmer is a member as provided in Article 302.

No Deck Registrations will be accepted

Age on JANUARY 10, 2026 will determine age for the entire meet.

ENTRIES: All Athletes are limited to 3 events per session.

WARM-UP: General warm up with assigned lanes for the first 55 minutes. Starts are during your warmup.

Please see the administrative table for lane assignments which will be distributed along with the

scratch sheet for each session.

SCRATCHES: Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later

than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual

event scratches and which swimmers will not be participating in the session.

COACHES: In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

AWARDS: All Age groups (8 & Under, 9-10, 11-12, 13-14, 15-18) will receive awards. Medals 1st to 3rd –

Ribbons 4th to 8th place.

The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee.

SAFETY: Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet.

Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the

safety rules.

Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal quardian, to ensure compliance with this requirement.

All swimmers must wear footwear upon leaving the pool area.
