## BOARD OF DIRECTORS EXECUTIVE MEETING

Thursday, August 11, 2021 ZOOM Meeting

**1.** WELCOME/ROLL CALL: Eric Fisher welcomed everyone present at this virtual Board meeting which was called to order at 4:03pm. Eric welcomed Kurt Thiel to this meeting.

#### 2. ACCEPTANCE/CORRECTIONS OF MINUTES:

A motion to accept the minutes of the July 28, 2021, BOD meeting was made, seconded, and approved by all. **Motion carries**.

#### 3. GENERAL CHAIR: Eric Fisher

a. <u>Metro Stipends</u>: Senior Co-Chair, Zac Hojnacki, made a motion to suspend the rules in *Metropolitan Swimming Policy and Procedures and Rules and Regulations Manual*, Article 203.4.3, permitting a one-time exception to reimburse athletes who competed in the 2021 Speedo Summer Championship Meet to be eligible for amounts up to \$800 for 18-under athletes meeting one or more of the published individual 18 & U standards, or \$1000 for athletes of any age meeting one or more of the individual 19-over standards, subject to the eligibility requirements outlined in Metropolitan Swimming Policy and Procedures and Rules and Regulations Manual Article 203.

The motion was seconded. Discussion on the motion followed.

A motion to propose an amendment to the above motion was made and seconded. The amended motion would allocate \$900 to the athletes regardless of the time standards. The motion was seconded. Vote on this amendment was made in a Chat to Mary. Majority of the votes were in favor of this amendment – **motion carries**.

A motion was made to suspend the rules in *Metropolitan Swimming Policy and Procedures and Rules and Regulations Manual* Article 203.4.3 permitting a one-time exception to reimburse athletes who competed in the 2021 Speedo Summer Championships meet to be eligible for amounts up to \$900, subject to the eligibility requirements outlined in *Metropolitan Swimming Policy and Procedures and Rules and Regulations Manual* Article 203.

This new motion was seconded. Votes on the final motion was made in a Chat to Mary. Majority voted yes. **Motion carries.**
