1. WELCOME/ROLL CALL: Eric Fisher welcomed everyone present at this virtual Board meeting which was called to order at 7:03pm.

2. ACCEPTANCE/CORRECTIONS OF MINUTES:

A motion to approve the Minutes of January 11, 2022. Motion was made seconded and approved by all. **Motion carries**.

3. GENERAL CHAIR: Eric Fisher

- 1: Kate Hallex mentioned that swimmers 10-under at JO's will now swim in a separate session from the 11-12 and 13-14. This change was approved to create a safe environment for the athletes. This session will take place in the East Pool, after the completion of the 11-14 sessions.

 Kate also presented a proposal from LIAC to host an 8-year-old only sanctioned Championship during the 10&Under sessions on Saturday and Sunday of JO's. If an 8-year-old has a JO cut, the coach may decide to enter the swimmer in JO's or in the 8-year-old session. This is offered to 8-year-olds ONLY. Discussion followed on entry fees for the 8-year-olds as well as opportunity for teams to now host a meet or time trial on the weekend that was originally scheduled for the Metro 8 and Under Championship of March 4-5, 2022. We must follow the information on fees from the P&P Manual. Kate made a motion to allow LIAC to host an 8-year-old Championships meet parallel to the 10-under sessions of Saturday and Sunday at JO's; the fee structure will follow what is listed for Metro Championships in the Policy & Procedures Manual. The motion was seconded and approved by all.

 Motion Carries.
- 2: A motion was made to open the weekend of March 4-5, 2022, to teams that would like to host meets and/or time trials without age-restrictions. Teams that were already hosting 9-over meets that weekend would now be able to open it to 8-under swimmers. This motion was made as there were no bids to host an 8-Under Championship on those dates. Motion was seconded and approved by all.
