#### **Eligibility:**

Invited Teams: The following teams are invited until the session has met the maximum either via timeline or capacity, including constraints established by Bard College with respect to covid or other considerations -- MR-RFAC, MR-MWDA, MR-HVD, AD-DELM (Delmar Dolfins), NE-SNAP (Snapper Swim Club)

Any other Teams: Please contact the meet director for an invite based on availability. All swimmers participating in this meet must be registered by the first day of the meet. No "Deck Registrations" will be accepted. Age on October 9, 2022 will determine age for the entire meet.

#### **Disabled Athletes:**

Metropolitan Swimming and the host club (NDAC) welcome athletes with disabilities. Contact the Meet Director at least 2 weeks in advance of the meet so that provisions can be made for any special accommodations. The athlete (or athlete's coach) must notify the Meet Referee prior to the meet.

#### **Entry Rules:**

Rules from the current USA Swimming Technical and Administrative Rules will be in effect.

Entries must be submitted electronically, using Hy-Tek, Team Unify or compatible Software and Emailed to the **Meet Entry Coordinator**. Team entries must be received by the Meet Entry Coordinator by Sunday, October 9, 2022.

#### **Host Facility Covid Restrictions:**

Bard College requires that all participants and spectators present either proof of covid vaccination (boosters not required) or a negative covid test (home test within 24 hours acceptable) when entering the Stevenson Gymnasium

#### **DEADLINE:**

- 1: Metro LSC teams will be given priority on a first come/first served basis. Metro team's entries must be received by **October 02, 2022**
- 2: The final entry deadline for this meet is October 4, 2022
- 3: Metro entries received between **September 5**, **2022**, **and October 02**, **2022** will be entered first. An email confirming receipt of entries will be sent if you provide an email contact. Please contact Meet Director if you do not receive such a report within 2 days.

#### **ENTRY FEE:**

An entry fee of \$4.25 per individual event must accompany the entries. \$3.00 per swimmer for Facility surcharge.

Payment must be received by October 9, 2022 for email entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.

#### **WARM-UP:**

General warm up with assigned lanes for the first 50 minutes. Sprint lanes and

General lanes will be available for the remaining 10 minutes. Lane assignments will

be distributed along with the heat sheet.

#### **COACHES:**

In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.

#### **RULES:**

Current USA Swimming Rules, including the Minor Athlete Abuse Prevention Policy ("MAAPP") will govern this meet. The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure ("fly-overs") will be used.

#### **MAAPP Policy:**

All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is condition of participation in the conduct of this competitions.

#### **SAFETY:**

All swimmers must wear footwear upon leaving the pool area. Metropolitan safety and Warm-up will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
