- LOCATION:** Boys & Girls Clubs of Northern Westchester – Trotta Millennium Pool
351 Main Street – Mount Kisco, NY 10549 – (914) 666-8069
- FACILITY:** 25-yard indoor pool with eight 7-foot lanes. Non-turbulent lane-lines. Seating for 200 spectators.
Colorado electronic timing system, with an eight-line scoreboard.
The pool has been certified in accordance with Article 104.2.2C (4)
- SESSIONS:** Session 1: 8-year-old girls and 7-Under boys – warm-up 7:00am – start 7:45am
Session 2: 8-year-old boys and 7-Under girls – warm-up 9:45am – start 10:20am
- FORMAT:** All events will be held as timed finals.
- ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302.
No Deck Registrations will be accepted.
Age on **November 9, 2025**, will determine age for the entire meet.
- DISABILITY SWIMMERS:** *Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact the Meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.*
- ENTRIES:** **Swimmers are limited to 4 events per session.**
Deck entries will not be accepted. Invited Teams entries only. Entries will be accepted on a first come first serve basis but are limited to 125 athletes per session.
The meet will be run on computer using Hy-Tek's Meet Manager. **All sessions MAY be limited to 1 ½ hours before scratches.**
Teams must submit entries using an export file of Hy-Tek Team Manager.
Payment must be received by Sunday, November 9, 2025.
Paper entries, phoned, or faxed entries will NOT be accepted.
An email confirming receipt of entries and a meet manager meet entries report will be sent to the coach. Please email Monique if you do not receive such a report within 2 days of your original email. Email all entries to Monique Grayson at mggrayson@gmail.com
- ENTRY FEE:** An entry fee of **\$8.00** per individual event, \$15.00 per relay, and **\$15.00** surcharge per swimmer,
SURCHARGE: must accompany the entries.
Host Club may waive meet entry fees & facility surcharge for registered outreach swimmers. Coaches should contact the Meet director and identify registered swimmers whom they wish considered for waiver of fees when submitting meet entries.

Failure to pay entry fees by this deadline could result in teams being barred from the meet.

- DEADLINE:** 1: Entries will be accepted on a first come/first served basis until the cap of 125 swimmers per session is reached.
2: The final entry deadline for this meet is **October 31, 2025**
3: An email will be sent confirming receipt of entries. Please contact the meet Director if you do not receive such a report within 2 days of your original email.
- WARM-UP:** Lane assignment will be given at the meet. One-way sprints at discretion of meet referee.
- SCRATCHES:** Coaches will be given scratch sheets upon check-in for each Timed Finals session. All scratches are due no later than 30 minutes prior to the start of each session. Coaches are asked to indicate **clearly** individual events scratches, and which swimmers will not be participating in the session.
- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** Ribbons (first to 8th places) will be given to 8-year-olds and 7-under top 8 swimmers.

- RULES:** The current USA Swimming Rules and Regulations will apply.
The USA Swimming Code of Conduct is in effect for the duration of the meet.
The overhead start procedure may be used at the discretion of the meet Referee.
- SAFETY:** Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
- Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement.
- Medical supervision will be provided by the Boys & Girls Club of Northern Westchester lifeguarding staff.
- WATER DEPTH:** USA 2011 - 202.3.7 "The meet announcement shall include information about water depth measure for a distance of 3 feet 3½ inches (1.0 meter) to 16 feet 5 inches (5.0 meters) from both end walls."
Deep end: at 1m: 9'0"; at 5m: 7'6" – **Shallow end:** at 1m: 4'0"; at 5m: 4'6"

AUDIO/VISUAL STATEMENT:	Use of Audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms, and locker rooms. The use of cell phones and cameras is prohibited from behind the starting blocks. "Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present."
DISCLAIMER:	Upon acceptance of his/her entries, the participant waives all claims against the Boys & Girls Clubs of Northern Westchester, The Marlins Swim Team, Metropolitan Swimming Inc., USA Swimming Inc., their agents, or representatives for any injury occurring because of the meet. "It is understood that USA Swimming, Inc. and Metropolitan Swimming, Inc. shall be free from liabilities or claims for damages arising by reason of injuries to anyone during the conduct of the event."
DECK CHANGING:	Deck Changes are prohibited.
MAAPP:	All adults participating in or associated with this meet acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Abuse Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.
ADMISSION:	Spectators will be permitted with \$10 admission fee per person (CASH Only). Results will be made available on Meet Mobile.
SEATING:	Bleacher seating available for athletes and spectators. Athletes may also be seated in overflow rooms at hosts discretion.
PARKING:	Parking is available at the Boys & Girls Club and may be available across the street at NW Hospital
DIRECTIONS:	<u>From I-684 North or South:</u> Take exit 4 to route 172 west (towards Mt. Kisco). Drive approximately 2 miles. Take 117 North (keep right at traffic light). Go one block. Just before the traffic light, turn right into B/G Club driveway. Enter the pool from the main entrance. <u>From Long Island:</u> Take Whitestone Bridge, to the Hutchinson Parkway North, to I-684 north, to exit 4 (then proceed as above). <u>From Saw Mill Parkway North:</u> Take exit 33, Readers Digest Road. Cross railroad tracks and keep right. At the traffic light, make a left turn on route 117 (it will become Main Street). Pass 2 traffic lights. Just before the third traffic light, turn right into B/G Club driveway. <u>From Taconic Parkway South:</u> Take exit for route 133, Mount Kisco. At the traffic light, make a right turn. At the next traffic light, turn right and follow signs for Mt. Kisco (on route 133 east). Drive approximately 4 miles. At the end of 133, turn right onto route 117 South (Main Street). Pass 2 traffic lights. Just after the third traffic light, make an immediate left turn into the B/G Club driveway. PS: Additional parking may be available across the street in hospital parking lot.
HOTELS:	The Mount Kisco Hotel (1 Holiday Inn Drive – Mount Kisco, NY 10549) will give a preferred rate if coaches mention that they are attending a meet at the Boys & Girls Club. 914-241-2600
