Colorado electronic timing system and FACILITY: an 8-line scoreboard. Seating for 600 spectators. The pool has not been certified in accordance with Article 104.2.2C (4). SESSIONS: Session 1 Saturday Session 1 8:00 AM Warm up / 9: 30 Start Session 2 Sunday Session 2 8:00 AM Warm up / 9: 30 Start FORMAT: All Events are Timed Finals. On deck seeding is in effect for the meet. Host club reserves the right to seed from off deck depending on number of entries accepted. Team representatives will be notified of any change. **ELIGIBILITY:** Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. No swimmer will be permitted to compete unless the swimmer is a member as provided in Article 302. No Deck Registrations will be accepted. Age on May 18, 2024, will determine age for the entire meet. Swimmers with disabilities are encouraged to enter and participate. Please notify the meet director DISABILITY SWIMMERS: of any accommodations you might require. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition. ENTRIES: Swimmers may enter up to 5 events per session on Saturday / Sunday. NT's will NOT be accepted. The host club reserves the right to keep their swimmers in the meet. There will be a Time Trial for the 400 IM on Saturday and the 400 Freestyle on Sunday. These Time Trials are open to 11 and over swimmers. Each time trial will be limited to 4 heats. Cost is \$15 per time trial event, first come first serve.

DEADLINE:	Entries must be received by: May 10, 2024 Entries will be entered in the order they were received as space allows. An email confirming receipt of entries if you provide an email contact. ENTRY FEE:	A per swimmer facility surcharge of \$15.00 and an entry fee of \$10.00 per individual event.

Payment must be included with all mail entries. WARM-UP:	Warm-up lanes and times will be assigned by the host team. Warm-up schedules will be posted at the scoring desk. Coaches are responsible for enforcing feet first entry during warm-ups and supervision of swimmers. No diving is permitted except in designated sprint lanes.
SCRATCHES:	Coaches will be given scratch sheets upon check-in for all sessions. Coaches must present current coaches' credentials in order to receive team scratch sheets. All scratches are due no later than 30 minutes prior to the start of the session. Coaches are asked to indicate clearly individual event scratches and which swimmers will not be participating in the session.
COACHES:	In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
AWARDS:	Ribbons will be awarded for places 1 <sup>st</sup> – 8 <sup>th</sup> for 12 & under only. Coaches must pick up their team awards at the end of the meet. Awards will not be mailed.

RULES:	The current USA Swimming Rules and Regulations will apply. The USA Swimming Code of Conduct is in effect for the duration of the meet. The overhead start procedure may be used at the discretion of the meet Referee.
SAFETY:	Metropolitan Swimming Safety Guidelines and Warm-up Procedures will be in effect at this meet. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules. Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal guardian, to ensure compliance with this requirement.
