Format: This meet is a timed final event. the meet will be deck seeded.

Open to all Invited USA Swimming/Metropolitan Swimming Inc. registered swimmers. **ELIGIBILITY:** 

All swimmers participating in this meet must be registered by the first day of the meet.

Age on February 7, 2020 will determine age for the entire meet.

scratches and which swimmers will not be participating in the session.

DECK: Deck Changes are prohibited.

**SAFETY:** Metropolitan Safety and Warm-up procedures will be in effect. Marshals will be present throughout

warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any

swimmer, coach, club, or spectator for failure to follow the safety rules.

"Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. When unaccompanied by a member-coach, it is the responsibility of the swimmer, or the swimmer's legal

guardian, to ensure compliance with this requirement"
