

swimmer's responsibility to make such arrangements prior to the start of the meet. Any swimmer entered in the meet must be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water. When an unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.

ENTRIES: All entries must be submitted electronically. This meet will be limited to 800 Swimmers. Entries will open December 16, 2024, and will be accepted on a first-come, first-serve basis until the 800-swimmer cap is reached. Team entries may be sent in a Hy-Tek CL2 entry file to the following email address:

Full payment (single team check) for an e-mail entry must be postmarked within 96 hours of the e-mail entry. No deck entries.

Teams are encouraged to finalize and pay for their entries early in the entry process. As you will see below, Teams will be allowed late qualifiers if they have completed an initial entry. **Teams not entered (including payment) when the 800-swimmer cap is reached, will not be allowed to enter late qualifiers.**

Late Qualifiers:

If the meet fills at 800 athletes, Teams that have already been accepted and checked out can submit late qualifiers. Late qualifiers will have an additional \$20 surcharge to enter the swim meet.

Time Standards:

Time standards are attached.

Bonus Entries:

Bonus standards are also attached. Swimmers with at least one "Hard Cut Standard" qualifying time standard may enter up to (4) additional bonus events in which they have qualified with the bonus standard. All athletes are only allowed a maximum of 7 events, this includes bonus swims.

- Any events over 200Y will not be allowed as bonus events.
- Swimmers can enter a maximum of four (4) bonus events in which they meet the qualifying bonus standard
- Reminder that swimmers get 7 total individual events (this includes bonus swims)
- Events 400y and longer MAY NOT be entered as a bonus event
- Bonus entries must be "selected" as bonus on hy-tek entry file. They can be yards bonus (YB) or long course meters bonus (LB).

RELAYS:

Relays must be entered electronically and must be submitted by the entry deadline. Relay entries will not be accepted at the meet. **If Teams are entered (and payment received) and the meet hits the 800-swimmer cap, they will be allowed to enter relays until the entry deadline.**

Teams may enter a maximum of two (2) relays per event. Relays will follow the same scratch deadlines as the individual entries. **All relays will be swum in the morning preliminary sessions.** All relays will be scored and awarded by the following age categories: 10&Un, 12&Un, 14&Un. **Swimmers may not compete in more than one age group** per specific discipline and category: 200 medley, 400 medley, 200 freestyle, 400 freestyle.

Entry Limit:

Athletes may compete in up to three (3) individual events per day plus relays and may compete in no more than seven (7) individual events in total for the meet.

Entry Fee:

\$7.00 per individual event. \$12.00 per relay for all age groups. \$25.00 surcharge for all athletes. No late entries will be accepted. No refunds. Entry fees paid by check should be mailed to:

Important Dates:

- Tuesday, December 16th – Meet Opens – Hy-tec File will be sent out and posted on the DART meet landing page.
- Tuesday, December 16th – Entry period begins
- Monday, March 10th – Entry deadline. All entries must be collected by this deadline. If 800-swimmer cap is reached first, the meet entry period will be closed.

Awards:

Custom medals for 1st through 10th in Individual Events ~ 1st through 3rd in Relay Events. Team awards for 1st through 5th places.

Individual events: 11-9-8-7-6-5-4-3-2-1

Relay events: 22-18-16-14-12-10-8-6-4-2

Timed final 11-14 events will be swum as combined and scored and awarded in single age groups.
