#### CHAMPIONSHIP COMMITTEE REPORT

Don Brown, 2004 Meet Director, reported: all 17 LSCs were represented with from 1 to 82 swimmers; Southern California placed first; Hawaii won the Adam Szmidt Sportsmanship Award; 67 entrants in the open water swim; 10 National Age Group records; 7 new Western Zone records. Other statistics:

Salt Lake City: Debby Fleisch will be Meet Director. Packets were given out at WZ dinner meeting at the meet; their pool director attended the meet to observe; everything will be on their website as it becomes available; Carolynn Burt has map and accommodations sheets.

#### REPORTS OF NATIONAL COMMITTEE MEMBERS

<u>Senior Swimming, Larry Liebowitz</u>. The Junior Championship meet will be held in Irvine beginning August 9 immediately following the Duel in the Pool. They have three items of legislation: 1) new event order for the National Championship; 2) sizing of National Championship to keep between 900 to 1000 swimmers, with relays about 1200; 3) allow all clubs to bring a licensed massage therapist who is a member of USA Swimming for a \$50 charge.

<u>All America, Joyce Lanphere</u>. This year's Scholastic All America Team was the largest with 483 women and 291 men. 357 women and 215 men had 4.0s and 54 women and 33 men were third time repeaters. Eligibility is based on a minimum 3.5 gpa for the year and participation as an individual swimmer in certain qualifying meets.

<u>National Age Group Time Standards, Jim Patterson</u>. This is the beginning of a new quadrennium and times are posted on the USA Swimming website. About half of them are new times and they are asterisked.

<u>Safety Education, John Riess</u> Challenge courses will be offered during convention.

Education, Club Fundraising, Outreach, Survey, Waterworks, Kim Holmes, Staff Liaison. Education – four workshops during convention: How They Did It, Novice to National; The Early Show; Club Resources and Drug Control; Athletes on Tools That Helped Them to be Successful. Club Fundraising – workshop during convention on New Facilities; Swim-a-thon awards are being made to over 300 individuals at various levels rather than to just the few who attended their camp in previous years. Outreach – highlighted their Cinco de Mayo and Black History meets, information can be found on the web. Survey – will only be at sessions which requested them; exit survey can be used for feedback. Waterworks – the Marketing Committee want to develop a "Club Marketing Kit" and they need input on what clubs are looking for.

<u>Communications, John Lorimer.</u> Two seminars during convention: 1)Tips and Tricks for LSC Webmasters, Hytek will make a presentation; 2) Advanced Webmaster Techniques which will include scripting and databases. A questionnaire is going out to athletes at the club level to evaluate communication and give what direction they think

staff should be going with their website and Splash Magazine. Staff has announced that they are intending that the new website will replace most of the functionality of LSC and club websites.

<u>Club Development, Rick Shipherd</u>. Are introducing their new program on Club Recognition which will dovetail into the Club Excellence program. It's a complex program with lots of potential

#### **UNFINISHED BUSINESS**

<u>Finance Task Force.</u> Chair Hale Adams, committee members Lou Schlitz; Lyle Campbell, Dave Salo, Duncan Scott; Ryan Stratton; Nate Rothman. Hale presented the committee's report. (Attachment 2) He reviewed their findings and raised several points: hosts need to make a profit on the championship meet; Western Zones present income from the meet does not cover our authorized expenses and an increase in splash fees is proposed; the athlete representative's travel to the meet is not included, but would be paid in the event they attended; half of the travel to the sectional meets will be paid by the sectionals. A 2005 Budget proposal was included.

Hale also mentioned that 11 of the 12 National Age Group records from the meet were relays and will only count if the swimmers are all from the same club. Adam Hinshaw from Pacific substantially broke the 200 free national record.

Meet Conduct/Format Task Force. Chair Terri Hermes reported the task was to figure out how to include distance events for the 11 and 12 year olds in the Western Zone Meet. She presented the following points: 1) Run the distance events as open events (11 and U) in prelims, separate in finals and score as age groups. The major concern is how much time it will add to the meet. 2) Why should we add? Findings from the Age Group Committee and other committees indicate that those 10/U and 11/12 year olds who are swimming just sprint events typically did not stay at the zone level as they got older.

Adapted Inclusion Task Force. Chair Char Tester reported that two adapted swimmers were included in the meet this year. Appendix B was followed and it worked satisfactorily. Swimmers were entered by their times or age groups. They will continue to monitor and find ways to make it easier for them to compete. They would also like input from the swimmers as well as anyone else.

- 2) Shall be based on the number of swimmers entered by each LSC.
- 3) 7:00-7:45 AM shall be for 13/14, 15/16 and 17/18 age groups.
- 4) 7:45-8:20 AM shall be for 10 & Under and 11/12 age groups.
- 3)) Exclusive warm-up for Tuesday's swimmers shall begin at 12:00 PM.

The Meet Conduct/Format Task Force was asked about the combining of the 15/16 and 17/18 age groups. Terri noted that in all their discussion no one thought that it was necessary to make any change. It was also requested that moving relays to Tuesday be considered. #### REPORT TO THE

## WESTERN ZONE USA SWIMMING CONVENTION SEPTEMBER 14 - 18, 2004

As a result of research and gathering of data over the course of the last year the following is a report from the Finance Task Force of the Western Zone.

The committee was charged with:

- 1. Developing a budget for the year of 2005.
- 2. Address the future planning for the Zone.
- 3. Review the finances for the past three championships.
- 4. Look at what we do with our accumulated surplus.

#### Attached is:

1. The proposed budget and format for 2005.

#### The recommendations are:

- 1. The Zone should begin to prepare an annual budget on the proposed format.
- 2. The budget should be as accurate as it can be for the upcoming year.
- 3. The Zone should continue to pay the expenses authorized in the bylaws.
- 4. If all the authorized expenses are paid they will be in excess of available income. The existing surplus can be used for this purpose. For example, a \$2,000 loss each year for the next ten years would only use  $\frac{1}{2}$  of the surplus.
- 5. The committee received no comments on what we might do with the existing surplus.
- 6. **Note**, the proposed budget contains a recommendation for the Section Meets to pay ½ the travel expenses for the Directors to attend Section Meets.
