Business

- 1. President Tony Popp called the meeting to order at 8:05 PM
- 2. Tami will check what past minutes have been approved, and which are awaiting approval.
- 3. Athlete Reps reports/updates:
 - a. Andrea Introduced newly elected athlete reps: Brendan Campbell and Darya Peters. Congratulations! Competitive season has calmed down Senior sectionals went well. Younger athletes on MAC are focused on NWAG sections this coming weekend.
 - b. Alyssa BAC has an Olympian coming for a Fitter & Faster clinic.
 - c. Darya Excited to be elected; has been swimming for 11 years and wants to get more involved with USA Swimming as a whole.
- 4. Mixed Meet (April 18-19, 2015):
 - a. Shelly Sent an email out to teams and coaches about the Mixer Meet very little response so far. Currently no commitments from coaches or teams outside of Bozeman. Shelly encouraged athlete reps to help promote the meet to their teams, boards, and other swimmers. Schedule and arrangements are well under way and

- looking good. Flyers were handed out at State meet; these will be circulated again to teams and coaches.
- b. Tony will work to promote the event in the NW corridor. He will be in Pheonix, AZ for the General Chair's annual meeting the same weekend as the Mixer so will not be able to personally attend.
- c. Lisa April 18-19, 2015 is the same weekend as the Grizzly Triathlon in Missoula. This could be effecting some of the MAC swimmers' ability to attend as many of the older swimmers get involved with the triathlon. Lisa will visit with coaches to at least encourage the younger swimmers to attend the Mixer.
- d. Shelly will coordinate with Curt on exact method of registration of swimmers. Registration needs to happen fairly soon to allow time for purchasing and arrangement of supplies for athletes numbers.
- e. Rosanne will promote the meet within the Billings teams.

5. Zones update:
