Montana Swimming Spring House of Delegates Meeting Minutes May 25, 2024 Virtual Meeting

The 2024 spring meeting of the Montana Swimming House of Delegates was a virtual meeting and was called to order at 11:30 a.m. on Saturday, May 25, by General Chair Jay Friend.

The meeting notice, which was duly and properly given, was posted on the LSC website, and emailed to clubs and board members. The meeting agenda is found in the appendix. Roll call was taken and those in attendance signified they were present. The attendance sheet is in the appendix. A quorum was present, and the meeting proceeded.

<u>Welcome, General Announcements, and Introductions:</u> General Chair Jay Friend welcomed everyone to the meeting.

Old Business

<u>At Large Voting Delegates:</u> The at large adult voting delegates were appointed at the fall HOD meeting.

- The at large adult board voting delegates include Records Chair Sean Marshall, Officials Chair Eric Belasco, and Operational Risk Chair Alana Cunningham.
- The elected athlete representatives present and voting at the meeting include Ellyn Lewis, and Teague McElwee.
- Kristen Wyatt will vote as the coach representative.
- The voting board members will include General Chair Jay Friend, Admin Vice Chair Michelle Schermerhorn, Program Development Vice Chair Jessica Marshall, Program Operations Chair Laura Parvey-Connors, Finance Vice Chair Beth Storey, Secretary Susan Huckeby, and Coach Representative Kristen Wyatt.
- The at large athlete voting delegates include Emery Belasco, BOZ; Trigve Chvilicek, BMA; Isabella Pachek, GFST; Noah Schroeder, KATS; Asher Renshaw, HOT; Lila Miller, HDST; Issac Urban, HLST; Meredith Hall, MAC; and Gavin Moore, LAKE.

Agenda: The final agenda was posted on the website. There were no additions or changes.

<u>Meeting Minutes</u>: It was moved and seconded that the meeting minutes from the October 2023 House of Delegates meeting be approved as presented. The motion passed.

<u>Athlete Report:</u> Analise Belasco and Jesse McCormick introduced the new junior athlete representatives Aeri La, MYST and Ella Stack, MAC. Jesse reported the athlete committee will be meeting again soon. They hope to have more input from smaller teams going forward.

Reports of Officers: Written reports by the officers are posted on the website and are included in the appendix. Oral reports are summarized below.

 Treasurer's Report: Treasurer Matt Yovich' reports are poste don the website. Matt went over the reports and explained that the 2023 LC State host fee does not appear in the 2023 financials, but in the 2024 financials. The 2023 990 tax forms were filed. He has already started on the 2024 990 tax return. We have a third-party auditor who audits the accounts. Matt said we need a better way to put the meet fees in the software. Checks are sent to Beth to deposit. Matt writes checks to pay the bills. Matt and Beth will work on this. Several teams are behind on paying their meet fees.

- Admin Vice Chair's Report: Michelle Schermerhorn reported all things were going along well.
- Program Operations (Zones) Chair: Laura Parvey-Connors report is posted on the website.
 The zones committee is considering adjusting the qualifying times for age group zones for
 Montana. We have 160 splashes available. If we lowered the time standards, other swimmers
 could go to zones and swim races using those available splashes.
- Coach Update: Current co-coach representatives Jessica Marshall and Caty Flikkema will be term limited out this fall. Coaches interested in serving as coach representative should contact them. For the coach of the year voting, coaches must be nominated to appear on the ballot. Each team receives one vote. Caty and Jessica will send out the nomination forms at the end of June or early July. Voting will be online.

There was no other old business.

New Business

Set Montana Swimming Registration Fees for 2023-2024:

Susan submitted a list of the 2025 fees with proposed increases to the premium athlete registration of \$2, seasonal athlete membership of \$2.50 and the club registration fee of \$25. The club admin registration fee would be reduced by \$14 resulting in no fee being charged by Montana Swimming. Outreach and flex fees are set and cannot be increased. The outreach fee could be reduced by \$2 which is the LSC portion of the fee. The fees can only be adjusted once per year and should be reviewed each May.

M/S/P: It was moved and seconded to increase the premium athlete fee \$2, the seasonal athlete fee \$2.50 and the club registration fee \$25. The club admin fee was reduced by \$14. Outreach and flex fees will not be increased. The motion passed.

Awards:

Nominations were accepted for the outstanding volunteer of the year, male and female athlete of the year, and the male and female sportsperson of the year. The male and female athlete of the year awards are based on power points. The sportsperson of the year must be a junior or senior in high school. Due to the nature of the virtual meeting, an electronic poll was set up for the delegates to vote for the awards; however, nominees were approved by acclimation and no electronic vote was taken.

Nominees: Michael Schermerhorn, Missoula YMCA Swim Team and Winston Sundeen, Bozeman Barracudas.

Montana Swimming Female Sportsperson of the Year: **Analise Belasco**, Bozeman Barracudas. Nominees: Analise Belasco, Bozeman Barracudas.

2024-2025 Short Course Meet Schedule and Short Couse Championship Meet Bids:

The 2024-2025 short course season meet bids were submitted to Technical Planning Chair Beth Storey and the draft schedule was posted on the website.

There was one bid received from the Butte YMCA to host the 2025 Montana Swimming Short Course State Championships in the amount of \$15,000. The bid included \$4500 for pool rent, \$1000 for gymrent, and \$750 for hospitality and \$250 for listed miscellaneous costs.

There was one bid received from the Butte YMCA to host the 2025 Montana Swimming Junior BC Championships in the amount of \$6500. The bid included \$4500 for pool rent, \$1000 for gym rent, and \$750 for hospitality and \$250 for listed miscellaneous costs.

After much discussion, it was decided the Montana Swimming board will determine the dates for the 2025 Short Course State Championships and the 2025 Junior BC Championships. Dates will be between February 20 and March 9.

M/S/P: It was moved and seconded that the 2025 Montana Swimming Short Course Championships will be held in Butte with the date to be determined. The bid was \$15,000. The motion passed.

M/S/P: It was moved and seconded that the 2025 Montana Swimming Junior BC Championships will be held in Butte with the date to be determined. The bid was \$6500. The motion passed.

M/S/P: It was moved and seconded that the executive board will determine the dates for the 2025 Montana Swimming Short Course State Championships and the 2025 Montana Swimming Junior BC Championships. Dates to be considered will be between February 20 and March 9. The motion passed.

M/S/P: It was moved and seconded that the meet schedule was approved as currently proposed with an exception to determine the dates for Short Course State and Junior BC Championships. The motion passed.

The short course meet schedule is in the appendix and posted on the website. If clubs need to make any changes to the schedule, contact sanctions chair Eric Belasco and webmaster Susan Huckeby. Once any date changes or additions have been approved, please inform Beth Storey.

<u>Fall elections Nominations for Program Development Vice Chair (Zones Coordinator) and Safe Sport Chair:</u> Jay Friend and Nicole Olson, governance committee chair, will accept nominations for the Program Development Vice Chair position previously held by Stephanie Boysen and the Safe Sport Chair position previously held by Brenda Huckert through May 20. Persons appointed to these

positions will fill out the remainder of the term. The program development position is open for election this fall.

Resolutions and Orders

There were no physical ballots to destroy as this was a virtual meeting. There were no electronic ballots to delete.

2024 Spring HOD Meeting

The Western Zone DEI Committee is hosting the 2024 WZ DEI Camp at Indianapolis during Trails June 17-20. Montana Swimming is excited to send three people to this great event – **athletes Elina Maganito (BOZ) and Omar Shahin (BAC) and coach Amy Mullen (BMA)**.

The group will stay, dine, and attend workshops at Butler University. Athletes will practice at the beautiful Riviera Club. On June 19, the group will attend the finals of the US Olympic Trials at Lucas Oil Stadium. It will be an amazing experience!! Congratulations Elina, Omar, and Amy!!

Montana Swimming paid the camp registration fee of \$425 per person and the transportation costs to and from the camp for the attendees. This is the first camp held since 2018. Plans are to hold the camp every two to three years in the future.

I am the Western Zone DEI Coordinator. As part of my duties, I chair the WZ DEI committee, post information on the WZ website, participate in the National DEI committee calls and the DEI Alignment group calls, and disseminate information to the WZ DEI chairs.

The Montana Swimming Reach Out grant program awards funding to Montana Swimming teams to provide opportunities for low income/outreach, minority, LGBTQ, and disabled athletes to participate in swimming through such activities as learn to swim camps, scholarships, providing training equipment or swimsuits and more. In October the **Hardin Otters Swim Team** was awarded \$1050 to purchase new swim caps for their team and t-shirts for their Otter Pups beginner swimmers. The remaining funds were directed to the WZ DEI camp and summit fund. This spring the Hardin Otters were awarded \$1000 to provide advanced training in coaching stroke technique to improve the quality of swimming instruction in their program. The remaining grant funds were again directed to the WZ DEI camp and summit fund. Congratulations to the Hardin Otters!

I would like to thank Montana Swimming Athlete Representative Analise Belasco (BOZ) and Finance Vice Chair Beth Storey (HDST) for serving on the grant committee. Thank you everyone for the continued support of the program. The fall 2024 grant applications and 2025 spring grant applications will be posted on the website soon.

Information about the Montana Swimming athlete outreach membership policy can be found on the website. In 2021 we voted to add swimmers with a disability to qualify for outreach membership. Part of the qualifying process requires teams to submit a letter to their club registrar verifying the athlete is disabled and the athlete must register as a disability athlete in the appropriate category (P1, P2, P3). Low-income families may submit a letter to their club registrar showing the family is qualified for SNAP, WIC, TANF, Medicaid or other programs including the federal free or reduced hot lunch program to qualify for outreach memberships. A year-round outreach membership is \$7.00 per athlete. If a family member has lost his/her/their job or had hours reduced, please check out the outreach membership as your children may qualify.

I would also like to encourage conversations between coaches, athletes with disabilities, and officials at swim meets to determine needed accommodations for a swimmer. Posted on the website is a form that can be completed by the athlete, athlete's parent or coach requesting accommodations and modifications at a swim meet. Accommodation and modifications may be granted at one swim meet

but may not necessarily be granted at another meet for various reasons including different layouts of the pool and locker rooms. Always reach out to the meet referee in advance if you need accommodation.

I would like to encourage all our athlete members and non-athlete members to check the box for ethnicity when registering with USA Swimming this fall using the SWIMS online member registration (OMR) process. The information is used by USA Swimming and helps them understand if programming and resources are of value to everyone in the organization. The information does not identify individual people.

The USA Swimming Policy 19 for transgender athletes is posted on the website. The policy explains how a transgender athlete may compete in USA Swimming. It is also posted on the USA Swimming website.

The Montana Swimming website features a tab for diversity and inclusion as well as disability swimming. Numerous resources can be found there.

2024 Spring Registration Chair Report

Montana Swimming currently has 1,126 athletes registered and 195 non-athletes. We had a high of 1300 athletes registered in 2013 and 229 non-athletes in 2022. We currently have 87 registered coach members and 87 registered officials.

Registration is proceeding much more smoothly this year than last as people become more familiar with SWIMS and online member registration (OMR). If you have a question about a registration issue, please email Jay Friend and me first before you submit a help ticker as we may be able to answer your questions faster.

Montana Swimming needs to set the 2025 registration fees at the spring HOD meeting. These fees must be set before the 2025 registration opens on September 1.

We are proposing that the premium athlete member fee be increased \$2 (\$106 total); the seasonal athlete fee be increased \$2.50 (\$69 total); the club annual registration fee be increased \$25 (\$150 total) and the administrator fee be decreased by \$14 to have no Montana Swimming (\$30 total). The club registration fee has not been increased in several years. USA Swimming suggested LSCs have a no fee for administrators. The administrator membership is for club board members and other club administrators – not admin officials. Montana Swimming did not increase any other registration fees. (See the registration fee report)

The club dashboard in the hub has had several new updates this spring. You can view these reports by going to club, my club, team management, reports.

The club member report will allow clubs to check if coaches, officials, athletes, and others have current memberships. The club roster can be sorted in several ways to show who is registered to your club by membership type. The club profile dashboard has graphs and charts detailing club membership over time, breakdowns by race and ethnicity, and more. The club flex athlete meet count will help coaches track when flex athletes have competed in two meets and need to upgrade their membership to premium. The club times report can be sorted to show top times by athletes in your club. IMX and IMR performances can be tracked in the IMX/IMR detail report and certificates can be printed in the club IMX certificate report. The club times progression dashboard will show how the times have progressed by athlete in your club over time. There are many other reports. Take some time and go through the reports and you may be pleasantly surprised at what information is available. Much of the same information can be found for the LSC as well that Jay and I can access.

For the 2025 registration year, there will be an update to the seasonal athlete membership. Athletes may only have one seasonal membership per registration year. Currently Montana Swimming offers three different individual seasonal athlete memberships (individual, season 1 for short course, and season 2 for long course), and all are only good for 150 days. Next year, only one seasonal athlete membership will be offered good for only 150 days beginning on the first day the athlete is registered. At the end of the 150 days, the athlete must upgrade the membership to a premium membership to continue to practice and compete. This year, if the athlete upgraded the seasonal membership before it expired, they only had to pay the difference between the seasonal membership cost and the premium membership cost. If the seasonal membership expired, the athlete had to pay the full cost of a premium membership. Next year, the seasonal athlete will be able to upgrade to the premium membership even if the seasonal membership has expired without paying the full premium cost. Meet directors and chaperones should register with an "other" membership at \$84. A person with an administrator only membership can't be a meet director.

If non-athletes have multiple types of memberships, such as coach, official, and other, you only pay one fee, currently \$84 – not a fee for each membership type. You do have to register for each membership.

Clubs to be in good standing must always have a head coach in good standing and at least one registered athlete member.

Montana Swimming does check the registration status of athletes entered in meets if the club sends me a Meet Manager back-up prior to the meet. Send the MM back-up to me as soon as your entries close. You can always send another back-up if you have late entries. Sending the back-up sooner allows me to contact teams to correct registration issues including athletes who must complete the APT. Any athlete18 and older must have a current APT. Anyone who does not and competes in a meet creates liability issues for the host team as the athlete doesn't have a current membership and the times for that athlete will not upload to SWIMS.

Montana Swimming is no longer checking the registration for coaches and officials prior to meets due to changes to the report generated in SWIMS. Officials and coaches must show their current registration card on their USA Swimming app on their mobile device or may print a copy of their card to show the meet referee or designee.

Clubs will again have the option to opt in for bulk renewal this fall for athletes and non-athletes or both. Look for information to be sent out in July and early August. Currently four clubs have opted in for bulk renewal for this registration year.

Coaches and officials should send concussion certificates and Red Cross certificates for CPR, lifeguard, STFSC-W, and STFSC-O to Jay and me to post to your accounts. These certifications do not automatically upload to your account but must be manually loaded.

Montana State law requires that all youth sport coaches and officials take the concussion course each year. To follow Montana High School Association guidelines, you should take the NFHS course after June 1 each year. Montana Swimming only needs to upload your concussion certificate once to your account. Individuals and clubs should track if coaches and officials have completed with state law after the first year.

Outreach Membership Criteria

Outreach memberships are offered to qualifying low income and/or disability athletes in Montana Swimming. A year-round outreach membership in Montana Swimming is \$7.00. The outreach membership must be applied for annually. The qualifying documents should be shown to the member's club registrar for verification (or in the case of unattached athletes to the Montana Swimming DDEI chair who will verify it to Montana Swimming registrar). Clubs and Montana Swimming may not retain the documents.

For low income families to qualify for outreach membership you must show one of the following documents or letters to the club registrar or Montana Swimming DDEI chair: Federal free or reduced hot lunch program, 1040 tax form, Food Stamps (SNAP) program, Food Distribution Program on Indian Reservations (FDPIR), TANF, WIC, low income housing (Section 8, housing choice vouchers), low income energy assistance (LIEAP), Supplemental Social Security Income (SSI), private/parochial school based financial needs program, foster children, participation in Head Start, Medicaid, Medicare, Healthy Montana Kids Plus, Healthy Montana Kids, homeless, runaway, migrant, refugee, is a member of the club on a reduced or free scholarship, or their income is within the Federal Poverty Guidelines. Cases not falling under these circumstances may be appealed to the General Chair.

Outreach membership registration is also available to athletes who have a disability as recognized under the USA Swimming rules, Article 105. Any athlete with a disability applying for outreach membership <u>must</u> also be registered as a disability athlete. Families must show the club registrar (or in the case of an unattached athlete, the Montana Swimming DDEI Chair who will verify it to the Montana Swimming registrar) a letter verifying that the athlete is disabled as recognized under the USA Swimming rules Article 105. Medical paperwork does not have to be submitted.

Disability is defined as a permanent physical or cognitive disability that substantially limits one or more major life activities.

Disability athlete registration categories include:

- Legally blind or visually impaired,
- Deaf or hard of hearing,
- Physical disabilities (such as amputation, dwarfism, cerebral palsy, spinal injury, mobility impairment, limb deficiency, wheelchair bound with high functioning upper body, non-ambulatory (wheelchair bound), limited use of all four extremities), and
- Intellectual/Cognitive disability (such as severe learning disorders, Down Syndrome, autism spectrum disorder).

Disability athlete may register to compete as:

- P1 athletes -- Non-ambulatory (wheelchair-bound), limited use of all four extremities.
- P2 athletes -- Ambulatory with assistance: includes dwarfism, multiple limb deficiency, wheelchair-bound with high functioning upper body.
- P3 athletes Ambulatory without significant assistance: includes single-limb deficiencies, blind/vision impaired; deaf/hearing impaired; intellectual, cognitive, and developmental impairments (including autism spectrum disorder and Down Syndrome); and other.

2024 Spring Times Chair Report

Congratulations to **Kaia Lyons**, **BOZ**, for being ranked nationally in the top ten for 11-year-old girls in these yard events:

- 100-yard breaststroke ranked 4th with a time of 1:08.84.
- 50-yard breaststroke ranked 8th with a time of 2.12.
- 200-yard breaststroke ranked 10th with a time of 2:32.56.

<u>LSC Top Times Reports:</u> These reports are ow available in SWIMS although the report format is different from the past reports. I will post these each month on the website. Clubs also have access to club times reports in their hub.

<u>Time Trials:</u> Due to how meets are set up in SWIMS 3.0, teams hosting a time trial in conjunction with an invitational meet must sanction the time trial separately from their invitational meet. Time trials need a separate sanction number, separate Meet Manager database and the er swimmer fees must be paid to Montana Swimming. Please name your time trial something similar to your invitational meet if you wish. 2024 BAC Spring Fling Invitational and 2024 BAC March Time Trials are examples. You do need to specify the events you'll offer in your time trial meet announcement. For officials training purposes, training at time trials does not count toward the required number of sessions to become certified. Time trials also don't count towards needed sessions for N2 and N3 certifications.

<u>Meet Results:</u> Meet results are posted on the website on the past meet results page. I try to have the meet results uploaded to SWIMS and Team Unify within a day or two of receiving them.

Scholastic All America: I serve as the Western Zone women's tabulator on the Scholastic All America sub-committee. The online application opens June 1. Athletes must have completed the 9th, 10th, 11th, or 12 grade; have a 3.5 GPA or higher in academic subjects; and have a 2023 Winter Juniors qualifying time to be named to the SAA team. I encourage all qualified Montana Swimming athletes to apply. This year the athletes and their parents and their club will receive an email notifying the athletes that they have a qualifying time. Athletes are directed to the application to apply.

<u>SwimCloud:</u> SwimCloud is an online platform showing meet results for athletes who wish to have their times available for college coaches to view. I do try to send the results to SwimCloud after each meet. I am unable to send them results from single team or dual meets – the team must submit those results. None of the times on SwimCloud are verified in the same manner as times in SWIMS. There have been concerns expressed across the country about providing results for Swim Cloud so USA Swimming may decide this will not be allowed in the future.

Meet Manager File Names and Report Headers: The correct manner to name your Meet Manager file for a meet is the Year-LSC-Club Code-Meet Name such as the 2024 MT BOZ Smiles May Classic. If names are too long, they will not upload in Team Unify. Also, under the report headers, please list the meet name, location, course, and include the sanction number. The USA Swimming rules require this information. You do not need to list the name of the meet referee. An example would be:

2024 MT BOZ Teddy Bear Classic, Sanction xxxx Butte YMCA 25Y Pool, Butte, MT

<u>Meet File Names:</u> Some meet event file names that are too long to be uploaded onto the Team Unify platform, so I have had to shorten the names to upload the files. Please be aware of that potential problem when naming your Meet Manager files.

<u>Flex Athlete Competing in More than 2 Sanctioned Meets:</u> This year I encountered some problems with uploading results for flex athletes who competed at more than two sanctioned competitions. Flex athletes may only compete in 2 sanctioned meets and no championship meets unless they upgrade to a premium membership. As I encounter this when doing pre-meet registration recon, I do email teams to let them know of the problem.

18 and Over Athletes and APT: Athletes ages 18 and over who had not completed the athlete protection training prior to competing in a meet had their times rejected when uploaded into SWIMS. I did contact coaches of athletes when possible that I was aware of who had not completed the APT prior to a meet, but there were some athlete times that were not uploaded into SWIMS. If these times should appear in Team Unify, they cannot be used for entry using OME or with an event file when proof of time is required. I do try to delete out these athletes from the results file before uploading times in Team Unify.

<u>Semi-final meet results:</u> SWIMS 3.0 and Team Unify will not upload semifinal results from meets. (The only exception is foreign meets or US Olympic Trials using different meet software.) Meets may not be sanctioned in Montana with semi-final rounds at this time.

Mixed Relay Errors: A legal mixed relay must be composed of two males and two females. All girls and all boys relays are not legal mixed relays and their times will not be uploaded into SWIMS (relays with 3 girls and 1 boy or 3 boys and 1 girl are also not legal mixed relays). These non-conforming relays should be disqualified. I encourage teams to offer girls, boys, and mixed relays at meets. The meet referee may combine those relays to swim together during the meet, but after the races are concluded the AO can adjust the relays and split the correct teams back into the correct events. If you have questions about how to do this, please contact me.

<u>Relays:</u> For relay times to be uploaded to SWIMS, each relay team in Meet Manager must list the names of the four swimmers who swam. The swimmers must be currently registered athletes from the same team. Relays must conform to the relay information listed on the event list as far as age and gender. Open relays may include swimmers of any age. Unattached swimmers may not swim on relays.

2024 Spring Scholastic All America Report



The Scholastic All America application for the 2023-2024 year will be available online at the USA Swimming website beginning June 1, 2024.

- The only method for application will be the online application on the USA Swimming website.
- New this year the swimmer and parent along with their club will receive an email letting them know the swimmer has a qualifying time for Scholastic All America. The athlete must go online and apply and upload a transcript (in pdf or jpeg format).
- Parents, if you apply for your child, you must log into the child's account to apply not your parent account.
- Applicants will be required to have a USA Swimming account.
- Qualifying pool times for the applicant will be validated in SWIMS. Times <u>MUST</u> be in SWIMS and have been achieved between September 1, 2023, and August 31, 2024 (dates inclusive).
- Applicants will be required to have a transcript for the complete 2023-2024 academic year available for uploading to the application. Must have a 3.5 or higher gpa. Report cards and grade cards are not accepted. Grading scale is as follows: A=4; B-3; C=2; or A= 90-100, B- 80-89; C=70-79. Grades lower than a C disqualify the applicant. Non-academic subjects are not included in the gpa calculation.
- Must have completed the 9th, 10th, 11th, or 12th grade.
- AP, IB, and Honors courses will receive an additional one fifth of a point (0.2) on the grading scale.
- Applicants must have been a member at the time of the swim and a current member when applying for the 2023-2024 SAA team.
- Applicants must have all application documents completed by the application deadline. Late applications will NOT be accepted or considered.
- Once you apply, you'll receive a conformation email. If you don't receive it, contact Anissa Kanzari at kanzari.anissa@gmail.com

POOL REQUIREMENTS

Applicants must have swum an individual pool time equal to or faster than the 2023 Winter Junior National qualifying time in any individual event during the SAA qualifying period (Sep 1, 2023-Aug 31, 2024, dates inclusive) with the qualifying times in SWIMS.

Only ONE time is necessary and only ONE application is necessary.

SWIMMERS WITH DISABILITIES

Applicants must have swum an individual pool time equal to or faster than the <u>2023-2024 Para Scholastic</u> <u>All American Standards</u> (posted on the SAA page) in any individual event noted within their self-reported P1, P2, or P3 grouping during the SAA qualifying period (Sep 1, 2023-Aug 31, 2024, dates inclusive) with the qualifying times in SWIMS.

Only ONE time is necessary and only ONE application is necessary. A cap of 56 athletes will be named with 2/event/gender.

OPEN WATER SWIMMERS

Applicants must have swum an individual pool time equal to or faster than the 2023 Winter Junior National qualifying time in the 800, 1000, 1500, or 1650 freestyle during the SAA qualifying period (Sep 1, 2023-Aug 31, 2024, dates inclusive) with the qualifying times in SWIMS <u>AND</u> participate in the Open Water National Championships held on May 3-5, 2024.

Only ONE time is necessary and only ONE application is necessary.

If the applicant wishes to be recognized as an open water swimmer, make sure to select that on the application.

GRADE & GPA REQUIREMENTS

Applicant must have completed 9th, 10th 11th or 12th grade

MINIMUM GPA

Application must maintain minimum 3.5 GPA for the current academic year

GRADE CONVERSION

A=4, B=3, C=2. If numerical grades are used, the following scale will be used unless the school's letter grade conversion is given on the transcript: A=90-100; B=80-89; C=70-79. In calculating the GPA, no rounding will be used – one decimal place only.

HONORS & ACADEMIC SUBJECTS

Honors, Advanced Placement, International Baccalaureate, PLTW courses, and dual credit college level academic courses will earn one fifth (.2) extra Grade Point.

Only grades for academic subjects will be used to calculate GPA – history/social studies, English, mathematics, sciences, foreign languages, computer sciences, visual and performing arts if indicated as academic.

A grade lower than a C in an academic subject will mean automatic rejection of the applicant.

Grades for non-academic courses will NOT be calculated – art, band, orchestra, choir, home economics, health, driver education, physical education, shop, etc. and any other class marked as non-academic will not be included in the GPA calculation (unless transcript indicates 'academic' or AP or IB).

GRADE

There will be no special status designation for a 4.0 GPA other than for a National Champion in the pool or open water who also has achieved a 4.0 GPA. Junior National or 18 and Under Champions will not be considered.
