I. Call to Order

Following discussion, the motion was made and seconded to provide reimbursement for participant's travel either for economy airfare or mileage up to the cost of the economy airfare at the MVS mileage rate. Motion was approved.

d. Safe Sport Recognition Program

Jae Davis discussed the idea of an incentive for clubs that complete the Safe Sport Recognition program. No decisions were reached.
