

USA Swimming Registration



Overview

An active USA Swimming registration is required for all members of ECA. All year-round athletes join USA Swimming through their Local Swimming Committee (LSC), one of 59 local organizations responsible for administering USA Swimming activities in a defined geographical area.

Year-round athlete membership is for a calendar year period (January - December).

Athlete memberships processed between September 1 and December 31st are valid through December 31 of the following year.

Year-round athlete membership provides liability and secondary accident medical insurance coverage.



Membership Options

Membership	Who	Limitations
Flex Membership (\$31)	Swimmers (ages 12 & U)	Limited to participated in 2 sanctioned swim meets (meet fees still apply)
Premium Membership (\$81)	All 13 & over swimmers 12& under who will be competing in 3+ meets or at championship level meets	None
Seasonal Membership (\$51)	13 & over swimmers who will only swim for a couple months or not sure they are ready to commit to a full season	Good for only 120 Days Must upgrade to Premium upon expiration (\$30 upgrade)
Outreach Membership	Families that can show financial need	None

FAMILIES NEW TO USA SWIMMING

Step 1 – SET UP A PARENT ACCOUNT
