Dave Sokolofsky made a motion to approve October 2025 minutes, 2nd; Bridget Phillips; all approved

Coach's Report - Dave Sokolofsky

BAC was a typical BAC meet, JP and Dave don't plan to go back there in January, WOW will host a dual meet at UNCW 1/24-25 instead, BAC may attend; proposed they scrap the BAC January meet and hold the qualifier there instead

74 kids going to ECA meet in Greenville, 97 going to Charleston. SC meet in December, entries in earlier than usual for Charleston because they have a very firm cap on the meet

Parent T-shirt orders have been out for a while, no date on them yet, decent number of orders, mostly black, then light blue, not too many beehives

After 10/31 deadline, we had 4 kids drop, but added 3 so at 168, middle school groups still low, 6 short in AG 3 and 7 short AG 4, over by 1 in AG 1

Treasurer's Report - Brianne Higgins

End of year financials for 24-25, meets will not match up from previous year

Loss of \$30,000

Our sweet spot is 200 swimmers; we would break even at the current expenditure with 200 swimmers

Changed \$5,000 from September figures because we hadn't been billed by the Y yet and a scholarship wasn't paid out

No update on the worker's comp situation

Once 2024-25 audit is complete around the end of November/beginning of December, we need to file by 1/19

Recommended changing audit due date to 1/1, bylaws originally stated 11/1

No invoices from UNCW yet, had prepaid \$2,200 dollars without invoice and they didn't know where to put it, they kept the \$ but asked us not to pay again without an invoice

UNCW has no emergency plan that doesn't involve students, faculty and staff and no response from campus security; Board OK with Brianne sending emails up the chain of command to request one

Nir YMCA hasn't officially billed us for this fiscal year, we are paid up through 11/30 (paying the fixed fee without the invoice)

Brianne asked Board to discuss whether she owes WOW \$548 for facility and monthly fees

Discussion around what goes in the Bylaws vs into a policy and procedures document, reference USA swimming for examples

John will look at what USA swimming has put in policies and procedures and make recommendations for the WOW policies and procedures document

Got cashback for spending enough on the credit card

John asked question about number of Board Members required for the audit, John offered to come

Discussion re: how we can break even moving forward without depending heavily on the number of swimmers
