Two of the swim meets would be international para-swimming meets which would attract swimmers from all over the world. The second meet would be a sectionals swimming meet, which would also attract a large number of swimmers from around the region/country. Brian Strom stopped by to discuss UND's potential role in hosting these meets. He agreed to speak with para-swimming leadership regarding the necessary requirements top host these meets. The RRV Board agreed to work with UND going forward as a co-host/co-sponsor of those meets.

The Board also agreed to support efforts to host a sectional swimming meet. The timeframe on a sectional swim meet would be in the 2019-2021 timeframe.
