• The JCCNS may adjust the monthly rate it charges for my (our) Swim Team Registration. I understand that I will receive notice prior to any such change. An example of this would be moving from one practice group to another.

• Should a draft not be honored by my (our) bank for any reason, I understand that the JCCNS will automatically resubmit the draft for payment. If the draft is not honored on the re-submission, the amount of the draft as well as a \$20 service charge will be immediately due and payable to the JCCNS.

• I understand that after two unpaid drafts, the JCCNS will terminate my (our) Swim Team Registraton until I (we) have brought all payments up to date. I have read the terms of this agreement on the front of this document and agree to abide by these terms.
