| <b>SITE</b>                | The University of New Hampshire Swasey Competition Pool is an 8-lane, 25-yard pool with 4-foot-wide lanes and non-turbulent lane lines. The timing system includes a full-automatic Colorado electronic timing system with touchpads at the finish end of the pool with single-line electronic display. There are no touchpads at the finish end of the pool. Six lanes will be used for competition. Lane 8 of the pool is a diving well area that is available for warm-up and warm-down. The pool deepens across the lanes that lane 1 has a minimum depth of 4 feet at the start and finish and lane 6 has a minimum depth of 6 feet at the start and finish. The depth at the start end is the same as that at the turn end. Spectator seating is for 605. The pool is located inside the UNH Field House, 145 Main Street, Durham, NH 03824. As you face the Field House with Main Street behind you, enter through the door to your far left. |
| <b>COURSE</b>              | SCY  |
| <b>FORMAT:</b>             | <ul style="list-style-type: none"><li>• The meet will be swum as Timed Finals. Swimmers will be seeded slow to fast. This meet will run as a positive check-in.</li><li>• <b>DISTANCE EVENTS:</b> The 500 Free will run as "mixed" slow to fast events. Lane timers will be provided.</li><li>• No events will swim with more than one swimmer per lane.</li><li>• 25-yard events will start at the start end) and will be timed with the electronic system or stopwatches.</li></ul>  |
| <b>SCRATCHES</b>           | <ul style="list-style-type: none"><li>• Scratch sheets will be used for all sessions and must be turned in at the control table 30 minutes before the start of each session regardless of scheduled warm-up time. Failure to do so could result in athletes being scratched from the session.</li></ul>  |
| <b>ELIGIBILITY</b>         | <ul style="list-style-type: none"><li>• All swimmers must be currently registered as athlete members of USA Swimming (USAS) <b><i>before 5:00 pm on the day before the first day of the meet.</i></b></li><li>• Age is determined by the age of the swimmer on the first day of the meet.</li><li>• Any swimmer entered in the meet must be certified by a USAS Member-Coach as being proficient in performing a racing start or must start each race from within the water without the use of the Backstroke ledge. When unaccompanied by a Member-Coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li><li>• Coaches must be registered before the start of the meet.</li></ul>  |

|                            | <ul style="list-style-type: none"> <li>• If a swimmer who is not properly registered with USAS competes in a sanctioned competition, the host LSC will impose <b>a fine of up to \$100.00 per event against the individual, member coach, or a member club</b> submitting the entry.</li> <li>• Deck Registrations will NOT be accepted.</li> </ul>  |
| <b>DISABILITY SWIMMERS</b> | <ul style="list-style-type: none"> <li>• Athletes with a disability are welcome; they, or the athlete's coach, shall provide advance notice of desired accommodations to the Meet Director.</li> <li>• The athlete, or the athlete's coach, is also responsible for notifying the Meet Referee of any disability prior to the competition.</li> </ul>  |
| <b>ENTRY POLICY</b>        | <p><u><b>100% Invitational</b></u></p> <ul style="list-style-type: none"> <li>• The meet host may allocate 100% of splashes for the meet.</li> <li>• 25% of the splashes allocated must be allocated to New England Swimming Teams, excluding the meet host. The meet host must make a reasonable effort at the time of allocation to solicit interest from New England Swimming teams express interest at the time of allocation, the meet host may proceed with allocating these reserved splashes to out-of-LSC teams.</li> <li>• If a specified allocation of splashes is granted to a team and agreed upon in writing between the meet host and attending team, the attending team is financially responsible for that allocation if unused, unless the meet host is able to substitute other participants to fill the unused splashes.</li> </ul>  |
| <b>CUT PROTOCOL</b>        | <p>If a session is over-subscribed, the Meet Director reserves the right to limit events, heats, swimmers, or adjust the format to conform to the 4-Hour Rule using the following Cut Protocols in any order deemed necessary:</p> <ul style="list-style-type: none"> <li>• Teams may be asked to cut each athlete to no more than two fewer events per day than the maximum allowed.</li> <li>• Entries may be cut by time, or to a specific number of heats, for specified events.</li> <li>• Teams may be asked to cut relay events.</li> <li>• If deck scratches allow a reasonable timeline, the swimmers can be reinstated into those previously entered events. Clubs will be notified of cuts no later than Monday before the meet.</li> </ul>   |
| <b>ENTRIES</b>             | <ul style="list-style-type: none"> <li>• Electronic entries should be emailed as an attachment to the Entry Chairperson. Please check that your team's name, address, and contact information are listed correctly in this file. For email entries, payment and hardcopy of the entry (including signed Entry Payment and Liability Release Form) must be received by February 7, 2026. Failure to pay Entry Fees by this deadline could result in teams being barred from the meet.</li> <li>• Mail completed signed Entry Payment and Liability Release Form, as well as payment, to:<br/>Oyster River Otters<br/>PO Box 105<br/>Durham, NH 03824<br/>Checks are to made out to 'Friends of Otters'</li> <li>• Any team that fails to send the Entry Payment and Liability Release Form as well as payment by the aforementioned date may be scratched from the meet and may be assessed a \$100 fine at the discretion of the Entry Chairperson. If no payment is received after 30 days, the fine is doubled. This fine is payable to Oyster River Otters. Late payment of entry fees may result in future exclusion from meets hosted by our club.</li> <li>• IMPORTANT: If payment is sent via Express Mail/FedEx/Airborne/UPS/etc., please ensure that a signature is NOT required for delivery.</li> <li>• Entries will be acknowledged within 24 hours if they are accepted into the meet. <b>Your entry is considered received only if you receive an acknowledgement.</b></li> <li>• All Unattached swimmers must be declared as "Unattached" on the Entry Payment and Liability Release Form before the meet begins.</li> <li>• All Entry Times must be entered in the specified meet course. Coach's times may be used (and are preferred) instead of "NT" Entry Times.</li> <li>• Athletes may only compete in a <b>maximum of three (3) Individual Events per day and two (2) relays</b>. Time trials count in the per day event count.</li> <li>• <b>ENTRY TIME UPDATES:</b> Entry Times may be updated <b>until 6:00pm on the Monday prior to the first day of the meet (February 1, 2026)</b>. No new entries will be accepted after the Final Date of Entry Acceptance; they will be automatically excluded from Entry Time Update files. | <b>TIME TRIALS</b>  | Time Trial events will be offered at the discretion of the Meet Director and the Meet Referee.  |
| <b>RELAYS</b>       | <ul style="list-style-type: none"> <li>Dual Human Confirmation of relay take off violations will be required at all New England Swimming meets.</li> <li>There is no limit to the number of relays a team can have.</li> <li>All relay swimmers must be officially entered into the meet.</li> <li>Unattached swimmers may not participate in any relays.</li> <li>Mixed relays must consist of four swimmers, two of each gender.</li> </ul>   |
| <b>FEES</b>         | <ul style="list-style-type: none"> <li>Timed Final Individual Specialty Events (200-yards and under): \$3.00</li> <li>Distance Events (400-yards and over): \$6.00</li> <li>Relay Event: \$12.00</li> <li>Time Trial Individual Events: \$5.00</li> <li>Time Trial Relay Events: \$20.00</li> <li>Per-Swimmer Participation Fee: \$12.00</li> <li>Per-Swimmer NES Travel Fee: \$1.00 (to be included in the check sent by the host team to NES)</li> </ul>  |
| <b>MEET MOBILE</b>  | <b>MEET MOBILE:</b> Meet Mobile will be functional for this meet, (dependent upon satisfactory internet access). All users should be aware that Meet Mobile publishes unverified raw data that may not always be accurate.  |
| <b>WARM-UP</b>      | <p>The pool will be open for warm-ups and designated on the event list. Two (2) twenty-five minute warmup periods will be held for each session. The pool will close ten minutes before the beginning of each session. Teams will be assigned warm-up lanes after all entries are received. The diving well area will be available during the meet for warm-up and warm-down.</p> <p><b>See “Safety” for Warm-up safety guidelines.</b></p>   |
| <b>AWARDS</b>       | Ribbons will be awarded through 6 <sup>th</sup> place to the following age groups: 8 and under, 9-10, 11-12, 13-14, 15 and up.  |
| <b>SCORING</b>      | The meet will not be scored.  |
| <b>LEGAL SPLITS</b> | <p><b>Individual Events:</b> Preferably, Legal Splits should be requested before the event, by a coach, using a Legal Split Form (available from the Control Table), and the requesting party should supply an additional timer(s) on the lane for the split, if necessary, to ensure an accurate time (one timer with touchpad timing, three timers without touchpad timing). Timers must be positioned over the lane at the end of the racing course. Optionally, a Legal Split may be requested after the event using a Legal Split Form when using a fully automatic timing system. The Admin Official has discretion to either grant or deny the request after reviewing the available evidence. Backstroke Legal Splits must be requested in advance to ensure a legal finish.</p> <p><b>LEGAL SPLITS – Relays:</b> All lead-off splits for relays are automatically loaded into SWIMS and do not require additional watches for validation unless there are no touchpads present, or the second swimmer starts in the water. If there are no touchpads, or the second swimmer starts in the water, a legal split form with three watches will be required for entry into SWIMS. Timers must be positioned over the lane at the end of the racing course. It is recommended that coaches report lead-off time discrepancies to the Administrative Referee or Administrative Official.</p> |
| <b>SWIMWEAR</b>     | Per USA Swimming rules (102.8.1.F), 12&Under swimmers may not wear a Technical Suit at any Sanctioned, Approved, or Observed meet. The age of the swimmer is determined on the first day of the meet. Guidance on identifying compliant and non-compliant suits can be found on the USA Swimming website under <a href="#">Tech Suit Restriction for 12-and-Under Swimmers</a> .  |
| <b>RULES</b>        | <ul style="list-style-type: none"> <li>The <a href="#">current USA Swimming Rules and Regulations</a> including the <a href="#">Minor Athlete Abuse Protection Policy (MAAPP 2.0)</a> will govern this meet.</li> <li>Operation of a <b>DRONE</b>, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USAS approval.</li> </ul>  |

|                   | <ul style="list-style-type: none"> <li>• Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is <u>not permitted</u>.</li> <li>• <b>PHOTOGRAPHY:</b> As per NES policy, professional photographers contracted by M.F. Swimming, LLC, or press photographers who have been approved in advance by the Meet Director, are allowed on deck. Use of audio or visual recording devices, including a cell phone, is not permitted behind the starting blocks, including in any spectator area behind the starting blocks, nor in any other marked NO CAMERA ZONE, including on deck. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests.</li> <li>• <b>VIDEO STREAMING:</b> All video streaming must be approved in advance by the Meet Director. Any such video stream must conform to all current SafeSport policies defined by USAS, NES, and the Meet Host. No video stream may originate from behind the starting blocks or from any other area marked as a NO CAMERA ZONE.</li> <li>• Deck Changing is <b>PROHIBITED</b>.</li> <li>• An athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider.</li> <li>• According to NES Best Practices, all athletes should shower before entering the pool.</li> <li>• In accordance with NES Policy, only those coaches who have current, valid USAS credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area.</li> </ul> |
| <b>SAFETY</b>     | <ul style="list-style-type: none"> <li>• No shaving is permitted at the competition site.</li> <li>• No glass containers are permitted within the facility.</li> <li>• Swimmers must be under the supervision of a coach. If a swimmer arrives at the meet without a coach, the swimmer should notify the Meet Referee before he/she warms up, and the Meet Referee will assign the swimmer to a registered coach for warm-ups.</li> <li>• At least 2 lifeguards are on duty during the meet. An AED is located on deck.</li> </ul> <p><b>WARM UP SAFETY:</b></p> <ul style="list-style-type: none"> <li>• Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time.</li> <li>• For all warm-up sessions, swimmers must utilize a “sit-and-slide”/“three-point” entry to enter the pool for warm-ups, by first sitting on the deck, and then sliding, feet-first, into the pool.</li> <li>• In extraordinary cases, due to bulkheads and other pool designs, it may be determined that it is unsafe or impossible for swimmers to perform the required sit and slide entry. In such extremely rare cases, the sit and slide rule may be modified. Exceptions to the sit and slide rule shall only be made when performing the sit and slide entry poses risk of injury to swimmers and/or risk damaging or ripping of swimsuits. An exception to the sit and slide rule shall only be made when the Safety Monitor, Meet Director, and Meet Referee have evaluated the risks and unanimously determined that the use of the sit and slide entry poses such great risk as to be unsafe. In these cases, the Safety Monitor, Meet Director, and Meet Referee must determine and agree upon an alternative safety plan to ensure swimmer safety.</li> </ul>   |
| <b>SAFE SPORT</b> | <ul style="list-style-type: none"> <li>• The USA Swimming SafeSport program is USAS’s comprehensive abuse prevention program dedicated to creating a healthy and positive environment free from abuse for all its members. Components of the program include, but are not limited to, providing education and training, enforcing policies (such as the <a href="#">Minor Athlete Abuse Prevention Policy</a>), rules and best practice guidelines, promoting healthy boundaries and mandatory reporting of violations.</li> <li>• The <a href="#">Minor Athlete Abuse Prevention Policy</a> prohibits Adult Participants (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult participant. Adult Participants are required to abide by this policy in full during this meet.</li> <li>• Pursuant to <a href="#">USAS Rules and Regulations</a> and federal law, it is every member’s responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. | <b>FACILITY RULES</b>            | Swimmers are limited to the pool and locker room areas. Children must be accompanied to the restrooms by an adult.  |
| <b>CHANGES TO MEET</b>           | Once a meet is sanctioned, changes can be made to the Meet Information before the meet only with the approval of the Co-Technical Chairs, <a href="#">Patrick Johnstone</a> and <a href="#">Greg Gower</a> . Any change to the Meet Format after the meet begins will be at the discretion of the Meet Referee, and will be presented to the coaches at a coaches meeting.  |
| <b>WEATHER/FACILITY PROTOCOL</b> | If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have a right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is the decision of the Meet Director, Meet Referee, and the Meet Jury.  |
| <b>MEET JURY</b>                 | The Meet Jury will be made up of one official, one coach, and one athlete to be selected by the Meet Referee who will present issues and moderate the Meet Jury but not vote. When possible, the three members shall be from separate teams. The Meet Jury will decide all issues of eligibility, and anything not addressed in the Meet Announcement. The Meet Referee shall have authority as described in the current USA Swimming Rulebook.   |
| <b>DECK ACCESS</b>               | Only current USA Swimming registered athletes, coaches, officials, and official meet staff are permitted on the pool deck. All non-athletes on the pool deck must produce proof of their valid USA Swimming registration when asked. Individuals without proof of a valid membership in USA Swimming will be removed from the pool deck and will be fined by New England Swimming of \$100 to the coach, and \$200 to the coach's club.   |
| <b>OFFICIALS</b>                 | Officials that know they will be attending the meet are highly encouraged to email the Meet Referee and let him/her know your level of certification, team, and sessions you will be available. Officials meetings will be at least 30 minutes prior to the start of a session or conducted virtually in the days before the meet.  |
| <b>GENERAL</b>                   | There will be no hospitality area or vendors at this meet.  |
| <b>WAIVERS</b>                   | USA Swimming, Inc., New England Swimming, Inc., and the Oyster River Otters cannot prevent you (or your children) from becoming exposed to, contracting, or spreading COVID-19 while participating in USA Swimming/New England Swimming sanctioned events. It is not possible to prevent the presence of the disease. Therefore, if you choose to participate in a USA Swimming/New England Swimming sanctioned event, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.  |
