

WHAT: Aqua Pentathlon - All swimmers compete in 5 events. Points are awarded for each event and combined for an overall finish in each age group.

LOCATION: Lake County West End Y @ Union Village, 36909 Ridge Road, Willoughby, Ohio 44094

COURSE, WARM-UPS, & START TIMES: 8 lanes, 25 yards. Daktronics timing system will be used. Warm-up times will be assigned by team on Thursday, February 12th, 2026. **Meet begins at 10 AM.**

ELIGIBILITY: Swimmers must be current Y members and swim exclusively for their YMCA team. No unattached swimmers.

AGE GROUPS: 8 & Under, 9-10, 11-12, 13 & Over. Age as of 12/01/26

ENTRY FEES: Fee of \$22 covers all 5 events. Make checks payable to Lake County YMCA. Please bring checks on day of meet.

Each 8&Under will swim 25 of each event plus a 50 free.

Each 12&Under will swim 50 of each event plus a 100 free.

Each 13&Over will swim a 50 free, 100 of each event plus a 200 free.

DEADLINE FOR ENTRIES: Best yard times must be submitted for all events.

PM Tuesday, February 10, 2026. Hy-Tek entries preferred. Deck entries can be seeded in to open lanes only.

AWARDS: Heat winner awards. Ribbons for top 8 places in each event. Trophies for top 8 overall swimmers in each age group to be presented immediately after completion of age group. No team scoring.

TEAM AREAS: Everyone will be housed in the field house. Swimmers will access the pool through the high school locker rooms. Parents will be able to view the meet from the balcony bleacher seating. No parents on the pool deck unless volunteering.

ADMISSION & HEAT SHEETS: There is no cost for admission. Heat sheets will be available in limited quantities for \$3.

CONCESSIONS: Full concession stand will be available. NO CHARGE for coaches and officials. All coolers must remain in Field House.

CONDUCT: Coaches are responsible for conduct and supervision of all swimmers. Please be responsible and clean up team areas in the field house and balcony.
