SITE	The Christopher G. Lynn Competition Pool is a 8-lane, 25-yard pool with six and a half foot-wide lanes and non-turbulent lane lines. The timing system includes a fully-automatic Omega Time Systems electronic timing system with touchpads at the finish end of the pool with single-line electronic display. There are no touchpads at the turn end of the pool. The pool is a consistent 7'1' to 7'3" depth. Spectator seating is for 500. The pool is located inside the Pan Athletic Center, 5 Highland Rd, Andover, MA 01810. The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.		
COURSE	 SCY Entry times will be seeded in the following order: SCY, LCM, SCM 		
FORMAT:	• The meet will be conducted in a trials/finals format. Prelims and Finals will be conducted in 8 lanes. There will be 3 heats in Finals: C (bonus final), B (consolation), and A (Championship) heats, in that order, in all individual events, except the 1000 Freestyle and 1650 Freestyle. The A		

- and B finals will score. The 1000 Freestyle and 1650 Freestyle are timed finals events. No events will swim with more than one swimmer per lane.
- 50 yard events, except the 50 Freestyle, will use their time in the 100 of the event to qualify and enter the event, even if they have a 50 time in SWIMS.
- Breaks within sessions may be added at the discretion of the Meet Director and Meet Referee in consultation with the Senior Chair and Performance and Development Vice Chair.
- DISTANCE EVENTS: The 1000 and 1650 Freestyles are timed finals. On Thursday evening, the women's 1000 Freestyle and the men's 1650 Freestyle will be seeded fastest to slowest, alternating heats women/men. On Sunday, the fastest seeded heat (8 swimmers) of the women's 1650 Freestyle and the men's 1000 Freestyle will compete in Finals. All other heats will be fastest to slowest alternating women/men, immediately after the completion of the final Sunday prelims event. All distance swimmers in the prelim heats must provide one timer for their swims.
- EARLY DISTANCE OPTION: During the positive check-in process for the Women's 1650 Freestyle and the Men's 1000 Freestyle on Sunday, coaches will have the option of declaring for a preliminary session swim. The fastest 8 swimmers who state no preference to compete in the preliminary session will be seeded into the finals session.
- THURSDAY DISTANCE: There will be a warm-up session at the conclusion of the distance events and before the start of the 800 Free Relays. The length of the warm-up will be determined by the Meet Director after the seeding of the distance events but will be no less than 20 minutes.
- 500 FREESTYLE AND 400 IM: At the discretion of the Meet Referee, in consultation with the Meet Director, Senior Chair, and Performance and Development Vice Chair, the 500 Freestyle and 400 IM may be seeded in an A/B flight format. All swimmers in the 500 Freestyle and 400 IM must provide 1 timer regardless of flighting.
 - O Flight A: The fastest 4 heats of women will be swum slowest to fastest (with the top 2 heats circle seeded) followed by the fastest 4 heats of men swum slowest to fastest (with the top two heats circle seeded).
 - Flight B: The remaining heats will be swum fastest to slowest, alternating women/men. (These heats may be swum at the end of the session).

SCRATCHES

- Scratch forms will be located at the Control Table on deck.
- Entrants in the Thursday 1000 and 1650 Freestyles must positively check in and confirm their intention to compete by 4:00 PM on Thursday.
- Other pre-meet scratches (including relays) can be e-mailed to mobrien8146@gmail.com by 4:00 PM on Thursday, December 18, 2025. Write: "SCRATCH —your team's name" in the subject of the email.
- All scratches for prelim sessions, including relays, are due 30 minutes after the start of the finals session the night before. Scratches should be processed, in person, at the control table. In the event that you need to scratch but have not yet arrived at the pool, please email jessworkman.swim@gmail.com.
- Positive check in for the Women's 1650 Freestyle and the Men's 1000 Freestyle are due 30 minutes after the start of finals on Saturday evening.
- Coaches and swimmers are expected to understand the scratch, verification and relay rules before the meet begins.
- In all events where preliminary heats are necessary or in any timed final event for which the swimmer has been positively checked in, after the heats have been seeded, any swimmer who fails to compete in an individual event heat in which such swimmer entered and has not been scratched in will be barred from all further individual and relay events of that day. The application of this penalty shall pertain to the order in which the event/heats are swum, not the numerical order of the events. Additionally, that swimmer shall not be seeded in any individual events on succeeding days unless that swimmer declares an intent to swim prior to the close of the scratch box for that day's events. As an alternative, the swimmer may elect to pay a fine of \$100 for immediate reinstatement in the meet, to be split between New England Swimming and the meet host. The Meet Referee has the discretion to waive the penalty in the case of illness, injury, and/or other circumstances beyond the control of the swimmer.

MEET MOBILE HEAT SHEETS: Meet Mobile heat sheets will be offered at this meet free of charge. The Meet Mobile heat sheet includes smart phone access to all heat sheets for the whole meet, including last minute changes and re-seeds. WARM-UP USA-Swimming warm-up policies will be in effect for the meet. Diving will be prohibited during warm-ups in the warm-up/down pool at all times during the meet. LEGAL SPLITS	Individual Events: Preferably, Legal Splits should be requested before the event, by a coach, using a Legal Split Form (available from the Control Table), and the requesting party should supply an additional timer(s) on the lane for the split, if necessary, to ensure an accurate time (one timer with touchpad timing, three timers without touchpad timing). Timers must be positioned over the lane at the end of the racing course. Optionally, a Legal Split may be requested after the event using a Legal Split Form when using a fully automatic timing system. RULES	 The current USA Swimming Rules and Regulations including the Minor Athlete Abuse Protection Policy (MAAPP 2.0) will govern this meet. Operation of a DRONE, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present without written USAS approval. Use of audio or visual recording devices, including cell phones, is not permitted in changing areas, rest rooms or locker rooms. In addition, photography behind the blocks is not permitted. All NO CAMERA ZONES will be clearly designated. Email the Meet Director with questions and requests. VIDEO STREAMING: All video streaming must be approved in advance by the Meet Director. Any such video stream must conform to all current SafeSport policies defined by USAS, NES, and the Meet Host. No video stream may originate from behind the starting blocks or from any other area marked as a NO CAMERA ZONE. Deck Changing is PROHIBITED. An athlete suspected of sustaining a concussion or exhibiting signs of a concussion, will immediately be removed from competition and shall not return to competition that day. The athlete may return to competition on a subsequent day, but only with a release authorization signed by a licensed healthcare provider. 						

According to NES Best Practices, all athletes should shower before entering the pool. In accordance with NES Policy, only those coaches who have current, valid USAS credentials will be permitted to act in a coaching capacity at this meet. Coaches with expired or non-current credentials will be required to leave the deck area. SAFETY No shaving is permitted at the competition site. No glass containers are permitted within the facility. Swimmers must be under the supervision of a coach. • WARM UP SAFETY:

- O Diving will be prohibited during warm-ups except in specifically announced one-way sprint lanes. There will be no diving in the warm-up and warm-down areas at any time.
- For all warm-up sessions, swimmers must utilize a "sit-and-slide" / "three-point" entry to enter the pool for warm-ups, by first sitting on the deck, and then sliding, feet-first, into the pool.
- O In extraordinary cases, due to bulkheads and other pool designs, it may be determined that it is unsafe or impossible for swimmers to perform the required sit and slide entry. In such extremely rare cases, the sit and slide rule may be modified. Exceptions to the sit and slide rule shall only be made when performing the sit and slide entry poses risk of injury to swimmers and/or risk damaging or ripping of swimsuits. An exception to the sit and slide rule shall only be made when the Safety Monitor, Meet Director, and Meet Referee have evaluated the risks and unanimously determined that the use of the sit and slide entry poses such great risk as to be unsafe. In these cases, the Safety Monitor, Meet Director, and Meet Referee must determine and agree upon an alternative safety plan to ensure swimmer safety.

SAFE SPORT

- The USA Swimming SafeSport program is USAS's comprehensive abuse prevention program
 dedicated to creating a healthy and positive environment free from abuse for all its members.
 Components of the program include, but are not limited to, providing education and training,
 enforcing policies (such as the <u>Minor Athlete Abuse Prevention Policy</u>), rules and best practice
 guidelines, promoting healthy boundaries and mandatory reporting of violations.

CHANGES TO MEET	Once a meet is sanctioned, changes can be made to the Meet Information before the meet only with the approval of the Co-Technical Chairs, Patrick Johnstone and Greeg Gowern . Any change to the Meet Format after the meet begins will be at the discretion of the Meet Referee and will be presented to the coaches at a coaches meeting.
WEATHER/ FACILITY PROTOCOL	If weather or facility conditions make it impossible to follow the original timeline of events, the Meet Director and Meet Referee have a right to make changes to the meet sessions. The Meet Director will notify the teams of the changes with as much notice as possible. Cancellation of the meet, or a session, is the decision of the Meet Director, Meet Referee, and the Meet Jury.
MEET JURY	The Meet Jury will be made up of one official, one coach, and one athlete to be selected by the Meet Referee who will present issues and moderate the Meet Jury but not vote. When possible, the three members shall be from separate teams. The Meet Jury will decide all issues of eligibility, and anything not addressed in the Meet Announcement. The Meet Referee shall have authority as described in the current USA Swimming Rulebook.
DECK ACCESS	Only current USA Swimming registered athletes, coaches, officials, and official meet staff are permitted on the pool deck. All non-athletes on the pool deck must produce proof of their valid USA Swimming registration when asked. Individuals without proof of a valid membership in USA Swimming will be removed from the pool deck and will be fined by New England Swimming of \$100 to the coach, and \$200 to the coach's club.
	Credentials for coaches that will serve as deck passes for this event shall be issued to those coaches listed on each team's deck pass request list. These deck credentials are issued according to the below schedule, based upon the total number of participating athletes.
