- 1. June meeting minutes were previously approved and posted to Team Unify
- 2. Coach's Update (Sharon)
 - a. Long Course going well this season
 - i. Silver/Bronze Championships held 7/15-7/17. Several swimmers achieved JO cuts at Silver/Bronze
 - ii. LC Junior Olympics and LC Nationals begin July 28th There are approximately 12 JO swimmers competing and 8 National swimmers
 - iii. Last day of LC practice is July 27th
 - b. The Team is mostly complete for the 2016-2017 season
 - i. Only a few try-outs left for kids who could not attend either group try-out date
 - ii. Majority of kids who tried out know if they were placed on the team
 - iii. Majority of kids who tried out were 8 and unders
 - iv. Waiting on just a few team members from last year to recommit
 - v. Within the next week or two, all tryouts will be completed and practice group placement will be sent to the entire team
 - vi. Email went out July 5th regarding bank draft for payments. First 2 payments will be the same for all swimmers. Payments 3 and 4 will be different based on your practice group placement. 1st draft payment will August 10th
