PAC Meeting 2/25/19

1. Coach's Update

- a) We are progressing well through the championship season.
 - a. Over 60 swimmers went to Bronze championship and took five first place finishes in individual events as well as one in a relay (see Team Unify News for full details)
 - b. The Silver Championship had double the amount of state time cuts by swimmers compared to last year
 - c. We finished 10th place at 12 & Under States in Toms River with a few less swimmers compared to last year but in spite of that had many personal best times, top 16 places and 8 new zones cuts. Claire Logan made a national cut in the 50 free and a meet record in the 100 free
- b) Upcoming meets are 13 & Over States from March 7-10 for ~30 swimmers and 14 & Under JO's on March 22-24 with two USA meets at BAC in March as well (13 & Over and Senior Champs) followed by Zones and Nationals in early April
- c) Information regarding the revised Spring Swim Program has been posted to the Team Unify site and was discussed at a Parent Meeting held at the end of February. The new program was developed based upon a competitive review of programs offered by other local YMCAs as well as club teams. Please direct any questions on the spring & long course program to Coach Chris by calling the YMCA office or through email. Note: we are holding a spring try out in March for Narwhal's, Angelfish, and all new swimmers
- d) Coach Chris is working to offer Water Polo clinics and a Triathlon program (with Coach Will Smith of Flyers); more to follow soon
- e) Awards/ribbons were recently received and will be distributed in swimmer mailboxes. PAC discussed offering assistance in future with this aspect of the program
- f) Coach Chris is expecting to hire a full time Head Age Group Coach (the role filled by Coach Chris last year) in the near future. When this is finalized, he will communicate to the parents
- g) The team plans to host a spring meet at home for the Narwhal's and Angelfish swimmers to help them obtain times. More information to be sent shortly
