#### 1. Coach's Update

- a) The winter season ended with good performances at both states and nationals with many individual and relay records being set/re-set (refer to Team Unify for details)
- b) Currently in the 7<sup>th</sup> week of the spring season with all progressing well. 2019 Spring enrollment increased from 82 to 160 swimmers. Swim and dry land practice attendance across all groups steady which should bode well for a solid start to the fall season
- c) Jackie Whitty will rejoin the Devilfish staff as the Assistant Director of Competitive Aquatics, effective April 29
- d) Summer Long Course practice information was distributed; both Memorial and Mountainside pools will be used which will provide for more adequate facilities for the swimmers. Long course summer meets are being added to Team Unify
- e) Try outs were held earlier in the spring and ~10 new swimmers were added to the roster. Summer try outs will still be held as usual (see Team Unify for details)
