1. Coach's Update

- c. All swim meets will be posted on Team Unify for the entire year a new approach permitting better planning and communication. Some meets have been listed as a backup if we do not get into our preferred choice. The team will be going to a few extra meets prior to the Long Island meet held in mid-December with the intention of having more swimmers obtain qualifying cuts
- d. For long distance swimmers, we are planning to participate in a Distance Derby Swim Event to provide more opportunities for swimmers to obtain cuts for championship meets

4. Fundraising (Crall)

- a. Devilfish Towel sale went very well; 132 towels sold by September 10 with ~\$650 earned thus far

5. DFC (Riordan)

- d. Actively recruiting new officials to ensure that we have proper coverage for dual meets; a letter has been sent via email to all parents of swimmers which netted 7 parents expressing interest in becoming an official with 3 already registered for a class
- e. Working on plans to host at least a Level 1 class (and Level 2 if possible) at the YMCA
