Rules: U.I.L. and National Federation Rules will govern the meet.

Team Eligibility: Each school entered must have a coach/sponsor who is a current TISCA member. Membership information can be found at: http://www.tiscaonline.org. Please complete membership application process by November 27, 2024.

Scoring: Individual Events: 20,19,18,15,14,13,12,11,10,8,6,5,4,3,2,1 Relay Events: 40,38,36,30,28,26,24,22,20,16,12,10,8,6,4,2

Awards: Team awards will be given to the top two (2) girls teams and the top two (2) boys teams. There will be an awards presentation for the top two teams at the conclusion of the meet.

Custom Medals will be awarded to first, second, and third place in individual and relay events. Ribbons will be awarded to 4th through 8th place in individual and relay events.

Entries: Each athlete may enter a maximum of four (4) events, no more than two (2) may be individual events (diving counts as an individual event). Each team may enter an unlimited number of entries in each event, provided the time standard is met. Do not enter JV teams.

COACHES: PLEASE ADHERE TO TIME. All entries are subject to proof-of- time. The only acceptable sources for proving times are: USA Swimming National SWIMS Database or Specific Team manager Proof-of-Time Reports. In cases where a swimmer's time does not meet the qualifying standard and the proof-of-time verification process fails to prove the time was achieved at one point, the athlete will be disqualified from the remainder of the meet and entry fees due will not be adjusted.

Qualifying Times and Proof-of-Time Clarification: Individual swimmers and relay teams may enter this meet ONLY if they have at some time achieved the qualifying time listed in the Order of Events on page four (4) for each event entered. There are no "free" or "bonus" events. Swimmers who enter into and/or compete in events for which they have not achieved the qualifying time are therefore ineligible for further competition, unless coach produces proof-of-time document(s).

Entry Procedure: Swimming/Diving: Enter your team with Team Manager. Event file will be posted on the TISCA website by September 1, 2025. Send entries to: Barry Ray rayb@cfbisd.edu. Be sure to include your diving entries.

TISCA Hy-Tek directives Use version 8.0 of Team Manager. Update your software often to insure compatibility. Use the official UIL Team Code (see UIL or TISCA website). Use the numeric grade level (09, 10, 11, 12) for each swimmer/diver. Use the school name as the "short name". Do not use a mascot name or shortened name.

Dive Sheets: Dive Coach: Amanda Poland polanda@cfbisd.edu. Use CleanEntries for submitting dive sheets. Dive sheets are due December 3rd. See Dive Sheet Instructions.

Entry Fees: \$30.00 per individual

Do not pay entry fees prior to the meet. You will receive an invoice in your packet at the meet; pay your teams entry fees from the invoice included in the coaches' team packet. Team Packets will be available upon entry downstairs at Clerk of Course.

Entry Deadline: Entries (Swimming & Diving, including Dive Sheets) must be received by 11:59pm Tuesday, December 9, 2025. ABSOLUTELY NO EXCEPTIONS.

A psych sheet will be emailed to participating schools by 12 pm Wednesday, December 10, 25. Please check your entries for errors. E-mail any time corrections and scratches to Barry Ray (rayb@cfbisd.edu) by 05:00pm on Wednesday, December 10, 2025. No additions can be accepted past the deadline. A warm-up schedule for prelims and seating assignments will be e-mailed by Wednesday, December 10th.
