The meet host will not add them manually. \*\* Athletes 18 and over who wish for their times to be in the USA swimming database, must have completed their APT prior to the start of the meet.

**Scratches:** 

It is the responsibility of the coach making the scratch to notify the coach of the first alternate, and the Region Meet Director of their intention to scratch an individual or relay. It is the responsibility of the coach of the alternate to notify the Region Meet Director their intention to compete or not compete.

Scratches received after the deadline will be considered DFS and will count toward the athlete's maximum number of events.

Diving Entries: MUST BE RECEIVED BY Monday February 3, 2025, at 11:00am

Each diving contestant shall submit a diving score sheet with the swim entries, due immediately following your district meet. Email dive sheets to Sherry McGuire: <a href="mcguires@lisd.net">mcguires@lisd.net</a>. The dive sheet must include the diver's and coach's signature, the dive number, written description, positions, degree of difficulty, and the order in which the dives will be done in all levels of competitions, prelims through finals. The dive number and position shall be the official description of the dive and shall take precedence. Coaches who have a diver competing and are certified judges, may be asked to judge the event.

ALL DIVERS MUST BE LISTED ON HY-TEK entry file

To film on the deck for All American Consideration you must email Sherry McGuire: <a href="mcguires@lisd.net">mcguires@lisd.net</a> for a film pass onto the deck.

**Entry Limit:** 

Each individual may compete in a maximum of four events, no more than two of which may be individual events. In relay events, <u>eight individuals may be listed on the entry card with any four assigned to swim</u>. This will count as an entry for each person listed only if they swim in prelims or finals. Of the eight swimmers listed, different swimmers may swim at each level (District, Region, State), send roster file.

**Entry Fee:** 

\$20.00 for every athlete entered in the meet and \$20.00 per relay team. Relay only swimmers and alternates will be charged.

**Rules:** 2024-25 National Federation Rules shall govern the meet, along with University Interscholastic

League Rules and Regulations.

**Scoring:** The fastest 16 swimmers in each individual and relay event will qualify for the Consolation and

Championship Finals on Saturday February 8, 2025.

Points will be awarded as follows.

Individual: 20 17 16 15 14 13 12 11 9 7 6 5 4 3 2 1 Relay: 40 34 32 30 28 26 24 22 18 14 12 10 8 6 4 2

**Awards:** Medals will be awarded for first through third place in each event. Ribbons will be awards to

fourth through eighth place. First through eighth place finishers in finals will be recognized during the scheduled awards breaks. The coach of the first-place finisher will hand out medals and

ribbons.

Female and Male Swimmer of the Meet will be determined by NISCA Power Points.

Female and Male Divers of the meet will go to the first-place finishers in the diving competition. Coach of the meet for female and male swimming will be voted on by the head coaches at the meet. Ballots must be turned in by the start of the 400 Freestyle Relays during Finals.

Female and Male Diving Coaches of the meet will be awarded to the coach of the first-place

female and male.

Trophies will be awarded to the girls' and the boys' team champions and runner's up.

**State Meet:** The top 2 in each swimming event will automatically qualify for the UIL State Championship

Meet. Also, the next eight swimmers with the best final time from the eight regional meets throughout the state will advance to the state championships. In diving events, the top three

finishers will automatically advance to the State Championship meet.

**Timers:** Each district is required to provide 8 timers during the meet. Each district may decide how to

divide their timers.

Districts 7-6A and 8-6A will provide timers for Prelims on Friday February 7, 2025. Districts 5-6A and 6-6A will provide timers for Finals Saturday February 8, 2025.

Officials: All officials are required to attend the officials' meeting one hour prior to the start of each session.

This meeting will review and clarify any rules necessary as well as answer questions. The

uniform for Prelims will be white Polo over khaki shorts/pants/skirt. Finals will be navy polo over khaki pants/skirt. No shorts at finals. All questions regarding officials should be directed to Chuck
