Facilities: One 8 lane 25-yard Competition Course. Colorado Timing System 6 Full matrix full color LED scoreboard. Spectator seating for 300+, deck seating for swimmers. **Swimmers will not be allowed to have chairs on the deck.**

USA Swimming:

This meet will be USA observed. Your swimmers must be current USA members and have their USA membership numbers listed with their entries for the times to count.

Schedule:Swimming January 17th

Warm up groups will be assigned next week.

Doors open for swimmers at: 8:00am

Warm - up 1 8:30 - 8:50

Warm – up 2 8:50 – 9:10

One Way Starts 9:15

Meet Start 9:30 am

Rules: U.I.L. and National Federation Rules will govern the meet.

Scoring: Individual Events: 9-7-6-5-4-3-2-1

Relay Events: 18-14-12-10-8-6-4-2

Awards: Team awards will be given to the girls' team champion, runner-up and 3rd place.

Also, boys' team champion, runner-up and 3rd place.

Medals will be awarded to first, second, and third place in each individual and relay event.

Ribbons will be awarded to fourth, fifth, and sixth place in each individual and relay event.

Entries: Each contestant may enter a maximum of four (4) events. No more than two (2) may be individual events (diving counts as an individual event). Each team may have up to four (4) individuals and one (1) relay in each event.

All Swimming will be due to the Meet Director Morgan Peele (Mpeele@healthywiseco.org) by Thursday, January 15th, 2026, by 12:00PM. Morgan will then send each coach an entry report for his or her team only. Coaches will have until 10:00 AM Friday, January 16th, 2026 to make any changes. After 10:00 AM on 1/16/26, entries are final and only scratches will be accepted.

Entry Fees: \$20.00 per individual event, \$40.00 per relay. Do NOT send entry fees prior to the meet. You will receive an invoice in your packet at the meet. Pay from the invoice. There is no recalculation of entry fees for scratches.

The awards cost is around \$1200. We will divide this cost with all the teams based on how many swimmers the team has entered for the meet.

Team Manager: Enter your team with Team Manager. Event file will be emailed to each coach. Coaches, please follow the directives listed below when submitting your district entries, as that database will follow your team and athletes all the way to the State Meet.

- For Team Abbr., use the official UIL Team Code.
- Use the numeric grade level (09, 10, 11, 12) for each athlete.
- Use the School Name as listed on the UIL alignment page
- Do not use a mascot name or shortened name.
