Fee Descriptions:

- <u>Program Fee</u>: This fee pays for coaches' salaries, trainings, coaches' expenses (when traveling with team), pool rental and general overhead costs associated with the program. The program fee must be paid in full, even if my child starts the season late (after October of the current season) or ends the season early (before February of the current season).
- <u>Booster Fee</u>: This fee supports the Miami County YMCA Swim Team Booster's Club account. Any expenses incurred for home meets, officials' training, team website management, banquets, fun nights, etc. are pulled from this account.
- Meet Fee: Meet fees are the fees incurred by each swimmer for each event he/she attends at a meet as well as additional surcharges from the host team/facility. Meet fees are held in an escrow account in the YMCA's program management software and the account must have a positive balance in order for a swimmer to attend a meet. Payments into the escrow account can made in increments throughout the season as needed. Prior to each meet, the Miami County YMCA pulls these fees from each MCY swimmer's escrow account sends them directly to the host team/facility. When attending a meet, every event your swimmer enters, including relays, is charged an additional fee. These fees are usually \$4.50 \$5.50 per event so please keep this in mind when entering meets throughout the season. Once sent to the host team/facility, meet fees are nonrefundable.
- <u>National Fee</u>: If your swimmer achieves a national cut and you choose to allow your child to participate in the national swim meet, an additional \$100 fee will be applied to your child's account. This fee helps cover a portion of the additional expenses the Miami County YMCA incurs through coaches' fees and expenses pertaining to the national swim meet.
