Meet Fees will be billed in addition to program fees, as your child attends meets. This is an escrow account that is held in the Miami County YMCA's Daxko payment system and must be in the positive to attend meets. This account may be broken down into payments, as needed throughout the season, or you may pay by each meet your swimmer attends, add up the fees and pay as you go. When attending an Invitational, every event your swimmer enters is an additional charge, usually \$4.50 - \$5.50 per individual event AND relay so please keep this in mind when entering meets throughout the season. **If meet fees are more than 30 days past due, a \$50 late charge fee will be applied to your account and your saved method of payment will be manually charged for these outstanding fees.**

**\*\*If you fail to provide us with a saved method of payment or provide us with a method of payment that will expire during the swim team season, your child will not be eligible to participate in practices, meets or register for the team.\*\***

**NOTE:** If your child achieves a national cut and attends Nationals, an additional \$100 fee will be applied to your account. See description of what each fee pays for below.

What each fee pays for:

Program Fee: This fee pays for coaches' salaries, trainings, coaches' expenses (when traveling with team), pool rental and general overhead costs associated with the program.

Dryland Practice Fee: this fee pays for reserved space in the UVMC Premier Health Branch for dryland practices and a youth trainer/sports enhancement trainer provided by the YMCA at the time of this scheduled practice. **\*\*Trainer not always guaranteed for every practice.\*\***

Booster Fee: This fee pays into the Miami County YMCA swim team booster account. Any expenses incurred for home meets, officials' training, team website management, banquets, fun nights, etc. are pulled from this account.

Meet Fee: Meet fees are the fees incurred by each swimmer for each event he/she attends at a meet as well as additional surcharges from the host team/facility. *The Miami County YMCA pays these fees directly to the host team/facility and charges our swimmers for their events **AFTER** payment has been made.* This is why meet escrow accounts need to be kept in the positive.

National Fee: If your swimmer achieves a national cut, the national fee helps cover a portion of the additional expenses the Miami County YMCA accrues through coaches' fees and expenses.
