

## Online Registration Agreements

During your online registration, you will read through five pages with terms and conditions that require your acknowledgement in order to advance forward through the pages to successfully complete your online registration. Please ensure that you read these agreements carefully and that you fully understand and agree to the terms and conditions on each page. ### Terms of Registration

I understand that in order for my registration to be accepted and for my diver(s) to be approved to begin attending practice that:

- All fees from previous seasons must be paid in full
- My registration paperwork must be both completed and received by July 25
- My non-refundable membership fee must be paid online and received by the OSDC office by July 25.
- My payment for the season or the first of ten installments must be paid and received on or before noon on September 5

### Financial Acknowledgement

Prior to joining the club, it is important to be aware of the cost of participation and to ensure that it fits within your family's financial plan.

### **Other Fees**

All fees for additional items such as embroidery, shirts, etc.(regardless of payment plan) are due at the time of the transaction.

## **Payment Information**

Payments should be made by credit/debit card through our online payment portal by visiting our website and clicking "Fees & Payments" and "[Make a Payment](#)". If you are unable to pay by credit/debit card, contact [BAABilling@osu.edu](mailto:BAABilling@osu.edu) to discuss an alternative payment option. For security reasons we do not accept cash payments.

**The following guidelines will be followed for payments *received* after the 15<sup>th</sup> of the month:**

- Late fees assessed on the 16<sup>th</sup> of the month: A \$10 late fee will be auto-assessed to accounts without a zero balance on the 16<sup>th</sup> of the month. Payment of the late fee should be included with the late payment.
- Suspension from participation: If your payment has not been received by the 17th of the month, your diver will be suspended from practice, other club activities, and may be restricted from meet registration until the outstanding balance has been received.
- If you are experiencing a financial hardship, it is imperative that you make us aware of your situation by emailing [BAABilling@osu.edu](mailto:BAABilling@osu.edu) *before* you miss a payment so that we may discuss a potential payment plan. University guidelines require that we submit accounts to collections when they fall 60 days behind in payment unless a special financial arrangement has been approved.

In accepting the Terms and Conditions on this page, I acknowledge that I have read the above fees and declare my understanding that:

1. I am enrolling my diver(s) in the Ohio State Diving Club (OSDC), a year-round competitive diving team that runs from September 2017 through late-July/early-August 2018 (depending on dates of final competition).
2. My non-refundable deposit (\$345 per diver) is due with online registration and registration paperwork.
3. My registration will not be accepted if I have any unresolved payment or other issues from previous seasons or if any needed registration items are incomplete or missing. Registrations will only be accepted while there is room in the program.
4. My payment of the annual training fees, or the first payment of the installment plan, is due by September 5, 2017, and that if my payment is not *received* by the due date then I may lose my spot on the team.
5. My diver(s) will be assigned to the training group(s) that the coaches feel will best fit my diver(s) and the program.
6. Late fees will accumulate at a rate of \$10 per month beginning immediately after the due date and my diver(s) will not be permitted to participate until fees are paid (this includes meets and team activities).
7. There is a \$30 NSF fee for all returned checks or failed bank withdrawals.
8. If payments are consistently late, we reserve the right to remove the account holder from the 10-payment plan and assess the remainder of the season's fees in one lump sum.
9. University guidelines require that we submit accounts to collections when they fall 60 days behind in payment unless a special financial arrangement has been approved (in writing).
10. **By enrolling in the OSDC, I understand that I am financially obligated to pay the total balance of my training fees as scheduled for the 2017-18 competitive training year (regardless of my diver(s) attendance at practice), as well as any other costs which I incur. I do NOT have the option to discontinue my financial obligation midway through the year.**
11. Payment of the first month's training fee (or the annual fee), and the agreement to the Terms and Conditions on this page, confirms my intent to enroll my diver(s) in the program for the 2017-18 competitive training year and binds me to the financial commitment outlined.

## **Release Form**

Because participation in the Ohio State Diving Club (OSDC) involves physical activity with risk of personal injury or damage to property, it is the policy of The Ohio State University to require participants to agree to the Terms and Conditions of this Release Form.

1. In consideration of and as a condition of being granted the opportunity to participate in this voluntary activity, I do hereby release and forever discharge all trustees, officers, employees and agents of The Ohio State University who arranged, advised, or supervised any function of this activity for myself and my heirs, executors,

administrators, and assigns from all claims demands, actions, and causes of action for personal injury or any other damage now existing or which may arise out of or be in any way related to their negligence or other conduct associated with this activity.

2. I do hereby also agree to acquire - prior to participation in this activity and maintain in force during the period in which the participant will be engaged in this activity - a policy of health and accident insurance covering hospitalization and treatment for any injuries sustained as a result of such activity. Such insurance shall be through an insurance company authorized and licensed to do business within the State of Ohio and shall provide coverage sufficient for the risks presented by this activity.
3. I do hereby grant permission for OSDC and those acting pursuant to its authority to record, use, exhibit, and/or distribute video, photographic, digital, or electronic images of the participant without compensation for any purpose, which OSDC deems appropriate, including promotional or advertising efforts.
4. Registration for the OSDC entitles the registered participant access to certain Department of Recreational Sports facilities during the set program schedule. Family members may accompany the participant for the purpose of watching during the program's scheduled practice time. This registration does not extend any membership privileges to the Department of Recreational Sports' facilities for the participant or family members. Non-member participants deemed in violation of this policy may be removed from the program and refused further registration.
