

Board of Directors Meeting Minutes Newport Swim Team January 11, 2023

1) Welcome

- a) Called to order by President Kasey Postlewait at 5:35 pm.
- b) In attendance: Kasey Postlewait, John Wray, Randy Moore, Randi Weisz, Anneke Brown, Dani Williams, Anastasia Kaldy.
- c) Not in attendance: Mike Perucci, Kacey Baxter, Shayna Swanson.

2) Secretary Report

a) November meeting minutes – Approved.

3) Treasurer Report / Registrar Report

- a) Account balance- Checking: \$26,114.32 Money Market: \$25,005.14 Approved. Money Market account is accruing interest.
- b) Profit Loss Reports Comparison I: Report from September 1, 2022 to January 11, 2023 (Current season start to current day) compared to September 1, 2021 to January 11, 2022 (Last year season start to last year same day as current).
 - i) Coach Travel Income Higher because the team has doubled since last year. More swimmers attending meets.
 - ii) Pool Fees Raised approximately \$500.
 - iii) Fundraising Income Approximately \$3000 higher than the report shows, because some money was received prior to September 1, 2022.
 - iv) Coach Payroll In line with last year. Watching this number with addition of new coach.
 - v) Taxes Number was expected to grow.
 - vi) Coach Travel Expense Lower due to attention of expenses by coaches (i.e. hotel costs). More single day meets.
 - vii) Net Income In the positive.
- c) Profit Loss Reports Comparison II: Report from November 1, 2022 to January 11, 2023 (Start of new coach hire to current day) compared to November 1, 2021 to January 11, 2022 (Last season same duration).
 - i) Coach Payroll Approximately \$700 higher. Shayna added to payroll, John voluntarily reduced to half pay.

4) Fundraising Report

- a) Thank you, Acorn Studios! Sale of photos + Intel match = \$517.34.
- b) Basket for Boosters earned \$650! NST is the only youth sport involved with boosters in the fall. Some swimmers (Ivan, Jay, Jahan, Illona, etc.) have joined the meetings.
- c) Swim a Thon scheduled for April 8 and kick off February 15.
- d) Yummy Bowl Dine Out will be scheduled for February 15 to coincide with Swim a Thon kick off. Proceeds will be 20-30% of income sales for the entire day. Includes dine in, take out, delivery, and Door Dash!
- e) Two custom towel designs were presented. One was chosen.
 - i) Post meeting update: Total cost for 50 towels is \$889. Includes a bulk discount, design fee, and free shipping. Team purchased 1/13/23.

- f) Sponsors have been emailed a link of our thank you FB, photo of their logo on tv screen/banner.
- g) Signed and framed team photos were personally delivered to 19 sponsors.
- h) Spring fundraising May not be necessary if Swim A Thon brings in goal amount of \$18K.

5) Coaches Report

COACHES REPORT / NST BOARD OF DIRECTORS 1/10/23

1. GROUP BREAKDOWN

Note: This is the most swimmers NST has ever had. Approximately 40 swimmers were on the team this time last year. There is possibility that one senior and one gold member will come back to the team, plus interest from 3 high school swimmers joining NST. There are 6 kids in Level 5 swimming lessons, some of which may join the team. As a comparison, Eugene has 600 swimmers, 100 of which are masters, half of the remaining members are from learn to swim program. John is impressed with our small team competing against big teams with success and continuity.

Note: There may be more qualifiers for this event. Relays are back. If some of the 10 & under or 11-14 age groups may extend to this year even if not qualified via invite. They must have B times. Expenses for championship meets will be coming up.

3. MEET SUMMARIES:

Pacific Coast All-Star meet in Snohomish, Washington on January 7-8, 2023. Ilona Weisz took 3rd in the 50 and 200 Free, 4th in the 100 Free and was a member of 4 relays that placed in the top 3. Along with that, she broke 4 11-12 girls NST team records.

Jan 6-8, 12 NST swimmers took part in the CAT SC Open, NST took 9th place. Nine of the NST 12 swimmers scored team points. The team recorded a 63% Personal Best percentage and recorded 18 Top 5 placings, with Sam Postlewait winning the 15 & Over 200 Backstroke and Jahan Eibner winning the 13-14 400 IM and 200 Breaststroke. Kindel Brandenberger, Maddie & Hudson Cline, Ivan Weisz, Jay & Jahan Eibner, Gwynn, William & Sam Postlewait, Layla Bretz, Ana Kaldy, and Ruby Perucci.

- 4. GROUP MOVES COMPLETED FOR JANUARY & FEB. PENDING This is for distribution of swimmer numbers in each group. There is now room in Bronze II for new team members.
- 5. HOODIE REORDER & PERSONALIZED CAPS DISTRIBUTED

6. MEET DIRECTOR & STROKE/TURN JUDGE VOLUNTEERS - Kacey Baxter is in the final evaluation stages to receive her certification to become a stroke/turn judge. There has been no other feedback or interest from others. NST currently has two stroke/turn judges.

7. PENDING AQUATIC CENTER ACTIVITY

- A. New Lane Lines input provided to Keeley. Just for competition. Note: Keely has approved a new set of competitive swim lines which will be kept covered and used only at meets.
- B. Motherboard in scoreboard status Note: Even though display does not work, swim result reports are still generated. More of a nuisance than anything. CO Systems has shortage on chips. Suggestion to buy one used. May not be acceptable for regulations.
 - C. Crack see below
- D. Chlorine substitute program Note: Newport City approved the upgrade to a UV system which reduces the amount of chlorine needed and costs in maintaining the condition of pool water. NST will contribute \$2500 toward this system.
- 8. POOL CLOSED WEEK OF FEB. 20 email from Lincoln City (below). John decided not to move the team to Toledo for this week because of the warm pool temp. Swimmers who will be on taper/trim for championships will be swimming in LC.
- 9. STAYCATION TALKS WITH CAT April or May pending. Note: Possible pool swap for gold/seniors between Newport and Corvallis. Gives the team the opportunity to swim in 25m outdoor pool and 50m indoor pool. Newport pool has become a popular place for other teams to practice. Hillsboro has rented for 2 days, and CAT for 3 days. Will not affect NST practice times. If staycation works out, the team will rent a rent a van and get a hotel for the kids.
- 10. TEAM BOWLING PARTY Note: Will need a parent volunteer to organize this event in January or February at Muggley's. Event is combined with farewell to Coach Tim (below). Post meeting update: Bowling alley has been reserved for Feb 4th. Cost is \$5/person which includes bowling, shoes, pizza, drinks. Board has voted in favor via email for NST to cover a portion of this cost, so bowlers do not have to pay \$14.95 ea., approximately a \$300 savings for participants.
- 11. COACH TIM'S RESIGNATION EFFECTIVE FEB. 9 See resignation letter below. Note: Farewell party will be combined with the team bowling party (above). Tim served for 2.5 seasons.
 - Discussion regarding hiring a new coach. If it is decided a new coach is needed, recruiting and reviewing applications will begin in April so as not to interfere with championships or spring break. Experience will matter. Multiple ideas on strategy and expectations for possible new coach hire.

12. SHAYNA MEET & GREET WITH PARENTS – Event will be combined with Newport VCSL meet on March 11th in the hospitality room. Parents are encouraged to participate. Need parent volunteer to coordinate. More details to come.

Additional discussion during Coach Report:

- Silver has a wide range of swimmer ability. This group has been split into 2 sub-groups. One which needs specific intense stroke work, led by Shayna. Swimmers from this group advance to Tim's group. This level of swimming is a "make or break" where the swimmers have lengthier and more difficult workouts. This prepares them for the next level.
- 3:30 practice start times are difficult for coaches and swimmers. Request to move start time to 4:00 PM has been submitted to the pool manager.
- Rec center is to start opening on Mondays.
- Small bronze groups allow for higher quality swim technique.
- 10 to 12 swimmers in gold is a comfortable number for coaching.
- Next year gold swimmers moving to senior may pose an issue for lane availability.
- John is replacing long wooden pole lap counters with upgraded expandable fiberglass.
- New coach: Shayna has been on deck 2 months. Feedback has mostly been positive. John is impressed with her work ethic, having workouts prepared for practice, immersing herself into the environment, practicing drills herself, and being in-line with his style of coaching with the willingness to adjust as needed. She is currently working on completing two certifications in chemical and management operations for her employment at the rec center in addition to coaching. It takes an average of 9-12 months for a team to transition to a new coach, but having both coaches on the deck eases this adjustment.

- a) Coach travel fee for one day meets Board approved new fees. Swimmers will be charged \$15 for a one-day meet, \$20 for one day of a multi-day meet, and \$30 for attending more than one day of a multi-day meet.

 - ii) President role Note: Kasey Postlewait wants to phase out of this position and train the new member over a year. She will delegate portions of her duties into groups.
