

Kelly expressed concerns with the reduced practice time that all the silver and gold group swimmers were able to get in the first week of June and the minimal communication about it. There are kids in all groups that are trying really hard to be competitive swimmers, like our club promotes. Taking a full week of reduced practice in the middle of long course season is less than ideal and seems like it could have easily been avoided. Also, no gold workout was posted for Saturdays when the Senior group went to Corvallis. NST needs all level swimmers to feel valued and supported to achieve their swimming goals so that we have kids in our community that will participate when it's their turn for the senior group. In the future, when/if week-long scheduling challenges occur, Kelly recommended there be consideration for equitable distribution of cutting practice times amongst all groups, communicating and posting schedule changes and the reasons for them as early as possible and posting group level workouts in lieu of grouping all non-senior group swimmers together.

- Shayna said that Senior swimmers require more regularity in swimming practices and amount of time in the water compared to younger swimmers and this is why she felt the senior group's schedule shouldn't be cut. She said she felt this was the best approach but

would consider these concerns in the future if similar situations arise, including holding Gold practice in Newport with a second coach.
