NST Board Meeting on September 17 2019

Meeting called to order at 5:45 PM

1. Review meeting minutes from annual meeting

a. John Motioned to accept, Andrew seconded, all in favor.

Jennifer Reinhart: Team Day update The jammer will be about \$18 and girls suit \$43. How should we handle the gift certificates? Leftover balance can be on people's account if they didn't fully expend it. We are ordering about 48 suits. Everyone signed a media consent form. John will hold the media consent forms.

- **2. Treasurer Report (Natasha)** Profit and Loss for August, about \$8,500; we have about \$45,000 in bank account We believe that we made about \$5376 on Seahorse. John motioned to approve the treasurer report, Andrew seconded, all in favor.
 - a. Scholarship Review We have 2 scholarship requests and 1 previously approved. We have planned on awarding up to 5 scholarships. Scholarships cover 50% of monthly dues.
 - b. Accountant update Bookkeeper that we were going to hire got in an accident, so Natasha is meeting with another bookkeeper. Natasha will do taxes and payroll and then pass off.

3. Sponsorship/Fundraising Report (Kasey)

- a. Website update Added awards, sponsorship link with forms, added info on the Fred Meyers rewards info; it would be great if we could get a sponsoship from every family, but need to keep track of who we ask so we don't ask multiple times. Grove and Oregon Coast bank will be on the shirts this year as sponsors.

We usually have 2 or 3 families opt out; and we received about \$1300 in billed volunteer hours. John will mention the opt out form in his next update.

5. Registrar Report (Amy Jones) - We have registered 44 people. 40 year round, 2 flex membership, and 2 outreach. Plus coaches and officials (Reinhart and DJ Smith have registered). We believe about 12 swimmers are missing from this list. Some swimmers (3 or 4) bought suits but haven't registered yet because they are doing another sport. John will remind swimmers that they need to be registered to practice.

Kasey said bronze groups seems really large and Kasey asked how many more bronze swimmers could be added. John thinks one could be moved up to bronze 2 soon. We are about at maximum capacity, might be able to move up a few.

MAAPP Update: We have met the minimum requirements. The one issue is whether the board needs to do the on line training, which would involve all board members needing register. We will hold off, since this will probably be discussed at the House of Delegates. We presently have 1 adult athlete and he has completed the training.

Jennifer Reinhart asked John about the WA meet. It is a senior meet with very competitive qualifying times. Jennifer Reinhart asked about where the OSI 11-14 Short Course Championship. OSI says Corvallis, but John's list says Mount Hood. John will double check location for these championship meets.

The shirts could then be worn at Seahorse. We could charge \$2 to 3 per kid to recover cost. Kasey is concerned about cost, with new contracts, costs, etc. Charles would prefer if budget neutral. John mentioned that we could use the t-shirts for Newport Open. Aaron motioned to have the

shirts printed, John seconded. All in favor. They will be printed the same as our team shirts, with this years logo on front and back.

Kasey brought up that Connie had mentioned needing some supplies (e.g, paddles), John has scaled back a bit, about \$60.
