- 1. Welcome-call meeting to order meeting was called to order by Kasey at 5:30pm.
- 2. Secretary Report

 - c. All unfulfilled volunteer hours for the 2020-2021 season will be forgiven.

- 7. Coaches Report
 - a. Group breakdown: 14 seniors, 9 gold, 4 silver, 7 Bronze I and 6 Bronze II swimmers, totaling 40 swimmers. Attendance is ranging between 74-77%.
 - b. Practice Changes: Restrictions have been lifted. Back to using locker rooms, using main entrance every day except Monday, when lifeguards letting the kids in. Front desk of rec. center has requested a roster and want kids to identify as NST. John will follow up with the rec center. This wasn't a problem pre-covid and there are three weeks of the season remaining.

 - iii. Seahorse/July 31-Aug 1 Currently 24 registered. Teams invited are Forest Grove, ECSC, Blue Dolphins & Hood River.
 - d. Recent meet summary: Corvallis, TEAM Eugene and HS Champs. To-date 11 team records, improvement rate in the low 80%, great team unity and the kids want to race.
 - e. Coaching update: Next week is Jenna's last day. Maria Pettis is shadowing to coach.
 - f. MAAPP 2.0 must be in place by Sept. 1, 2021. John motion to approve the new MAAPP Policy, Cheryl seconded and the policy was approved.
 - g. Proposed 21-22 coaching season:

- 8. Meet Director Report: Travis reports a positive working experience with Keeley. Rec Center is closed on Sunday, and we will have to pay for building attend and someone to sit at the counter during Seahorse. The cost is \$350. Special permits have been turned in; Travis has not heard back. The meet is sanctioned and posted on Oregon swimming. Quilters have cancelled their show.
