NST Meeting Minutes July 17, 2018

- 1. Approve meeting minutes from April & June

- 4. Coach's Report (John)
 - a. Our roster is at 46; lost one family but they will be back in Sept; and another family on break for Sept but will be back in Sept; 2 new bronze swimmers
 - b. The kids swam great at Team Eugene Summer as well as at the OSI 10 & Under LC Championships. New team records and aged up A & B times. Upcoming meets: 11& Over LCM Championships (10 qualifiers and 3 relays). Layla is closest to Age Group Zones. Age Group Zones is the same weekend as Seahorse.
 - c. Seahorse: 36 registered; plus probably 3 more will register.
 - d. One swimmer who has only done 3 practices, so John is going to remove that swimmer from Seahorse.
 - e. John drafted an assistant coach contract: he will provide to the board.
 - f. Stroke School: Jenna is doing a great job, yesterday John handed out a flyer to 8 swimmers; he also translated into spanish and printed the back in spanish. Jenna at Friday lesson, they will tryout for the swim team. There were a number of parents that expressed interest. John said for them to wait until Sept to join.
 - g. LCSC-NST Dual meet on Aug 1 in Lincoln City. Connie and Jenna will be deck coaches. Will be done by 5:30 pm
