## Minutes from TAC Board Meeting August 4, 2021

(To begin with, let me apologize that this is not an entirely complete record of this meeting. Our Secretary was not in attendance.)

#### Rob –Executive Director of FPFC

He has asked that a Representative from TAC Board attend the next FPFC Commissioners' Meeting on 8/19/21. Silvy would like to go but is scheduled to work but has a call into a coworker to see if she can switch work days. If Silvy is unable to attend, Tish will attend meeting. Rob presented the Board the idea of having TAC be a "Pool Owned Competition Team" or be a "Club-Owned Competition Team". Both Coaches would like TAC to become a fully "Pool-Owned Team". If this happens, TAC's Fundraising money can now be used for more social gatherings, food for coaches/officials at Meets, Dues Scholarships, College Scholarships, etc. After 8/19/21, we will have a final decision on this matter.
