# 2025-2026 Machine Aquatics Registration

## General Information

Registration for the 2025–26 season opens for current Machine families the week of May 12, 2025. New families may begin registering in early June.

**Important: New swimmers must attend an evaluation or receive coach approval before registering.**

Registrations after January 1, 2026, will be prorated.

Note: Once registration is completed and approved, it is non-refundable.

## Competitive Program Fees

1. Training Group Fees
2. Annual Registration Fee: \$550 for competitive groups

Returning families who register by Wednesday, June 11, receive a \$100 discount on the registration fee. This fee includes: USA Swimming & Potomac Valley Swimming (PVS) registration and Team Apparel Package.

**Meet Fees are NOT included.**

## Maintenance Program Fees

1. Training Group Fees
2. Annual Registration Fee:
  - \$225 for session-based programs
  - \$130 for the year-round Maintenance program

This fee Includes: USA Swimming & PVS registration and Team Apparel Package

No volunteer fee applies to this program. Meet fees and team suit are not included.

## Volunteer Hours

Running a successful swim meet requires many volunteers. Each family in the Competitive Program pays a \$100 refundable Volunteer Fee. After 22 hours of volunteering (meets, hospitality, parent events, etc.), the fee is refunded. Volunteer hours are tracked in the Team Unify system for easy access.

## Transaction Fees

Two payment options are available:

1. Credit card payments include a 2.85% processing fee.
2. ACH transactions have a \$1.25 processing fee. Checks do not incur a fee.

## Payment Plans

Two payment options are available:

1. PAY in Full
2. Four Installments - Payment Schedule: At Registration: Registration Fee + Volunteer Fee +  $\frac{1}{4}$  Team Dues. Remaining payments are due: August 1, October 1 and December 1.

Sibling Discount: \$150 per additional swimmer

## Apparel Packages

All swimmers receive a gear package with registration. Once your registration is confirmed, you will receive the link to order your apparel for the season through the Machine Gear Store.

### Competitive Groups:

- **New Swimmer:** Team Shirt, Sweatshirt, Team Suit, Cap and Magnet
- **Returning Swimmer:** Team Shirt, Team Suit, Cap, Magnet and bonus item.

**Maintenance Program Swimmer** (New & Returning Maintenance, Tech/Fit & HS Prep Groups): Team Shirt, Sweatshirt, Cap and magnet. A team suit is not provided for these groups.

## Responsibility for Fees

Team registration is non-refundable once approved. Parents are responsible for all program fees, including registration and training fees, for the full season, regardless of participation.

Exceptions: Military relocation or approved medical withdrawal with documentation.

## Refund Policy

Machine Aquatics does not offer refunds for mid-season withdrawals due to advance commitments on pool rentals and coaching. Families are responsible for the entire season's fees, regardless of swimmer participation. Only documented medical withdrawals or military relocations are eligible for exceptions.
