Registration for returning swimmers and families: Monday March 1st, 2022 – Monday March 15, 2022

Registration will open to **new swimmers and families after March 15**th depending on number of spots available, and will be on a first come, first serve basis. If groups are full, swimmers may be placed on a wait list.

Orca Summer Swim Club 'Out of Town Registrations' Policy (revised 2018)

This policy has been created to both preserve the Lethbridge Orcas Summer Swim Club mandate of serving Lethbridge and area and to recognize that families have a choice in the coaching environment that they wish their child/children to participate in.

Club registration for Out of Town Swimmers* will occur at the same time as registration for new Lethbridge swimmers. There will be a grace period of 1 week to allow the registrants to be sorted and processed, at which time any Out of Town Swimmers will be assessed on a CASE BY CASE BASIS** by the Executive. Registrants will be assessed based on club population and group sizes.

*Out of Town Swimmers are applicants who reside outside of the Lethbridge County limits.

**Previously registered Out of Town Swimmers will be classified as 'returning swimmers' and will register on the returning swimmer night and therefore be exempt from any such assessment.

Please note: The Lethbridge Orcas Summer Swim Club reserves the right to refuse admittance to ANY family and further, reserves the right to expel any members not adhering to club rules or displaying behavior detrimental to the club.

Swimmer Classification

A swimmer can be registered in four ways:

Age Group Swimmers – permitted to participate in ASSA sanctioned swim meets in all events except Para-Swimming events; their times are eligible to be considered for race placing and records.

** Swimmers' age as of April 30, 2022 determines the age group entered at all of this seasons swim meets. **

Masters Swimmers – permitted to participate in ASSA sanctioned swim meets in all events except Para-Swimming events; their times are eligible to be considered for race placing and Alberta Masters Swimming Association records.

Para Swimmers – permitted to participate in ASSA sanctioned swim meets in all events, including Para-Swimming events; their times are eligible to be considered for race placing.

Exhibition Swimmers – permitted to participate in ASSA sanctioned swim meets, except the Regional and Provincial Championships, in all events except Para-Swimming events; their times are not eligible to be considered for race placing and/or records.

NOTE: A swimmer will not be allowed to register with Alberta Summer Swim Association (ASSA):

• If they are a member of a Winter Swim Club. To swim as a competitive swimmer with ASSA, they must cease to be a member of a Winter Swim Club for 8 continuous months prior to the start of the new summer season

Lethbridge Summer Swim Club Coaches will group swimmers according to age and swimming ability as follows:

The method of payment will be one lump sum payment for registered swimmer(s) at the time of registration by credit card on Team Unify.

There is a registration fee reduction of \$50.00 for the third and subsequent Mini Orca/Orca swimmer registered per family.

Registration fee includes: Orcas T-shirt, Regional and Provincial Association Fees and Swim Meet Fees.

** Fundraising and volunteer monies are in addition to registration fees, and will be collected

at the start of the swim season**

Lethbridge Orca Parents Volunteer Policy

Purpose: This policy is intended to regulate the volunteer requirements for member families, and to ensure that adequate volunteer support is available to meet the needs of the Swim Club throughout the swim season. This policy will routinely be evaluated by the Board of Directors and may be adjusted throughout the swim season based on need. This policy outlines the minimum volunteer expectations for member families.

Like most youth sport teams, member volunteers are elected to the Board of Directors and oversee the administrative functions of the club. The team relies on member volunteers to assist with day-to-day operations and special events.

A typical two-day swim meet takes over 50 volunteers to run, and that does not include set-up and tear down, or other non-swimming meet activities outside of competition. A commitment from all member families is essential to make the meet or special event run as smooth and as fair as possible. When all families pitch in and help, no one individual or family will be over-burdened. Thank you in advance for your willingness to help make the Orca Swim Club a success!

Volunteer Requirements

Each member family will be required to fulfill a MINUMUM OF 10 HOURS of volunteer hours per family.

- To encourage parents to fulfill our team's responsibility to provide trained ASSA Swimming officials at meets we attend; the Board will ensure opportunities for officials training.
- Volunteer sign up sheets will be available at all volunteer opportunities, please ensure you sign in to have your hours counted.
- Families will need to hand in \$250 volunteer deposit in the form of **cheque** on the first day of swimming, prior to your child entering the pool. This will be handed back at the end of the season if requirement is met.
- Families will need to hand in \$250 fundraising deposit in the form of **cheque** on the first day of swimming. prior to your child entering the pool. This will be handed back at the end of the season if requirement is met.
- If requirement is not met, deposit will be used to pay hired officials, etc. that were secured to ensure events could continue.

-Swim meets- officials, timekeepers, marshalling, hospitality.

-Fundraising- bottle drives, casino, other opportunities.
