The following information should answer any questions you may have about the cost and procedures for admitting new members to our pool.

To join the swim club, you must purchase a bond for \$300.00. This is a one-time fee and makes you an owner of the pool. In the future, when, for whatever reason, you decide to give up your membership to the club, **you will receive a \$250.00 refund when your bond is sold**; this may take a year or two. You may purchase a bond by choosing one of the options listed below:

OPTION 1 – Payment of \$300 in full

OPTION 2 - Payment of \$100 each year for 3 years

OPTION 3 – 1ST Year Trial Membership – No Bond for the first year – You **MUST** become bonded the 2nd year by using one of the options stated above.

The following are the fees for the **2024 season**:

Basic Membership Fee	\$350
(This includes husband & wife or Single head of household)	
Sinking/Maintenance Fee	\$125
Additional Immediate Family Members living within the home	
1 year of age to 21 years of age	\$50 each
Additional Member not residing within the home or over the age of 21	\$175 each
