

JEFFERSON SHELBY SWIM COUNCIL (JSSC)

RULES FOR THE SUMMER SWIM SEASON

SECTION 1: JSSC RULES

- (A) The most current USA Swimming (USAS) rules shall apply in all instances except where they differ from the following Jefferson County Swim Council (JSSC) rules. JSSC rules shall supersede USAS rules in the event of a conflict.
- (B) The Vice President of the Jefferson Shelby Swim Council shall be in charge of all swim meets held under the JSSC Charter. Protests, disputes or questions concerning rules and meet governance shall be emailed to the Vice President.

The Vice President has the authority, upon consultation with the Board of Directors, to determine appropriate action when a JSSC team violates the rules when such violation results in unfair competition, even when no formal complaint has been received. Changes to these rules, except for spelling corrections and formatting improvements from the prior year, are denoted by *italics*. An underlined phrase is of particular importance.

SECTION 2: COMPLAINTS

- (A) Written complaints and/or protests concerning competition may be submitted only by the team delegate or coach. Complaints must be submitted to the Vice President of Rules, or in his/her absence, a member of the Board of Directors, concurrently with a copy to the team named in the complaint. Complaints arising from a specific competition must be submitted within seventy-two (72) hours after the purported rules infraction occurs. Failure to do so will make a complaint invalid. Complaints should be emailed to the Vice President. After submission of a complaint, the President, upon the request of the Vice President, may at the President's discretion convene an Ethics Committee which shall:
 - i. Consider written complaints received by the Vice President.
 - ii. Determine and impose action fitting the violation up to and including forfeiture of the meet during which the incident occurred, suspension of the offending party for an indefinite period or loss of points in the meet in which the incident occurred.
 - iii. Consider written complaints and render a decision within fourteen (14) days from the time the complaint is received.
 - iv. Advise, in writing, both the coach and delegates of teams involved in the complaint of the decision of the Ethics Committee.
 - v. Take action on the decision of the Ethics Committee before the end of that competitive season.
- (B) Any other issue or complaint can be brought to any board member and the board will do its due diligence in investigating the complaint.

SECTION 3: SWIMMER REGISTRATION AND COACHES CERTIFICATION

- (A) Each swimmer must be registered with the Director of Registration by 5:00 pm of the Friday preceding the first JSSC approved meet in which the swimmer intends to participate. No swimmer may register after the date outlined in the schedule of JSSC events. Exceptions may be agreed upon by coaches of all teams competing in the meet.
- (B) Without exception, swimmers must participate in a minimum of two (2) JSSC sponsored meets to be eligible to participate in the Senior County Championship Meet as recognized by the JSSC Board. This rule acknowledges the high priority JSSC places on the team approach to competitive swimming. Local year-round USAS programs offer excellent opportunities for individual competitive swimmers who cannot meet this requirement.

JSSC Registration: The current year registration records for each swimmer shall be maintained by the Director of Registration. There is a JSSC registration fee per child (see appendix for fee). Team is responsible for any unregistered swimmers who participate in JSSC meets after the last registration date.

The Waiver of Liability must be electronically signed and dated for EACH swimmer with the swimmer registration information.

- (C) Certification Requirements

Head Coach: Red Cross First Aid, CPR, and Coaches Safety Training

Assistant Coaches: Coaches Safety Training

In addition, someone on deck must be: Lifeguard Certified

- i. Courses must be completed prior to their work with the children on the deck and in the pool.
 - ii. JSSC coaches are required to submit copies of their certification as proof of attendance at these courses to the Director of Registration electronically.
- (D) At a minimum the head coach of each team and at least one other coach must be fully certified with documents submitted to JSSC by 5:00 pm of the Friday preceding the first JSSC approved meet.
- (E) All JSSC member teams must perform background checks on all coaches (paid and volunteer coaches) at the team's expense. Proof of background checks will be the signature of the club on the Team Waiver. Team waiver must be submitted electronically no later than 5:00 pm on the Friday preceding the first dual meet.
- (F) Swim coach registration and certification is a JSSC requirement intended to enhance the safety of our sport. Failure to conform to these requirements may place the league at risk and jeopardize the safety of our swimmers. Teams who do not have at least one fully certified coach shall be fined for each week of the season or until certification is obtained, whichever is less (see appendix for fee).

SECTION 4: DUAL MEETS

The rules referenced in this section are applicable to all JSSC meets.

- (A) JSSC dual meets (or sometimes “Tri” meets if there are 3 teams competing) shall be scheduled by the Board of Directors and announced at the spring meeting. All registered teams must be able to host a minimum of 2 dual meets and understand that there is a possibility that they will be required to host 3 dual meets. If a team registers with 25 or fewer swimmers or is a new team within the JSSC, all efforts will be made to schedule those teams as visitors in tri-meet formats. However, if a team cannot host any meets, they may be ineligible to register as a team with JSSC. The team must contact the Director of Registration to discuss their situation and the JSSC Board will determine team eligibility.
- (B) Dual Meets shall be open to all swimmers of each club. All swimmers must be registered with the JSSC before the meet. If a swimmer that is unregistered participates in a meet, team is responsible for any unregistered swimmers who participate in JSSC meets after the last registration date.
- (C) The JSSC has a stated policy of non-discrimination. In the event a member of the host team refuses to permit a team access to their facilities, the Board of Directors of JSSC will determine the disciplinary action to be taken against the host team. The Board will consider all salient factors in arriving at a decision. While the Board reserves the right to determine the action, a forfeit by the host team will be considered.
- (D) Dual meets will normally be held on Tuesday evenings. Every effort should be made to begin the meet by 5:00 pm. Pools with insufficient lighting for the pool and deck must suspend competition before dark. In the event the meet is cancelled due to inclement weather or other reason, the following Thursday will be the makeup day of choice. Other makeup dates may be used at the discretion of team delegates and/or coaches.
- (E) If a situation occurs where a club has to cancel a dual meet or participation in a tri-meet, it must give at least 24-hours notice to the other team(s). Failure to abide by this rule or repeated cancellations could result in disciplinary action by the Board of Directors of JSSC. The Board will consider all salient factors in arriving at a decision.
- (F) Host teams are responsible for ensuring proper safety of all equipment including but not limited to lane ropes, starting blocks, pool surface, and deck surface. If there are known safety or availability issues, these should be made known to the visiting team coach as soon as possible and coaches shall decide whether to continue as scheduled, postpone, or relocate to an alternate venue.
- (G) Host teams are responsible for the availability of all equipment, systems, and volunteer coordination as well as ensuring all of these components are ready to proceed at the start of the scheduled meet. If the host team cannot fulfill these responsibilities and did not contact the visiting team coach prior to the meet to make alternate arrangements, the host team may forfeit the meet.

SECTION 5: DUAL MEET EVENTS

- (A) The rules referenced in this section are applicable to all JSSC dual meets. Occasionally JSSC may schedule a triangular meet or “tri-meet”. Except where specifically noted, the rules referenced in this section are also applicable to tri-meets.

- (B) Dual meets shall consist of (but not limited to) the following:

<u>Age Group</u>	<u>Individual Event Distance</u>	<u>Age Group</u>	<u>Relay Event Distance</u>
6 & under	25 yards/meters	6 & under	4 by 25 yards/meters
7 – 8	25 yards/meters	8 & under	4 by 25 yards/meters
9 – 10	50 yards/meters	10 & under	4 by 50 yards/meters
11 – 12	50 yards/meters	12 & under	4 by 50 yards/meters
13 – 14	50 yards/meters	14 & under	4 by 50 yards/meters
15 – 18	50 yards/meters	18 & under	4 by 50 yards/meters

- (C) Events and order of events for each age group:

- i. Girls first within a given stroke, then boys.
- ii. Order of events: Freestyle, Breast, Back, Butterfly, and Relays. If both coaches agree, relays may be swum first.
- iii. During the odd weeks of each season (i.e. Weeks 1, 3, etc.), the Freestyle Relay will be swum.
- iv. During the even weeks of each season (i.e. Weeks 2, 4, etc.), the Medley Relay will be swum.
- v. *During all weeks of the season, the Freestyle Relay will be swum for age group 6 & under (no medley).*
- vi. *For dual meets: only one heat of relays per event will be swum, with each team allotted half of the lanes (i.e. 3 lanes per team for a 6-lane pool; 4 lanes per team for an 8-lane pool). If all allotted lanes are not used by a team, the other team may use them.*

- (D) Changes to events and order of events:

Any event/distance may be added, changed, or modified upon agreement of all head coaches involved and acknowledgement of the Meet Referee.

- (E) **Scoring:**

Dual Meets

Individual Events

5 – first place
3 – second place
1 – third place

Relays

7 – first place
0 – second place

Tri Meets

Individual Events

6 – first place
4 – second place
3 – third place
2 – fourth place
1 – fifth place

Relays

8 – first place
4 – second place
0 – third place

If multiple heats are held in any event, the best times overall will be awarded points as outlined above.

SECTION 6: DUAL MEET ADMINISTRATION

- (A) All home meets in the regular season should be set up by the home team in the prevailing meet management software by May 31st preceding the season.
- (B) Teams must enter their meet entries into the meet management software by 10:00 pm the night prior to the meet unless otherwise agreed by the coaches.

- (C) A final heat sheet for the meet must be emailed to the visiting team's head coach no later than 12 noon the day of the meet. A 20-point penalty will be assessed for each team failing to comply with the punctuality rules prescribed herein. Consequently, the official team score shall be the team points after reduction for the penalty. The Board of Directors has authority to abate the penalty in the event of reasonable cause due to "extreme, unusual, and non-recurring circumstances".
- (D) Substitutions can be made after the list is turned over to the head scorer only if a swimmer is unable to compete in the meet as follows:
- i. Substitutions can be made for swimmers who fail to show up for a meet. If the swimmer arrives late, no substitutions may be made in subsequent events.
 - ii. Late entries may be made only if there is an open lane. The team originally assigned to a particular lane shall have first priority.
- (E) At least thirty (30) minutes warm-up time must be provided, permitting an equal number of the available lanes for each club. This warm-up period must be within one hour of the scheduled starting time of the meet. This warm-up period may be adjusted to 20 minutes per team when hosting a tri-meet. Coaches can agree to waive the warm-up period given extenuating circumstances like weather.
- (F) Swimmers will be permitted to swim a maximum of three (3) individual events and two (2) relays unless the involved coaches mutually agree, in writing, to a larger number. These agreements must be submitted to the Vice President together with the final results. All swimmers must compete in their own age group in individual events.
- (G) Lane assignments shall be as follows:

Dual Meets

Host team – odd numbered lanes (lanes 1,3,5)

Visiting team – even number lanes (lanes 2,4,6)

Tri Meets

Host – lanes 3 & 6

Team A* – lanes 1 & 4

Team B* – lanes 2 & 5

*Team A & B are determined by alphabetical order

All events will be seeded slowest to fastest.

- (H) At least ONE swimmer on each relay must be within the age group of that relay. For instance, for an 18 & under relay, at least one swimmer must be age 15-18 for the relay to be eligible.
- (I) In the event of inclement weather, safety of our swimmers will be the top priority. The host team can decide to delay/cancel the meet based on the host coach's and/or local pool management discretion. Continuation of the meet during questionable conditions shall require mutual agreement by representatives from both teams. Coaches of the teams in the originally scheduled meet can mutually agree on whether or not the meet is made-up, completed, or declared final. A date and time for a makeup meet (or continuation) should be determined and agreed upon at the time the cancellation decision is made. JSSC recommends (no requirement) that the Thursday following the cancellation be reserved for makeup meets. Virtual meet completion is also an option, if mutually agreed upon by coaches.

A meet that is completed through the last heat of the backstroke before cancellation can be considered complete. The meet score shall not include scoring for stroke or relay events that are only partially complete. Example: a meet is cancelled during the boys 9–10 butterfly. The meet should be scored only through the last heat of backstroke.

A meet that is started and interrupted by weather or otherwise, shall be resumed under the following procedures:

- Meet shall not be reseeded. Original seeding shall apply. Late additions (i.e., swimmers not originally entered in the meet) may be added, provided there is room in originally-seeded heats due to open lanes and/or scratches.

Only with the prior approval of all teams involved, a make-up or resumed meet may be conducted with more than the team (s) originally scheduled, however, the meet shall be scored as originally scheduled (unless arranged and approved in advance by all parties involved). Example – Teams A and B were originally scheduled in a dual meet that is postponed or interrupted. Teams A and C were scheduled in a dual meet the following week. Due to time constraints, Teams A, B and C elect to resume the meet together. The meet may be conducted (and scored) as a tri-meet (provided all three teams agree) or may be conducted as a tri-meet but scored as two dual meets (A versus B and A versus C).

SECTION 7: SWIMMERS ELIGIBILITY

- (A) The swimmer must be properly and timely registered in accordance with registration procedures prior to competing in any JSSC sponsored meet.
- (B) No swimmer may compete for more than one JSSC club in one season.
- (C) A swimmer's age as of June 1st of the current year shall determine the correct age group in which to swim.
- (D) If you wish to have your child placed in the age group directly above their legal age group, this request must be submitted in writing to the JSSC Director of Registration at the time of registration. The request will be reviewed by the JSSC Board and approval notification will be given to your coach before the first swim meet. Swimmers granted a swim up request will be required to swim all meets during that season at that age level and may never go back to their legal age group either during the current season or any other season. They must also qualify at the higher age level in order to swim at the JSSC Senior County Meet.
- (E) Before diving from a starting block at a JSSC meet, each swimmer must be certified as safe to use the starting block by the head coach in accordance with USAS requirements. By submitting the team waiver, each team agrees each swimmer diving from a starting block has completed certification. A swimmer must start from the wall in the water until they have been certified as safe pursuant to these rules.

SECTION 8: HOST TEAM AND VISITING TEAM RESPONSIBILITIES

- (A) The host team is responsible for providing the pool.
- (B) The visiting team will provide the following officials. All deck officials must be USAS or JSSC certified.

- One (1) Stroke & Turn Judge (USAS, YMCA Cert., or JSSC Cert.)
- One (1) Place Judge
- (C) The host team will provide the following officials: All deck officials must be USAS or JSSC certified.
 - One (1) Referee (USAS or JSSC Cert.)
 - One (1) Starter (USAS or JSSC Cert.)
 - One (1) Scorer
 - One (1) Clerk of Course
 - One (1) Head Timer
 - One (1) Timer per lane
 - One (1) Place Judge -- Note: Starter or Scorer may serve as Place Judge
 - Two (2) Stroke & Turn Judges (USAS, YMCA Cert., or JSSC Cert.)
 - Two (2) Lifeguards (minimum)
- (D) If a team cannot provide enough workers for the home meet, they can contact the visiting team to help provide workers.
- (E) A coach from a participating team will not be permitted to serve as a meet official.
- (F) All meet workers, with the exception of runners, shall be age twelve (12) or older. A penalty of twenty (20) points per non-complying person will be assessed against the negligent team failing to observe this rule.
- (G) Host team will be responsible for ordering and providing first through sixth place ribbons (or largest number of lanes) and heat winner ribbons or awards. First through sixth place (or largest number of lanes) will not have to have JSSC logo. Team logo is permitted for heat winner awards only. JSSC will provide clubs with an email address or phone number of companies they can order from, if they need assistance with ordering. Teams must use the standard disqualification practice in the prevailing meet management software.
- (H) Ribbons need to be delivered by the host team to the away team(s) by Thursday noon after a meet. This is important so that teams can celebrate swimmer accomplishments in a timely manner.
- (I) All participating teams should be able to produce a list of volunteers present at the meet upon request from the Board.
- (J) JSSC certified officials will be required to attend a stroke and turn seminar prior to the beginning of the summer season. JSSC will provide the dates, times and locations of the clinics. (Note: Certified USAS officials who have already satisfied this requirement are exempt from this requirement.) Stroke and Turn certifications must be renewed every two years.
- (K) It shall be the responsibility of the scorer to identify any obvious errors (unrealistic finish times, order of finish, wrong gender for event, flagged errors, etc). Team coaches shall be responsible for bringing any non-obvious errors to the attention of the scorer. Scorer and/or coaches shall be responsible for validating or correcting any potential errors once they have been made aware of any such potential error by any official or coach.
- (L) All meet officials and volunteers will be expected to serve in their respective role for the entirety of the meet unless prior arrangements to be relieved early have been made. In the event of accident or

illness, the meet will be paused briefly while coaches find a suitable replacement for the affected position.

- (M) The host team shall be expected to provide, at a minimum, cold water for all meet officials and volunteers during the meet.
- (N) The host team shall provide details on accommodations to the visiting team at least 12 hours prior to the start of the meet. This information shall include, but is not limited to, arrival times, parking, seating arrangements (if chairs should be brought), if tents or shade structures are allowed (safety of swimmers and spectators should be considered, especially in extreme heat), and availability of on-site refreshments.
- (O) Meet results in electronic format shall be uploaded to the corresponding host system by 12:00 pm the day following the completion of the meet provided that electronic scoring systems were used at the meet.

SECTION 9: GUPPY MEETS

- (A) The purpose of a Guppy Meet is to promote competition for the new and less experienced swimmers. The Guppy Meets will be limited to swimmers age 10 and below.
- (B) A swimmer shall not be eligible to participate as a guppy in a particular stroke if he/she has achieved the Senior County Championship meet time standard in the stroke.
- (C) The cutoff date for the above disqualifying factors shall be the entry deadline for the first scheduled date of the Guppy Meet. Rain dates shall not affect a swimmer's status, i.e. if he/she was eligible to swim on the originally scheduled first meet day, then he/she will be eligible for the meet regardless of when it is held.
- (D) All participants in the JSSC sponsored Guppy Meets shall be registered in accordance with the registration procedures.
- (E) Minimum Standard awards for Guppy Meets are as follows:
 - i. Token heat ribbons for each lane of each heat in individual events. For example, first through sixth place of each heat would receive a ribbon for guppy meets contested in a six lane pool. Eight places would be awarded for an eight lane pool and so on;
 - ii. Three medals for each individual event; and
 - iii. Team trophies shall not be awarded.
- (F) Guppy Meets are classified as invitational meets and can be hosted by any member team according to the published schedule for Guppy Meets. All fees for Guppy Meets are set by the hosting team. The host team will provide all awards for a Guppy Meet which include ribbons for every heat and medals for 1st through 3rd place in each event.
- (G) Guppy Meet Events will be as follows:
 - i. 6 & Under - 25 yards all 4 strokes
 - ii. 7-8 - 25 yards all 4 strokes
 - iii. 9-10 - 50 yards all 4 strokes

SECTION 10: CHAMPIONSHIP AND INVITATIONAL MEETS

- (A) Only a JSSC member team can bid and host Senior County or any championship meet. The bid for JSSC Senior County Championship Meet and Invitational Meets shall be presented to the delegates at the spring meeting for JSSC. The meets shall include the Senior County Championship, JSSC Sponsored Invitational, and Guppy Meets. In any given year the JSSC Board may suggest an alternative Championship meet format including additional meets or substitutions. The membership present at that time will vote to decide on acceptance of meet format and acceptance of meet bids. All meet information for revenue generating meets (meets with entry fees) must state a refund policy.
- (B) The date for the JSSC Senior County Championship Meet shall, if at all possible, avoid conflict with the Southeastern Long Course Championship Meet as agreed upon by the delegates at the spring meeting.
- (C) The team(s) hosting the JSSC Senior County Championship Meet and JSSC Sponsored Invitational Meets shall provide the following:
- i. The JSSC Senior County Championship Meet and JSSC Sponsored Invitational Meets shall have USAS approved timing (i.e. touchpad or approved alternate); Guppy Meet excluded from this rule.
 - ii. Non-turbulent lane ropes properly installed between ALL lanes and where there are no gutters, the ropes should be installed on the outside of Lanes 1 and 6 (lane 8 if an 8 lane pool).
The host team shall supply ALL meet workers. (Referees, starter, stroke and turn judges, marshal, scorers, timers and runners.) To ensure certification requirements are met, the names of the above officials and meet information must be approved by the JSSC Board of Directors before the meet information is mailed.
 - iii. All championship and invitational meet results shall be emailed to the JSSC Director of Registration no later than 24 hours following the meet.
 - iv. Event results in championship and invitational meets shall include individual place, time and JSSC time standard achieved (i.e. AAA, AA, A etc.) during the meet. Computerized time standards will minimize errors during end of year award determination.
- (D) All participating teams shall supply a minimum of one (1) volunteer for every ten (10) swimmers attending the Senior County Championship meet (minimum of one (1) volunteer per team), if meet is hosted by JSSC.
- (E) *The minimum time standards to enter the JSSC Senior County Championship Meet will typically be consistent from year to year by default. Time standards may be adjusted based upon a review of the prior season's Senior County participation level and times achieved during the prior season's regular meets. Goal is to provide an inclusive championship meet that also completes within a target timeframe. The time standards will be published and distributed to each club by the spring scheduling meeting. A swimmer may enter all events in his/her age group for which the qualifying time has been achieved. In addition, a swimmer who has qualified in one event may swim in all other events of the same distance and age group on that same day (i.e. swimmer qualifies in 25 free, they may swim in any other 25 event offered that same day). Swimmers who have qualified in three individual events of different strokes may swim in the 100 IM. Swimmers*

who have qualified for the 50 free may swim in the 100 free. The Director of Scheduling shall have the right to limit any event to the top 40 qualifiers, if required to keep the meet timeline reasonable.

- (F) The events offered for the JSSC Senior County Championship Meet shall include the following:

<u>Age Group</u>	<u>Individual Event Distance</u>
6 & under	25's in every stroke, 50 free and 100 IM
7 – 8	25's in every stroke, 50 free and 100 IM
9 – 10	50's in every stroke, 100 free and 100 IM
11 – 12	50's in every stroke, 100 free and 100 IM
13 – 14	50's in every stroke, 100 free and 100 IM
15 – 18	50's in every stroke, 100 free and 100 IM

- (G) The relay events for the JSSC Senior County Championship Meet shall include the following:

<u>Age Group</u>	<u>Event Distance</u>
18 & Under Mixed (2 girls, 2 boys, any order)	4 by 50 free and medley relays (first relay event)
6 & Under	4 by 25 free relay (no medley)
8 & Under	4 by 25 free and medley relays
10 & Under	4 by 50 free and medley relays
12 & Under	4 by 50 free and medley relays
14 & Under	4 by 50 free and medley relays
18 & Under	4 by 50 free and medley relays

Note: Swimmers are allowed to swim a maximum of two relays per day in Senior County Championship Meet. At least ONE swimmer on each relay must be within the age group of that relay. Swimmers will be allowed to swim up two age group. Swimmers will also be allowed to swim up more than two age groups if they have swum the minimum Senior County time standard for the stroke they are swimming in a JSSC meet during the current year. For instance for a swimmer to swim in a 15 & over relay, at least one swimmer on the relay team must be age 15-18 and the other swimmers must be either in the 11-12, 13-14, or 15-18 age group; or have swum the 15-18 minimum Senior County time standard in a JSSC meet during the current year. A swimmer that swims in a relay and fails to swim the minimum Senior County time standard for the stroke they are swimming or fails to submit proof that they have swum the minimum Senior County time standard for the stroke they are swimming in a JSSC meet during the current year will be DQ each relay if unproven entry.

- (H) Scoring for Championship Meets:

<u>Individual Events</u>	<u>Relays</u>
Top eight score: 9-7-6-5-4-3-2-1	18-14-12-10-8-6-4-2

- (I) Minimum award standards for the JSSC Senior County Championship Meet are as follows:

- i. County Championship Meet
 - (a) Heat ribbon for the winner of each heat (10 and under only)
 - (b) Ribbons for each event 1st -8th place

- (c) Awards for overall places 1-8, per boy and girl, per each age group
- (d) Trophies for small and large team first place finish. Trophies for small and large team runner up.
- (J) Each team must participate in a minimum of three (3) dual meets to be eligible to compete in the JSSC Senior County Championship Meet. In the event a club is unable to participate in three (3) meets, the Board of Directors will attempt to arrange additional meets for the club. Alternatively, the Board of Directors may waive the minimum participation rule.
- (K) The JSSC shall have the option of sponsoring any approved JSSC meet and retaining the proceeds therefrom, in the event a satisfactory bid is not received for hosting any such meet.
- (L) A swimmer's age shall be determined on the first day of June of the current year.
- (M) *There is a fine assessed per swim for a swimmer who has not swum a Senior County Time Standard during the current swim season for any event offered on a day at Senior County Championship Meet, but swims that day and fails to meet a time standard (see appendix for fee).* After the Senior County Championship Meet, the JSSC Secretary will send each team the list of non-qualifying swims and the team will send the fine or proof of the swim back to the JSSC Secretary within 30 days.

SECTION 11: DIVISIONS

- (A) There will be two divisions based on team size; Large Team Division and Small Team Division. The team divisions will be chosen such that there are approximately an equal number of teams in each division. The team divisions will be determined based upon the number of swimmers in the previous season, proposed by the Director of Scheduling and approved by the delegates at the spring meeting.
- (B) The Senior County Championship meet team results will determine the division champions.
