  - a. Meet builder non-profit status has legal restrictions about board members receiving money directly from the board. Since board members vote for funds allocation they are not eligible to receive funds.

  - c. 2020 Schedule Two or three division structure
    - i. Concern: If there is only three meets that count; do we communicate that swimmers only need to apply themselves three times. Several comments that this is a team culture issue and that all meets are important.
    - ii. Tri meets are still on the table for all schedule variations
    - iii. Division structure will need to addressed each fall and evaluated passed on the results of the previous season. For 2019 the data indicates a three division structure may be best passed on the performance of the teams falling in three groups.
  - d. Motion for HSL to adopt a 3 divisions structure for 2020.
    - i. Raised: Head Official Peter Entner; Second: Fountain Green Randy Slotnik; Passed: unanimously by verbal vote
  - e. Motion for each division to have equal in-division meets that count toward standings.
    - i. Discussion: Since one division will have 5 teams and the other divisions will have 4, two of the division will have 3 in division meets and the other division will have 4 in division meets. A proposal was raised to have the teams in the smaller divisions swim one of the other division teams twice so that all teams have 4 meets that count toward their division standing. Based on the 2019 standings the additional meets would be determined by ranking. For each division, 1-2 and 3-4 would swim a second dual meet.
