Two options were presented to the membership:

OPTION 1:

Division Champs: Saturday July 13<sup>th</sup> League Champs: Saturday July 20<sup>th</sup>

OPTION 2:

Division Champs: Saturday July 27<sup>th</sup> League Champs: Saturday August 3<sup>rd</sup>

Regardless, here are the suggested options for the week of July 4th:

A-meet on Tuesday, B-meet on Wednesday OR

With both clubs approval, combine the meet scoring as an A-meet but allowing more exhibition heats

#### **Discussion Points:**

- MICC concerned over high school coaching conflicts
  - o WIA may waive
- Concerns over conflict with Water Polo
  - o WP can easily adjust their practice schedule so this should not be an issue
- What are the benefits of Option 2?
  - Weather
  - o Conflicts with end of school year
  - Conficts with baseball
  - Giving swimmers more pool time
- SeaFair Saturday & problem with bridge closing
- PNS swimmers may not want to swim an additional week
- Summer swim is being used as a 'filler' between other activities instead of a focus
- Board encourages attendees to vote for what is best for their clubs, not personal preferences
- Coached are frustrated when they cannot make it to the start of the season (college coaches)
- Conflicts with fall high school sports schedules

A move to vote was offered and seconded.

The vote for those in attendance was 10 for Option #1 and 10 for option #2, one abstention. It was determined that since there was not a lean toward making a change to the schedule that the calendar will remain the same and Option #1 will be adopted.

## 2012 Season Recap:

- Changes were made to the Operating Plan and ByLaws
- Swimp-ups & equity: a little rough at the beginning of the season
- 1:1 clarifications were made and need to be put in writing for next season
- Coaches need to communicate better. Parent Reps need to encourage communication between coaches
- Inquiry regarding ineligible swimmer @ League Champs
  - A full investigation was performed and it was confirmed that the swimmer was eligible.
  - Language regarding what constitutes and official roster needs to be clarified in the
     Operating plan
- How do we enforce communication?
  - Performance evaluation by the club
  - o Club can ask the League to intervene

### Coach of the Year

I was determined that this designation is not working and is not needed Instead:

- Suggested that the league support serving complimentary food to the coaches at Champ Meets
- Use League Funds for a coaches social event at the beginning of the season

• It is the League responsibility to recognize & acknowledge coaches excellance

Nancy Anderson presented the Treasurer's Report

- Handed out hard copies of the League profit & loss
- Identified costs for League & Division Champs
- Paid out \$20,000 over 27 teams per Appendix B of the Operating Plan
