### **Roster Numbers**

Total roster numbers for the 2014 season ended at 423. This indicates an increase of approximately 173 athletes from the 2013 season. A full breakdown of roster numbers by team is attached.

## **Operating Plan Adjustments**

At the Postseason Committee Meeting, the following Operating Plan changes were submitted:

1. Teams must consist of at least 6 eligible players (equivalent to "man down"). Any team that does not have the minimum number of players will forfeit the contest in question.

2. Players who belong to a Member Club in good standing of MSL, and whose Club does not field its own water polo team, may petition the Water Polo Director for placement in another program. Any player placed in this manner must pay the participation fee of the team to which they are assigned. In cases where the player is placed on a Combined Team, the player will pay the average of any differing participation fees. The final placement of the player is at the sole discretion of the Water Polo Director, but efforts will be made to take factors such as location, travel time, etc., into account. The Water Polo Director must finalize placement before an individual may compete for any Club.

3. At any point in any game where the point differential exceeds seven (7) goals, the Timekeeper will transition to a running clock and the Secretary will not record additional goals scored by the winning team. In the event the losing team narrows the differential, score keeping shall resume but the clock will remain running.

4. No logos for school or club teams other than Midlakes shall be allowed on caps, suits, or any coach or league officer attire.

Of those proposals submitted, Proposals 1 and 2 were passed with no changes. Proposal 4 was passed in the following form:
