2. RECEIPT OF MEMBERSHIP PLAN.

The undersigned (hereinafter referred to as the “Applicant”) hereby acknowledges receipt of a copy of The Plateau Club Bylaws dated December 1999 (with addendums) and the Rules and Regulations dated May 2001, a Membership Fee Schedule, and hereby provides to The Plateau Club, this Membership Deposit Agreement and Membership Application, each of which are incorporated by this reference (collectively, the “Membership Handbook”). If approved for membership, the undersigned agrees to fully substitute the membership privileges acquired pursuant to the Membership Handbook for any and all present and prior rights the Applicant may have had to use the Club Facilities and agrees to be bound by all of the respective and applicable terms and conditions of the Membership Handbook.

3. MEMBERSHIP PRIVILEGES IN THE CLUB.

The Club Facilities (as defined in the Membership Handbook) are owned and operated by , Plateau Golf LLC (dba The Plateau Club). Membership in the Club creates a right to access and to use certain of the Club Facilities, as set forth in the Bylaws.

4. PAYMENT OF MEMBERSHIP APPLICATION FEE.

Deposit and any Additional Fees are required within ten (10) business days of the Club’s approval of the Applicant.

5. MISCELLANEOUS.

- a. Law. This Membership Agreement shall be governed by and construed in accordance with the laws of the State of Washington.
- b. Arbitration. In the event that any dispute relating to or arising from this Agreement cannot be settled by the parties, they shall submit the dispute to an arbitrator selected in the following manner: within twenty (20) days of receiving written demand for arbitration, the parties involved in the dispute shall attempt to reach agreement upon the selection of a qualified impartial arbitrator. If the parties cannot agree upon an arbitrator within twenty (20) days from the date written demand for arbitration is served, the party demanding arbitration may commence an action for the limited purpose of obtaining appointment of an arbitrator by the Presiding Judge of the Superior Court of the State of Washington for King County. Any arbitration shall be conducted in accordance with the rules of the American Arbitration Association then in effect, although the arbitration need not be conducted under the auspices of the Association. Any

arbitration award may be enforced by judgment entered in the Superior Court of the State of Washington for King County.

- c. **Indemnity.** To the fullest extent permitted by law, Applicant/Member/Member's Parent/Guardian shall release, indemnify, defend and hold harmless Plateau Golf LLC, its affiliates and its lender and their officers, agents, employees, representatives, consultants and contractors, from and against any and all claims, damages, losses and expenses, including, but not limited to, reasonable attorneys' fees, which arise out of or result from any breach of this Agreement, failure to abide by the Bylaws or Rules or Regulations, or any negligent, reckless or illegal act or omission of Applicant/Member or anyone for whose acts Applicant/Member may be liable. The provisions of this paragraph shall survive termination of this Agreement or Membership for any reason.
- d. **Remedies.** The exclusive remedy for any Applicant or Member under this Membership Agreement or Membership Handbook for any non-performance or other breach by Plateau Golf LLC shall be the return of the Applicant's Initiation Fee without interest. In addition, the Applicant specifically acknowledges and accepts the limitation on liability and hold harmless provisions contained here initiation Fee
- e. **Financial Responsibility.** Junior Member's Parent/Guardian understand and agree they are fully responsible and liable for all charges to member's account.

6. **ACKNOWLEDGMENT.**

Upon signing this Application for Membership, I authorize the disclosure and release of information to Plateau Golf LLC for investigating my qualifications for membership and authorize those persons or entities contacted to furnish information to the Club which may include, but is not limited to investigating either directly or through others, my background in accordance with the Fair Credit Reporting Act. The Applicant hereby releases Plateau Golf LLC from any consequences as related to these activities.

In the event of non-payment of any dues, fees and other charges due and payable by the Member in accordance with the Membership Handbook, the Member's Parent authorizes any and all charges incurred on Member's account with The Plateau Club to be charged to the credit card listed below and certifies that the below listed card is issued to the Member's Parent and agrees that all disputes on said credit card account relating to The Plateau Club will be promptly brought to the Club's attention.
